1 A BILL FOR AN ACT relating to firearms; to amend sections 69-2402, 2 69-2404, 69-2405, 69-2409, 69-2409.01, 69-2410, 69-2411, 69-2412, 3 69-2414, 69-2421, 69-2422, 69-2424, 69-2425, 69-2427, 69-2429, 4 69-2430, 69-2436, and 69-2439, Reissue Revised Statutes of Nebraska; to define terms; to require notification when a person prohibited by 5 6 state or federal law attempts to purchase, lease, rent, or receive 7 transfer of a handgun, apply for a permit or renew a permit to carry 8 a concealed handgun under the Concealed Handgun Permit Act, or has 9 such a permit revoked; to eliminate an obsolete provision; to harmonize provisions; and to repeal the original sections. 10

- 3 69-2402 For purposes of sections 69-2401 to 69-2425:
- 4 (1) Antique handgun or pistol means any handgun or pistol, including
- 5 those with a matchlock, flintlock, percussion cap, or similar type of
- 6 ignition system, manufactured in or before 1898 and any replica of such a
- 7 handgun or pistol if such replica (a) is not designed or redesigned for
- 8 using rimfire or conventional centerfire fixed ammunition or (b) uses
- 9 rimfire or conventional centerfire fixed ammunition which is no longer
- 10 manufactured in the United States and which is not readily available in
- 11 the ordinary channels of commercial trade;
- 12 (2) Commission means the Nebraska Commission on Law Enforcement and
- 13 <u>Criminal Justice;</u>

- 15 criminal history records of the Nebraska State Patrol and a check of the
- 16 Federal Bureau of Investigation's National Instant Criminal Background
- 17 Check System;
- 18 (4) (3) Firearm-related disability means a person is not permitted
- 19 to (a) purchase, possess, ship, transport, or receive a firearm under
- 20 either state or federal law, (b) obtain a certificate to purchase, lease,
- 21 rent, or receive transfer of a handgun under section 69-2404, or (c)
- 22 obtain a permit to carry a concealed handgun under the Concealed Handgun
- 23 Permit Act; and
- 24 <u>(5)</u> Handgun means any firearm with a barrel less than sixteen

- transfer of a handgun shall apply with the chief of police or sheriff of 1 2 the applicant's place of residence for a certificate. The application may be made in person or by mail. The application form and certificate shall 3 4 be made on forms approved by the Superintendent of Law Enforcement and Public Safety. The application shall include the applicant's full name, 5 address, date of birth, and country of citizenship. If the applicant is 6 7 not a United States citizen, the application shall include the applicant's place of birth and his or her alien or admission number. If 8 the application is made in person, the applicant shall also present a 9 current Nebraska motor vehicle operator's license, state identification 10 card, or military identification card, or if the application is made by 11 mail, the application form shall describe the license or card used for 12 identification and be notarized by a notary public who has verified the 13 identification of the applicant through such a license or card. An 14 applicant shall receive a certificate if he or she is twenty-one years of 15 age or older and is not a prohibited possessor from purchasing or 16 possessing a handgun by 18 U.S.C. 922. - Sec. 3. Section 69-2405, Reissue Revised Statutes of Nebraska, is amended to read:
- 22 69-2405 Upon the receipt of an application for a certificate, the chief of police or sheriff shall issue a certificate or deny a 23 24 certificate and furnish the applicant the specific reasons for the denial 25 in writing. The chief of police or sheriff shall be permitted up to three days in which to conduct an investigation to determine whether the 26 applicant is a prohibited possessor by law from purchasing or possessing 27 a handgun. If the certificate or denial is mailed to the applicant, it 28 shall be mailed to the applicant's address by first-class mail within the 29 three-day period. If it is determined that the purchase or possession of 30 a handgun by the applicant would be in violation of applicable federal, 31

- 1 state, or local law, the chief of police or sheriff shall deny the

- (3) Any person, agency, or mental health board participating in good faith in the reporting or disclosure of records and communications under this section is immune from any liability, civil, criminal, or otherwise,

- 8 (5) The Nebraska State Patrol and the Department of Health and Human 9 Services shall report electronically to the Clerk of the Legislature on a biannual basis the following information about the data base: (a) The 10 number of total records of persons unable to purchase or possess firearms 11 because of disqualification or disability shared with the National 12 13 Instant Criminal Background Check System; (b) the number of shared records by category of such persons; (c) the change in number of total 14 shared records and change in number of records by category from the 15 previous six months; (d) the number of records existing but not able to 16 be shared with the National Instant Criminal Background Check System 17 because the record was incomplete and unable to be accepted by the 18 19 National Instant Criminal Background Check System; and (e) the number of hours or days, if any, during which the data base was unable to share 20 records with the National Instant Criminal Background Check System and 21 22 the reason for such inability. The report shall also be published on the web sites of the Nebraska State Patrol and the Department of Health and 23 24 Human Services.
