- 1 A BILL FOR AN ACT relating to the Constitution of the United States; to
- 2 adopt the Faithful Delegate to Federal Article V Convention Act.
- 3 Be it enacted by the people of the State of Nebraska,

1 Section 1. This act shall be known and may be cited as the Faithful

- 2 <u>Delegate to Federal Article V Convention Act.</u>
- 3 Sec. 2. For purposes of the Faithful Delegate to Federal Article V
- 4 Convention Act:
- 5 (1) Alternate delegate means an individual elected by the
- 6 Legislature to represent this state as an alternate delegate at an
- 7 Article V convention;
- 8 (2) Article V convention means a convention called by the United
- 9 States Congress under Article V of the Constitution of the United States;
- 10 (3) Delegate means:
- 11 (a) An individual elected by the Legislature to represent this state
- 12 <u>as a delegate at an Article V convention; and</u>
- 13 (b) An alternate delegate who fills a vacancy created by the removal
- of a delegate or acts in place of the delegate in his or her absence; and
- 15 (4) Unauthorized vote means a vote by a delegate at an Article V
- 16 convention that:
- 17 (a) Is contrary to the instructions adopted by the Legislature in
- 18 effect at the time the vote is taken;
- 19 (b) Exceeds the scope of the subject matter of the Article V
- 20 <u>convention authorized by the Legislature in the application to the United</u>
- 21 States Congress to call the convention if the Legislature made an
- 22 application to call the convention; or
- 23 (c) Exceeds the scope or subject matter of the Article V convention
- 24 if the Legislature did not make an application to the United States
- 25 Congress to call the convention.
- 26 Sec. 3. <u>The purpose of the Faithful Delegate to Federal Article V</u>
- 27 <u>Convention Act is to provide the rules and procedures necessary to create</u>
- 28 and guide a delegation to an Article V convention and provide legislative
- 29 <u>direction relating to the election or recall of a delegate or an</u>
- 30 alternate delegate, the filling of a vacancy of a delegate or an
- 31 alternate delegate, and the determination of an unauthorized vote.

- 1 Sec. 4. (1) As soon as possible following the calling of an Article
- 2 <u>V convention</u>, the <u>Legislature shall create an Article V Convention</u>
- 3 Committee. The Legislature shall elect a delegate committee chairperson
- 4 and vice-chairperson. The Committee on Committees of the Legislature
- 5 <u>shall, by majority vote of all the members, nominate one delegate and one</u>
- 6 <u>alternate delegate from each legislative caucus and submit a report of</u>
- 7 the nominations to the Legislature for approval. If the Legislature does
- 8 <u>not adopt the report by a vote of the majority of the members, the</u>
- 9 <u>Committee on Committees shall prepare another report.</u>
- 10 (2) If the number of delegates allocated to represent this state at
- 11 the Article V convention is determined by the United States Congress or
- 12 by agreement among the states to be a number other than five, the
- 13 Legislature shall elect the appropriate number of delegates and alternate
- 14 <u>delegates</u>.
- 15 (3) Service as a delegate or alternate delegate by a member of the
- 16 Legislature is an additional duty of the legislative office.
- 17 <u>(4) The Legislature shall pair each alternate delegate with a</u>
- 18 <u>delegate</u> at the time of the election. The alternate delegate is
- 19 designated to automatically fill a vacancy in the position of the paired
- 20 delegate. If the positions of both the delegate and alternate delegate
- 21 are simultaneously vacated, the Legislature shall elect a new delegate
- 22 and paired alternate delegate to succeed the prior delegate and alternate
- 23 delegate.
- 24 Sec. 5. (1) The delegates and alternate delegates shall not be
- 25 compensated for their service as delegates and alternate delegates.
- 26 <u>(2) The delegates and alternate delegates may be reimbursed for</u>
- 27 <u>their actual and necessary expenses incurred in the performance of their</u>
- 28 official duties as provided in sections 81-1174 to 81-1177.
- 29 <u>(3) A delegate or an alternate delegate may not accept a gift as</u>
- 30 defined in section 49-1423 from a person who is required to register as a
- 31 lobbyist under the Nebraska Political Accountability and Disclosure Act.

- 1 Sec. 6. (1) Each delegate and alternate delegate shall take the
- 2 <u>following oath before voting or taking an action as a delegate or</u>
- 3 alternate delegate of this state: I do solemnly swear (or affirm) that,
- 4 to the best of my abilities, I will, as a delegate (or alternate
- 5 <u>delegate</u>) to the Article V convention, act according to the limits of the
- 6 <u>authority granted to me as a delegate or alternate delegate under the</u>
- 7 Faithful Delegate to Federal Article V Convention Act, will not consider
- 8 <u>or vote to approve an amendment to the Constitution of the United States</u>
- 9 not authorized by the Legislature in its application to the United States
- 10 Congress to call this convention or an amendment outside of the scope of
- 11 this convention if the Legislature did not make an application to the
- 12 <u>United States Congress to call this convention, and will faithfully abide</u>
- 13 by and execute the instructions to the delegates and alternate delegates
- 14 <u>adopted by the Legislature.</u>
- 15 (2) Each delegate and alternate delegate shall file the executed
- 16 oath with the Secretary of State.
- 17 Sec. 7. (1) At the time delegates and alternate delegates are
- 18 elected under the Faithful Delegate to Federal Article V Convention Act,
- 19 the Legislature shall adopt instructions for the delegates and alternate
- 20 <u>delegates to govern their actions at the Article V convention.</u>
- 21 (2) The Legislature shall not adopt instructions for an Article V
- 22 convention called following the application by the Legislature to the
- 23 <u>United States Congress for the convention that authorize a delegate or</u>
- 24 alternate delegate to consider or vote to approve an amendment to the
- 25 Constitution of the United States that is not authorized by the
- 26 Legislature in its application for the convention.
- 27 <u>(3) The Legislature may amend the instructions at any time.</u>
- 28 Sec. 8. An alternate delegate shall act in the place of the
- 29 alternate delegate's paired delegate when the delegate is absent from the
- 30 convention. An alternate delegate acting under this section shall be
- 31 <u>deemed the delegate for purposes of such action.</u>

Sec. 9. (1) A delegate shall not cast an unauthorized vote. A vote

- 2 determined to be an unauthorized vote is invalid.
- 3 (2) The determination that a vote is an unauthorized vote shall only
- 4 be made by the Legislature or by the advisory committee created pursuant
- 5 to section 11 of this act when the Legislature is not in session.
- 6 (3) A delegate who casts a vote determined to be an unauthorized
- 7 vote is disqualified to continue to serve as a delegate or alternate
- 8 <u>delegate</u>, and the vacancy created by the disqualification shall be filled
- 9 <u>as provided in section 4 of this act.</u>
- 10 Sec. 10. When it is determined by the Legislature or the advisory
- 11 committee created pursuant to section 11 of this act that a delegate has
- 12 cast an unauthorized vote, the Speaker of the Legislature shall promptly
- 13 <u>notify the head of the delegation of this state and the presiding officer</u>
- 14 of the Article V convention that the delegate has cast an unauthorized
- 15 vote and is disqualified to serve as a delegate.
- 16 Sec. 11. (1) The Executive Board of the Legislative Council and the
- 17 <u>Lieutenant Governor shall serve as the advisory committee for the</u>
- 18 delegates and alternate delegates attending the Article V convention. The
- 19 chairperson of the executive board shall serve as the chairperson of the
- 20 advisory committee. If the chairperson or any other member of the
- 21 executive board is serving as a delegate or an alternate delegate, his or
- 22 her position on the advisory committee shall be deemed vacant and the
- 23 vacancy shall be filled in the same manner as a vacancy on the executive
- 24 board. The Lieutenant Governor may cast the deciding vote in the event of
- 25 a tie vote by the rest of the members of the advisory committee.
- 26 <u>(2) If the Legislature is not in session at a regular or special</u>
- 27 <u>session while an Article V convention is convened, the members of the</u>
- 28 advisory committee shall:
- 29 <u>(a) Meet at the call of the chairperson at the State Capitol;</u>
- 30 <u>(b) Upon the request of a delegate or an alternate delegate, advise</u>
- 31 the delegate or alternate delegate whether there is reason to believe

1 that an action or an attempt to take an action by a delegate or alternate

- 2 <u>delegate could result in an unauthorized vote; and</u>
- 3 (c) Determine whether a vote cast by a delegate is an unauthorized
- 4 vote as provided in subsection (3) of this section.
- 5 (3) If a vote cast by a delegate is challenged as an unauthorized
- 6 vote under the Faithful Delegate to Federal Article V Convention Act, the
- 7 advisory committee shall determine that the vote is an unauthorized vote
- 8 only if six or more members of the advisory committee vote that it was an
- 9 unauthorized vote.
- 10 (4) The advisory committee shall not take any action when the
- 11 Legislature is convened in regular or special session.
