16	any items appropriated in this act until a receipt and release in full,
17	releasing the State of Nebraska, its officers, employees, and agents, and
18	their successors and assigns, has been filed by each of the beneficiaries
19	respectively. Upon presentation of the warrants, the State Treasurer is
20	hereby directed to pay the same out of money in the General Fund or out
21	of money in other funds indicated in this act not otherwise appropriated.
