Introduced by Pansing Brooks, 28. Read first time January 23, 2019 Committee: Revenue

- A BILL FOR AN ACT relating to revenue and taxation; to amend section
 77-2715.07, Reissue Revised Statutes of Nebraska; to increase the
 earned income tax credit as prescribed; and to repeal the original
 section.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 77-2715.07, Reissue Revised Statutes of Nebraska,
 is amended to read:

3 77-2715.07 (1) There shall be allowed to qualified resident
4 individuals as a nonrefundable credit against the income tax imposed by
5 the Nebraska Revenue Act of 1967:

6 (a) A credit equal to the federal credit allowed under section 22 of 7 the Internal Revenue Code; and

8 (b) A credit for taxes paid to another state as provided in section9 77-2730.

10 (2) There shall be allowed to qualified resident individuals against
 11 the income tax imposed by the Nebraska Revenue Act of 1967:

(a) For returns filed reporting federal adjusted gross incomes of 12 greater than twenty-nine thousand dollars, a nonrefundable credit equal 13 to twenty-five percent of the federal credit allowed under section 21 of 14 the Internal Revenue Code of 1986, as amended, except that for taxable 15 years beginning or deemed to begin on or after January 1, 2015, such 16 nonrefundable credit shall be allowed only if the individual would have 17 received the federal credit allowed under section 21 of the code after 18 adding back in any carryforward of a net operating loss that was deducted 19 pursuant to such section in determining eligibility for the federal 20 21 credit;

(b) For returns filed reporting federal adjusted gross income of 22 twenty-nine thousand dollars or less, a refundable credit equal to a 23 24 percentage of the federal credit allowable under section 21 of the Internal Revenue Code of 1986, as amended, whether or not the federal 25 credit was limited by the federal tax liability. The percentage of the 26 federal credit shall be one hundred percent for incomes not greater than 27 28 twenty-two thousand dollars, and the percentage shall be reduced by ten percent for each one thousand dollars, or fraction thereof, by which the 29 reported federal adjusted gross income exceeds twenty-two thousand 30 dollars, except that for taxable years beginning or deemed to begin on or 31

1 after January 1, 2015, such refundable credit shall be allowed only if 2 the individual would have received the federal credit allowed under 3 section 21 of the code after adding back in any carryforward of a net 4 operating loss that was deducted pursuant to such section in determining 5 eligibility for the federal credit;

6 (c) A refundable credit as provided in section 77-5209.01 for 7 individuals who qualify for an income tax credit as a qualified beginning 8 farmer or livestock producer under the Beginning Farmer Tax Credit Act 9 for all taxable years beginning or deemed to begin on or after January 1, 10 2006, under the Internal Revenue Code of 1986, as amended;

(d) A refundable credit for individuals who qualify for an income tax credit under the Angel Investment Tax Credit Act, the Nebraska Advantage Microenterprise Tax Credit Act, the Nebraska Advantage Research and Development Act, or the Volunteer Emergency Responders Incentive Act; and

16 (e)(i) (e) A refundable credit equal to:

<u>(A) Ten</u> ten percent of the federal credit allowed under section 32
 of the Internal Revenue Code of 1986, as amended, <u>for taxable years</u>
 <u>beginning or deemed to begin before January 1, 2020;</u>

20 (B) Thirteen percent of the federal credit allowed under section 32
21 of the Internal Revenue Code of 1986, as amended, for taxable years
22 beginning or deemed to begin on or after January 1, 2020, and before
23 January 1, 2021;

(C) Seventeen percent of the federal credit allowed under section 32
 of the Internal Revenue Code of 1986, as amended, for taxable years
 beginning or deemed to begin on or after January 1, 2021, and before
 January 1, 2022; and

(D) Twenty percent of the federal credit allowed under section 32 of
 the Internal Revenue Code of 1986, as amended, for taxable years
 beginning or deemed to begin on or after January 1, 2022.

31 (<u>ii) For except that for</u> taxable years beginning or deemed to begin

1 on or after January 1, 2015, <u>the such</u> refundable credit <u>provided in</u> 2 <u>subdivision (2)(e)(i) of this section</u> shall be allowed only if the 3 individual would have received the federal credit allowed under section 4 32 of the code after adding back in any carryforward of a net operating 5 loss that was deducted pursuant to such section in determining 6 eligibility for the federal credit.

7 (3) There shall be allowed to all individuals as a nonrefundable
8 credit against the income tax imposed by the Nebraska Revenue Act of
9 1967:

10 (a) A credit for personal exemptions allowed under section11 77-2716.01;

(b) A credit for contributions to certified community betterment programs as provided in the Community Development Assistance Act. Each partner, each shareholder of an electing subchapter S corporation, each beneficiary of an estate or trust, or each member of a limited liability company shall report his or her share of the credit in the same manner and proportion as he or she reports the partnership, subchapter S corporation, estate, trust, or limited liability company income;

(c) A credit for investment in a biodiesel facility as provided in
section 77-27,236;

(d) A credit as provided in the New Markets Job Growth InvestmentAct;

(e) A credit as provided in the Nebraska Job Creation and Mainstreet
 Revitalization Act;

25 (f) A credit to employers as provided in section 77-27,238; and

26 (g) A credit as provided in the Affordable Housing Tax Credit Act.

(4) There shall be allowed as a credit against the income taximposed by the Nebraska Revenue Act of 1967:

(a) A credit to all resident estates and trusts for taxes paid to
another state as provided in section 77-2730;

31 (b) A credit to all estates and trusts for contributions to

certified community betterment programs as provided in the Community
 Development Assistance Act; and

3 (c) A refundable credit for individuals who qualify for an income tax credit as an owner of agricultural assets under the Beginning Farmer 4 Tax Credit Act for all taxable years beginning or deemed to begin on or 5 after January 1, 2009, under the Internal Revenue Code of 1986, as 6 amended. The credit allowed for each partner, shareholder, member, or 7 beneficiary of a partnership, corporation, limited liability company, or 8 9 estate or trust qualifying for an income tax credit as an owner of agricultural assets under the Beginning Farmer Tax Credit Act shall be 10 equal to the partner's, shareholder's, member's, or beneficiary's portion 11 of the amount of tax credit distributed pursuant to subsection (4) of 12 13 section 77-5211.

(5)(a) For all taxable years beginning on or after January 1, 2007, 14 and before January 1, 2009, under the Internal Revenue Code of 1986, as 15 amended, there shall be allowed to each partner, shareholder, member, or 16 17 beneficiary of a partnership, subchapter S corporation, limited liability company, or estate or trust a nonrefundable credit against the income tax 18 19 imposed by the Nebraska Revenue Act of 1967 equal to fifty percent of the partner's, shareholder's, member's, or beneficiary's portion of the 20 amount of franchise tax paid to the state under sections 77-3801 to 21 22 77-3807 by a financial institution.

(b) For all taxable years beginning on or after January 1, 2009, 23 under the Internal Revenue Code of 1986, as amended, there shall be 24 allowed to each partner, shareholder, member, or beneficiary of a 25 partnership, subchapter S corporation, limited liability company, or 26 27 estate or trust a nonrefundable credit against the income tax imposed by the Nebraska Revenue Act of 1967 equal to the partner's, shareholder's, 28 member's, or beneficiary's portion of the amount of franchise tax paid to 29 the state under sections 77-3801 to 77-3807 by a financial institution. 30

31 (c) Each partner, shareholder, member, or beneficiary shall report

his or her share of the credit in the same manner and proportion as he or
she reports the partnership, subchapter S corporation, limited liability
company, or estate or trust income. If any partner, shareholder, member,
or beneficiary cannot fully utilize the credit for that year, the credit
may not be carried forward or back.

6 (6) There shall be allowed to all individuals nonrefundable credits 7 against the income tax imposed by the Nebraska Revenue Act of 1967 as 8 provided in section 77-3604 and refundable credits against the income tax 9 imposed by the Nebraska Revenue Act of 1967 as provided in section 10 77-3605.
