## **LEGISLATIVE BILL 667**

- 1 A BILL FOR AN ACT relating to employment training; to adopt the Youth

- 3 Be it enacted by the people of the State of Nebraska,

1	Section 1. <u>Sections 1 to 9 of this act shall be known and may be</u>
2	cited as the Youth Opportunities in Learning and Occupations Act.
3	Sec. 2. <u>(1) The Legislature finds and declares that a skills gap</u>
4	exists between employers and young people between the ages of sixteen
5	years and twenty-four years. An opportunity exists to invest in such
6	young people by identifying individual abilities, analyzing existing job
7	opportunities within this state, and training such young people to meet
8	<u>the needs of Nebraska employers.</u>
9	(2) It is the intent of the Legislature and purpose of the Youth
10	Opportunities in Learning and Occupations Act to practice early
11	investment in the young people of this state by offering training
12	services that encourage young people to identify individual abilities and
13	interests by exposing them to potential employment opportunities within
14	this state, teaching young people the soft skills necessary to succeed in
15	employment, identifying demand occupations, and assessing the required
16	<u>skills.</u>

3	Sec. 3. <u>For purposes of the Youth Opportunities in Learning and</u>
4	Occupations Act:
5	(1) Commissioner means the Commissioner of Labor;
6	(2) Demand occupation means an occupation requiring specific skills
7	and for which, as a result of business development, there are positive
8	growth-to-replacement ratios, or such ratios are expected within the next
9	twelve to twenty-four months, according to the best available sources of
10	state and local labor-market information;
11	(3) Department means the Department of Labor;
12	<u>(4) Employer means an individual or entity engaged in a business, an</u>
13	industry, a profession, a trade, or other enterprise in this state that
14	is in compliance with the reporting and payment requirements of the
15	Employment Security Law as determined by the department;
16	(5) Nonprofit corporation means any corporation that is exempt for
17	<u>federal tax purposes under section 501(c)(3) of the Internal Revenue</u>
18	Code; and
19	<u>(6) Soft skills means personal attributes and interpersonal skills</u>
20	that complement occupational skills in the workplace.
21	Sec. 4. The following entities may apply to the commissioner for a
22	grant pursuant to the Youth Opportunities in Learning and Occupations

24	<u>(1) One or more employers seeking to secure training for young</u>

26	<u>(2) One or more nonprofit corporations that do business in this</u>

31 Sec. 5. <u>Beginning in fiscal year 2019-20 and each fiscal year</u>

thereafter, the commissioner shall award grants pursuant to the Youth 1 2 Opportunities in Learning and Occupations Act such that the grant funds 3 awarded are approximately equal for each congressional district, except 4 that if there are not sufficient qualified applicants in any congressional district, the commissioner may award the unused grant funds 5 to applicants in another congressional district. No more than one-half of 6 7 the funds allocated to each congressional district shall be awarded to employers. The commissioner, in awarding grants, shall give priority to 8 9 programs, services, or training that results in employment, and no money 10 in the Youth Opportunities in Learning and Occupations Fund shall be used for capital construction. Appeals of any decision of the commissioner 11 pursuant to this section shall be in accordance with the Administrative 12 Procedure Act. 13

On or before November 1, 2020, and on or before November 1 14 Sec. 6. of each year thereafter, the commissioner shall report to the Governor 15 and the Clerk of the Legislature on the distribution and use of the 16 17 grants distributed under the Youth Opportunities in Learning and Occupations Act, including how many entities applied to receive grants, 18 19 how many entities received grants, the types of programming receiving grants, how many individuals the entities plan to train, how many 20 21 individuals successfully completed their training, and information on any 22 funds that have not been used. The report to the Clerk of the Legislature shall be submitted electronically. 23

Sec. 7. <u>The department shall adopt and promulgate rules and</u> <u>regulations to carry out the Youth Opportunities in Learning and</u> <u>Occupations Act. The rules and regulations shall include, but not be</u> <u>limited to, application timelines and requirements, guidelines for</u> <u>evaluating applications, a plan for evaluating the effectiveness of</u> <u>programs, services, and training that receive funding, and a reporting</u> <u>process for grant recipients.</u>

31 Sec. 8. <u>(1) The Youth Opportunities in Learning and Occupations</u>

1	Fund is created. The fund shall be used for (a) administrative costs of
2	establishing, assessing, and maintaining the grant program pursuant to
3	the Youth Opportunities in Learning and Occupations Act and (b) providing
4	grants pursuant to the act. The fund shall consist of such money
5	appropriated to the fund by the Legislature, any money made available by
6	any department or agency of the United States if so directed by such
7	<u>department or agency, and any donations, gifts, bequests, or other</u>
8	contributions to the fund from public or private entities. Money in the
9	fund shall not be expended until matching funds equal to at least one
10	hundred percent of the money appropriated by the Legislature have been
11	received by the commissioner and remitted to the State Treasurer for
12	<u>credit to the fund. Matching funds may be from any nonstate source,</u>
13	including private foundations, federal or local government sources, or
14	quasi-governmental entities, or any other source that is not using money
15	appropriated by the Legislature to provide the matching funds.
16	(2) Any money in the fund not distributed shall be retained by the

 17 department to be distributed as grants in the next fiscal year and shall
 18 not be expended by the department for any other purpose.

<u>(3) Any money in the fund available for investment shall be invested</u>
 <u>by the state investment officer pursuant to the Nebraska Capital</u>
 <u>Expansion Act and the Nebraska State Funds Investment Act. Investment</u>
 <u>earnings from money in the fund shall be credited to the fund.</u>

23 Sec. 9. <u>It is the intent of the Legislature to appropriate twenty</u> 24 <u>million dollars from the General Fund for fiscal year 2019-20 to carry</u> 25 <u>out the Youth Opportunities in Learning and Occupations Act.</u>
