- 1 A BILL FOR AN ACT relating to motor vehicles; to amend section 60-387,
- 2 Reissue Revised Statutes of Nebraska; to change provisions relating
- 3 to proof of financial responsibility; and to repeal the original
- 4 section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-387, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 60-387 (1) An application for registration of a motor vehicle shall
4 be accompanied by proof of financial responsibility or evidence of
5 insurance covering the motor vehicle. Proof of financial responsibility
6 shall be evidenced by a copy of proof of financial responsibility filed
7 pursuant to subdivision (2), (3), or (4) of section 60-528 bearing the
8 seal of the department. Evidence of insurance shall give the effective
9 dates of the automobile liability policy, which dates shall be evidence
10 that the coverage is in effect on and following the date of registration,
11 and shall designate, by explicit description or by appropriate reference,
12 all motor vehicles covered. Evidence of insurance in the form of a
13 certificate of insurance for fleet vehicles may include, as an
14 appropriate reference, a designation that the insurance coverage is
15 applicable to all vehicles owned by the named insured, or wording of
16 similar effect, in lieu of an explicit description. Proof of financial
17 responsibility also may be evidenced by (a) ~~(1)~~ a check by the department
18 or its agents of the motor vehicle insurance data base created under
19 section 60-3,136 or (b) ~~(2)~~ any other automated or electronic means as
20 prescribed or developed by the department.

21 (2) A named driver insurance policy, which restricts coverage to an
22 individual named in the policy, shall not be valid for registration of a
23 motor vehicle under subsection (1) of this section. Any such policy
24 shall, upon issuance, be accompanied by a notice that the policy is not
25 valid for motor vehicle registration purposes and any evidence of
26 insurance for such policy shall list by name the individual or
27 individuals covered.

28 (3) A named driver exclusion insurance policy, which excludes
29 coverage for operating a covered motor vehicle for an individual named in
30 the policy, shall list on the evidence of insurance the individual or
31 individuals excluded from coverage.

1 (4) For purposes of this section, fleet means a group of at least
2 five vehicles that belong to the same owner.
