- 1 A BILL FOR AN ACT relating to the Tax Equalization and Review Commission;
- to amend section 77-5015.02, Reissue Revised Statutes of Nebraska;
- 3 to authorize the commission to hold certain hearings by
- 4 videoconference and telephone conference; and to repeal the original
- 5 section.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 77-5015.02, Reissue Revised Statutes of Nebraska,
- 2 is amended to read:
- 3 77-5015.02 (1) A single commissioner may hear an appeal and cross
- 4 appeal and appeals and cross appeals consolidated with any such appeal
- 5 and cross appeal when:
- 6 (a) The taxable value of each parcel is one million dollars or less 7 as determined by the county board of equalization; and
- 8 (b) The appeal and cross appeal has been designated for hearing
- 9 pursuant to this section by the chairperson of the commission or in such
- 10 manner as the commission may provide in its rules and regulations.
- 11 (2) A proceeding held before a single commissioner shall be
- 12 informal. The usual common-law or statutory rules of evidence, including
- 13 rules of hearsay, shall not apply, and the commissioner may consider and
- 14 utilize all matters presented at the proceeding in making his or her
- 15 determination.
- 16 (3) Any party to an appeal designated for hearing before a single
- 17 commissioner pursuant to this section may, prior to a hearing, elect in
- 18 writing to have the appeal heard by the commission. The commissioner
- 19 conducting a proceeding pursuant to this section may at any time
- 20 designate the appeal for hearing by the commission.
- 21 (4) Documents necessary to establish jurisdiction of the commission
- 22 shall constitute the record of a proceeding before a single commissioner.
- 23 No recording shall be made of a proceeding before a single commissioner.
- 24 (5) A party to a proceeding before a single commissioner may request
- 25 a rehearing pursuant to section 77-5005.
- 26 (6) An order entered by a single commissioner pursuant to this
- 27 section may not be appealed pursuant to section 77-5019 or any other
- 28 provision of law.
- 29 (7) Subdivisions (3), (6), (8), (9), (10), (11), and (12) of section
- 30 77-5016 apply to proceedings before a single commissioner.
- 31 (8) Hearings before a single commissioner may be held by means of
