- A BILL FOR AN ACT relating to public health; to amend section 81-666,
 Reissue Revised Statutes of Nebraska, and section 68-901, Revised
 Statutes Supplement, 2017, as amended by section 1, Initiative Law
 2018, No. 427; to create the Medicaid Cost and Quality Data and
 Analysis Center of Nebraska; to provide duties relating to funding;
 to provide for an approved researcher; to harmonize provisions; and
 to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 68-901, Revised Statutes Supplement, 2017, as
- 2 amended by section 1, Initiative Law 2018, No. 427, is amended to read:
- 3 68-901 Sections 68-901 to 68-991, and section 2 of this act, and
- 4 <u>sections 2 and 3 of this act</u> shall be known and may be cited as the
- 5 Medical Assistance Act.
- 6 Sec. 2. (1) The department in partnership with the University of
- 7 Nebraska Medical Center shall create the Medicaid Cost and Quality Data
- 8 and Analysis Center of Nebraska. The purpose of the center is to collect,
- 9 analyze, and manage data to create policy recommendations to decrease the
- 10 cost of the medical assistance provided by the medical assistance program
- 11 and improve access to and quality of care provided by the medical
- 12 assistance program. The center shall have electronic access to all health
- 13 data collected by the Division of Medicaid and Long-Term Care, Division
- 14 of Public Health, Division of Developmental Disabilities, Division of
- 15 Children and Family Services, and the Division of Behavioral Health of
- 16 the department. The center shall ensure the privacy and security of the
- 17 <u>data accessed as part of the research.</u>
- 18 (2) On December 1 of each year beginning in 2020, the center shall
- 19 report electronically to the Health and Human Services Committee of the
- 20 Legislature and the Appropriations Committee of the Legislature on the
- 21 work of the center and any recommendations for policy changes resulting
- 22 from such work.
- 23 Sec. 3. (1) On or before January 1, 2020, the department shall
- 24 <u>submit an application to the federal Centers for Medicare and Medicaid</u>
- 25 Services of the United States Department of Health and Human Services to
- 26 amend the medicaid state plan or seek a waiver to provide for the
- 27 creation and administration of the Medicaid Cost and Quality Data and
- 28 Analysis Center of Nebraska, funded through the Nebraska Health Care Cash
- 29 Fund which shall be used as the state match for the federal medical
- 30 assistance percentage, to research data and provide policy
- 31 recommendations to decrease the cost of the medical assistance provided

- 1 by the medical assistance program and improve access to and quality of
- 2 <u>care provided by the medical assistance program.</u>
- 3 (2) Upon approval of the amendment to the medicaid state plan or the
- 4 granting of the waiver, the State Treasurer shall transfer the funds to
- 5 the Board of Regents of the University of Nebraska to provide funds to
- 6 the University of Nebraska Medical Center for operation of the Medicaid
- 7 Cost and Quality Data and Analysis Center of Nebraska.
- 8 Sec. 4. Section 81-666, Reissue Revised Statutes of Nebraska, is
- 9 amended to read:
- 10 81-666 (1) The department may approve an individual or entity to be
- 11 an approved researcher upon application and proof satisfactory to the
- 12 department that the applicant is a qualified researcher, that the data
- 13 will be used for bona fide scientific or medical research for prevention,
- 14 cure, or control of certain diseases or injuries, and that the applicant
- 15 will maintain the confidentiality and security of data obtained. The
- 16 application shall contain, but not be limited to, the following
- 17 information:
- 18 $\frac{(a)}{(a)}$ The qualifications of the applicant and of the principal
- 19 investigator, if other than the applicant, including education,
- 20 experience, prior publications, and recommendations of professional
- 21 colleagues who have knowledge and experience of scientific or medical
- 22 research;
- 23 (b) (2) The purpose of the research project, a summary of the
- 24 project, and the anticipated time of completion of such project;
- 25 (c) (3) The location where the research project will be conducted
- 26 and the equipment, personnel, and other resources available to the
- 27 applicant to carry out the project;
- 28 (d) (4) The identity of the individual or entity funding the
- 29 research project, a description of the availability of funds for the
- 30 research project, and any conditions on the receipt or continuation of
- 31 such funding;

- 1 $\underline{\text{(e)}}$ (5) The specific data requested and a description of the use to
- 2 be made of such data and, if patient-identifying data is requested, a
- 3 substantiation of the need for access to such patient-identifying data;
- 4 (f) (6) A description of the measures to be taken to secure the data
- 5 and maintain the confidentiality of such data during the research
- 6 project, for disposal of the data upon completion of the study, and to
- 7 assure that the results of the study will not divulge or make public
- 8 information that will disclose the identity of any individual patient;
- 9 (g) (7) If contact with a patient or patient's family is planned or
- 10 expected, substantiation of the need for such contact and a description
- 11 of the method to be used to obtain permission from such patient or
- 12 patient's family for such contact; and
- (h) (8) Such additional information as the department determines to
- 14 be necessary to assure that release of data to the applicant is
- 15 appropriate and will further the purpose of sections 81-663 to 81-675 or
- 16 the laws governing the specific registry.
- 17 (2) The department shall approve the University of Nebraska Medical
- 18 <u>Center as an approved researcher for purposes of the Medicaid</u> Cost and
- 19 Quality Data and Analysis Center of Nebraska.
- 20 Sec. 5. Original section 81-666, Reissue Revised Statutes of
- 21 Nebraska, and section 68-901, Revised Statutes Supplement, 2017, as
- 22 amended by section 1, Initiative Law 2018, No. 427, are repealed.
