- 1 A BILL FOR AN ACT relating to motor vehicles; to amend sections 60-301,
- 2 60-393, 60-395, 60-396, 60-3,104, 60-3,130.04, and 60-495, Revised
- 3 Statutes Supplement, 2019; to provide for Donate Life Plates; to
- 4 harmonize provisions; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 60-301, Revised Statutes Supplement, 2019, is
- 2 amended to read:
- 3 60-301 Sections 60-301 to 60-3,244 <u>and sections 7 and 8 of this act</u>
- 4 shall be known and may be cited as the Motor Vehicle Registration Act.
- 5 Sec. 2. Section 60-393, Revised Statutes Supplement, 2019, is
- 6 amended to read:
- 7 60-393 Any owner who has two or more motor vehicles or trailers
- 8 required to be registered under the Motor Vehicle Registration Act may
- 9 register all such motor vehicles or trailers on a calendar-year basis or
- 10 on an annual basis for the same registration period beginning in a month
- 11 chosen by the owner. When electing to establish the same registration
- 12 period for all such motor vehicles or trailers, the owner shall pay the
- 13 registration fee, the motor vehicle tax imposed in section 60-3,185, the
- 14 motor vehicle fee imposed in section 60-3,190, and the alternative fuel
- 15 fee imposed in section 60-3,191 on each motor vehicle for the number of
- 16 months necessary to extend its current registration period to the
- 17 registration period under which all such motor vehicles or trailers will
- 18 be registered. Credit shall be given for registration paid on each motor
- 19 vehicle or trailer when the motor vehicle or trailer has a later
- 20 expiration date than that chosen by the owner except as otherwise
- 21 provided in sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128,
- 22 60-3,224, 60-3,227, 60-3,233, 60-3,235, 60-3,238, 60-3,240, 60-3,242, and
- 23 60-3,244 and section 8 of this act. Thereafter all such motor vehicles or
- 24 trailers shall be registered on an annual basis starting in the month
- 25 chosen by the owner.

- 17 registered is subsequently declared by legislative act or court decision
- 18 to be illegal or ineligible to be operated or towed on the public roads
- 19 and no longer subject to registration fees, the motor vehicle tax imposed
- 20 in section 60-3,185, the motor vehicle fee imposed in section 60-3,190,
- 21 and the alternative fuel fee imposed in section 60-3,191;
- (e) Upon a trade-in or surrender of a motor vehicle under a lease;

- 24 (f) In case of a change in the situs of a motor vehicle or trailer
- 25 to a location outside of this state.
- 26 (2) If the date of the event falls within the same calendar month in
- 27 which the motor vehicle or trailer is acquired, no refund shall be
- 28 allowed for such month.
- 29 (3) If the transferor or lessee acquires another motor vehicle at
- 30 the time of the transfer, trade-in, or surrender, the transferor or
- 31 lessee shall have the credit provided for in this section applied toward

- 1 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 2 transferor or lessee shall file a claim for refund with the county
- 3 treasurer upon an application form prescribed by the department.
- 4 (4) The registered owner or lessee shall make a claim for refund or
- 5 credit of the fees and taxes for the unexpired months in the registration
- 6 period within sixty days after the date of the event or shall be deemed
- 7 to have forfeited his or her right to such refund or credit.
- 8 (5) For purposes of this section, the date of the event shall be:
- 9 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 10 (b) in the case of a change in the situs, the date of registration in
- 11 another state; (c) in the case of a trade-in or surrender under a lease,
- 12 the date of trade-in or surrender; (d) in the case of a legislative act,
- 13 the effective date of the act; and (e) in the case of a court decision,
- 14 the date the decision is rendered.
- 15 (6) Application for registration or for reassignment of license
- 16 plates and, when appropriate, validation decals to another motor vehicle
- 17 or trailer shall be made within thirty days of the date of purchase.
- 18 (7) If a motor vehicle or trailer was reported stolen under section
- 19 60-178, a refund under this section shall not be reduced for a lost plate
- 20 charge and a credit under this section may be reduced for a lost plate
- 21 charge but the applicant shall not be required to pay the plate fee for
- 22 new plates.
- 23 (8) The county treasurer shall refund the motor vehicle fee and
- 24 registration fee from the fees which have not been transferred to the
- 25 State Treasurer. The county treasurer shall make payment to the claimant
- 26 from the undistributed motor vehicle taxes of the taxing unit where the
- 27 tax money was originally distributed. No refund of less than two dollars
- 28 shall be paid.

When no such 19 replacement motor vehicle, trailer, or semitrailer is so registered, the 20 county treasurer shall forward the application and affidavit, if any, to 21 the State Treasurer who shall determine the amount, if any, of the 22 allowable credit for the registration fee and issue a credit certificate 23 24 to the owner. For the motor vehicle tax and fee, the county treasurer shall determine the amount, if any, of the allowable credit and issue a 25 credit certificate to the owner. When such motor vehicle, trailer, or 26 semitrailer is removed from service within the same month in which it was 27 28 registered, no credits shall be allowed for such month. The credits may be applied against taxes and fees for new or replacement motor vehicles, 29 trailers, or semitrailers incurred within one year after cancellation of 30 registration of the motor vehicle, trailer, or semitrailer for which the 31

- 3 60-3,130.04 (1) An owner of a historical vehicle eligible for 4 registration under section 60-3,130 may use a license plate or plates 5 designed by this state in the year corresponding to the model year when the vehicle was manufactured in lieu of the plates designed pursuant to 6 section 60-3,130.03 subject to the approval of the department. The 7 department shall inspect the plate or plates and may approve the plate or 8 9 plates if it is determined that the model-year license plate or plates are legible and serviceable and that the license plate numbers do not 10 conflict with or duplicate other numbers assigned and in use. 11 original-issued license plate or plates that have been restored to 12 13 original condition may be used when approved by the department.
- (2) The department may consult with a recognized car club in determining whether the year of the license plate or plates to be used corresponds to the model year when the vehicle was manufactured.
- (3) If only one license plate is used on the vehicle, the license plate shall be placed on the rear of the vehicle. The owner of a historical vehicle may use only one plate on the vehicle even for years in which two license plates were issued for vehicles in general.
- (4) License plates used pursuant to this section corresponding to 21 the year of manufacture of the vehicle shall not be personalized message 22 23 license plates, Pearl Harbor license plates, prisoner-of-war license 24 plates, disabled veteran license plates, Purple Heart license plates, amateur radio station license plates, Nebraska Cornhusker Spirit Plates, 25 handicapped or disabled person license plates, specialty license plates, 26 special interest motor vehicle license plates, Military Honor Plates, 27 28 Nebraska 150 Sesquicentennial Plates, Breast Cancer Awareness Plates, Prostate Cancer Awareness Plates, Mountain Lion Conservation Plates, 29 Choose Life License Plates, Donate Life Plates, Native American Cultural 30 Awareness and History Plates, Sammy's Superheroes license plates for 31

- 3 Sec. 7. (1) The department shall design license plates to be known
- 4 as Donate Life Plates. The design shall support organ and tissue
- 5 <u>donation</u>, registration as a donor on the Donor Registry of Nebraska, and
- 6 the federally designated organ procurement organization for Nebraska. The
- 7 design shall be selected on the basis of limiting the manufacturing cost
- 8 of each plate to an amount less than or equal to the amount charged for
- 9 license plates pursuant to section 60-3,102. The department shall make
- 10 applications available for this type of plate beginning January 1, 2021.
- 11 The department may adopt and promulgate rules and regulations to carry

- 25 registered under section 60-3,198. An applicant receiving a Donate Life
- 26 Plate for a farm truck with a gross weight of over sixteen tons or for a
- 27 <u>commercial motor vehicle registered for a gross weight of five tons or</u>
- 28 over shall affix the appropriate tonnage decal to the plate. The
- 29 department shall make forms available for such applications through the
- 30 county treasurers. The license plates shall be issued upon payment of the

1 (2)(a) In addition to all other fees required for registration under

- 2 the Motor Vehicle Registration Act, each application for initial issuance
- 3 or renewal of alphanumeric Donate Life Plates shall be accompanied by a
- 4 fee of five dollars. County treasurers collecting fees pursuant to this
- 5 subdivision shall remit such fees to the State Treasurer. The State
- 6 Treasurer shall credit five dollars of the fee to the Organ and Tissue
- 7 Donor Awareness and Education Fund.
- 8 (b) In addition to all other fees required for registration under
- 9 the Motor Vehicle Registration Act, each application for initial issuance
- 10 or renewal of personalized message Donate Life Plates shall be
- 11 <u>accompanied by a fee of forty dollars. County treasurers collecting fees</u>
- 12 pursuant to this subdivision shall remit such fees to the State
- 13 <u>Treasurer</u>. The State Treasurer shall credit twenty-five percent of the
- 14 fee for initial issuance and renewal of such plates to the Department of
- 15 Motor Vehicles Cash Fund and seventy-five percent of the fee to the Organ
- 16 and Tissue Donor Awareness and Education Fund.
- 17 (3) When the department receives an application for Donate Life
- 18 Plates, the department may deliver the plates and registration
- 19 certificate to the applicant by United States mail or to the county
- 20 treasurer of the county in which the motor vehicle or trailer is
- 21 registered and the delivery of the plates and registration certificate
- 22 shall be made through a secure process and system. The county treasurer
- 23 or the department shall issue Donate Life Plates in lieu of regular
- 24 license plates when the applicant complies with the other provisions of
- 25 the Motor Vehicle Registration Act for registration of the motor vehicle
- 26 or trailer. If Donate Life Plates are lost, stolen, or mutilated, the
- 27 <u>licensee shall be issued replacement license plates upon request pursuant</u>
- 28 to section 60-3,157.
- 29 <u>(4) The county treasurer or the department may issue temporary</u>
- 30 license stickers to the applicant under this section for the applicant to
- 31 lawfully operate the vehicle pending receipt of the license plates. No

- 1 charge in addition to the registration fee shall be made for the issuance
- 2 of a temporary license sticker under this subsection. The department
- 3 shall furnish temporary license stickers for issuance by the county
- 4 treasurer at no cost to the counties. The department may adopt and
- 5 promulgate rules and regulations regarding the design and issuance of
- 6 temporary license stickers.
- 7 <u>(5) The owner of a motor vehicle or trailer bearing Donate Life</u>
- 8 Plates may apply to the county treasurer to have such plates transferred
- 9 to a motor vehicle or trailer other than the motor vehicle or trailer for
- 10 which such plates were originally purchased if such motor vehicle or
- 11 trailer is owned by the owner of the plates. The owner may have the
- 12 unused portion of the fee for the plates credited to the other motor
- 13 vehicle or trailer which will bear the plates at the rate of eight and
- 14 one-third percent per month for each full month left in the registration
- 15 period. Application for such transfer shall be accompanied by a fee of
- 16 three dollars. Fees collected pursuant to this subsection shall be
- 17 remitted to the State Treasurer for credit to the Department of Motor
- 18 Vehicles Cash Fund.
- 19 (6) If the cost of manufacturing Donate Life Plates at any time
- 20 exceeds the amount charged for license plates pursuant to section
- 21 <u>60-3,102</u>, any money to be credited to the Organ and Tissue Donor
- 22 Awareness and Education Fund shall instead be credited first to the
- 23 Highway Trust Fund in an amount equal to the difference between the
- 24 manufacturing costs of Donate Life Plates and the amount charged pursuant
- 25 to section 60-3,102 with respect to such plates and the remainder shall
- 26 be credited to the Organ and Tissue Donor Awareness and Education Fund.

- 29 60-495 (1) The director may adopt and promulgate such rules and
- 30 regulations necessary to carry out sections 60-493 to 60-495 and the
- 31 duties of the department under the Revised Uniform Anatomical Gift Act.

- 1 The director shall prepare and furnish all forms and information
- 2 necessary under the act.
- 3 (2) The Organ and Tissue Donor Awareness and Education Fund is
- 4 created. Department personnel and the county treasurer shall remit all
- 5 funds contributed under sections 60-484, 60-4,144, and 60-4,181 to the
- 6 State Treasurer for credit to the fund. The fund shall also include any
- 7 money credited to the fund pursuant to section 8 of this act. The
- 8 Department of Health and Human Services shall administer the Organ and
- 9 Tissue Donor Awareness and Education Fund for the promotion of organ and
- 10 tissue donation. The department shall use the fund to assist
- 11 organizations such as the federally designated organ procurement
- 12 organization for Nebraska and the State Anatomical Board in carrying out
- 13 activities which promote organ and tissue donation through the creation
- 14 and dissemination of educational information. Any money in the fund
- 15 available for investment shall be invested by the state investment
- 16 officer pursuant to the Nebraska Capital Expansion Act and the Nebraska
- 17 State Funds Investment Act.
