## **LEGISLATIVE BILL 862**

- 1 A BILL FOR AN ACT relating to tobacco; to amend sections 28-1418 and
- 2 28-1418.01, Revised Statutes Supplement, 2019; to prohibit
- 3 possession by minors of tobacco, electronic nicotine delivery
- 4 systems, or alternative nicotine products as prescribed; to redefine
- 5 a term; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 28-1418, Revised Statutes Supplement, 2019, is
- 2 amended to read:
- 3 28-1418 (1) A Whoever, being a person under the age of nineteen
- 4 years, shall not smoke or possess cigarettes or cigars, use or possess
- 5 electronic nicotine delivery systems or alternative nicotine products, or
- 6 use or possess tobacco in any form whatever. A violation of this section
- 7 is , in this state, shall be guilty of a Class V misdemeanor.
- 8 (2) Any person charged with a violation of this section may be free
- 9 from prosecution if he or she furnishes evidence for the conviction of
- 10 the person or persons selling or giving him or her the cigarettes,
- 11 cigars, electronic nicotine delivery systems, alternative nicotine
- 12 products, or tobacco.

- 15 28-1418.01 For purposes of sections 28-1418 to 28-1429.03:
- 16 (1) Alternative nicotine product means any noncombustible product
- 17 containing nicotine that is intended for human consumption, whether
- 18 chewed, absorbed, dissolved, or ingested by any other means. Alternative
- 19 nicotine product does not include any electronic nicotine delivery
- 20 system, cigarette, cigar, or other tobacco product, or any product
- 21 regulated as a drug or device by the United States Food and Drug
- 22 Administration under Chapter V of the Federal Food, Drug, and Cosmetic
- 23 Act;
- 24 (2) Cigarette means any product that contains nicotine, is intended
- 25 to be burned or heated under ordinary conditions of use, and consists of
- 26 or contains (a) any roll of tobacco wrapped in paper or in any substance
- 27 not containing tobacco, (b) tobacco, in any form, that is functional in
- 28 the product which, because of its appearance, the type of tobacco used in
- 29 the filler, or its packaging and labeling, is likely to be offered to, or
- 30 purchased by, consumers as a cigarette, or (c) any roll of tobacco
- 31 wrapped in any substance containing tobacco which, because of its

- 1 appearance, the type of tobacco used in the filler, or its packaging and
- 2 labeling, is likely to be offered to, or purchased by, consumers as a
- 3 cigarette described in subdivision (2)(a) of this section;
- 4 (3)(a) Electronic nicotine delivery system means any product or
- 5 device <u>designed or manufactured to contain</u> containing nicotine, tobacco,
- 6 or tobacco derivatives that employs a heating element, power source,
- 7 electronic circuit, or other electronic, chemical, or mechanical means,
- 8 regardless of shape or size, to simulate smoking by delivering the
- 9 nicotine, tobacco, or tobacco derivatives in vapor, fog, mist, gas, or
- 10 aerosol form to a person inhaling from the product or device. A product
- 11 <u>or device may constitute an electronic nicotine delivery system</u>
- 12 <u>regardless of whether the product or device actually contains nicotine,</u>
- 13 <u>tobacco, or tobacco derivatives.</u>
- 14 (b) Electronic nicotine delivery system includes, but is not limited
- 15 to, the following:
- 16 (i) Any substance containing nicotine, tobacco, or tobacco
- 17 derivatives, whether sold separately or sold in combination with a
- 18 product or device, that is intended to deliver to a person nicotine,
- 19 tobacco, or tobacco derivatives in vapor, fog, mist, gas, or aerosol
- 20 form;
- 21 (ii) Any product or device marketed, manufactured, distributed, or
- 22 sold as an electronic cigarette, electronic cigar, electronic cigarillo,
- 23 electronic pipe, electronic hookah, or similar products, names,
- 24 descriptors, or devices; and
- 25 (iii) Any component, part, or accessory of such a product or device
- 26 that is used during operation of the product or device when sold in
- 27 combination with any substance containing nicotine, tobacco, or tobacco
- 28 derivatives.
- (c) Electronic nicotine delivery system does not include the
- 30 following:
- 31 (i) An alternative nicotine product, cigarette, cigar, or other

- 1 tobacco product, or any product regulated as a drug or device by the
- 2 United States Food and Drug Administration under Chapter V of the Federal
- 3 Food, Drug, and Cosmetic Act; or
- 4 (ii) Any component, part, or accessory of such a product or device
- 5 that is used during operation of the product or device when not sold in
- 6 combination with any substance containing nicotine, tobacco, or tobacco
- 7 derivatives;
- 8 (4) Self-service display means a retail display that contains a
- 9 tobacco product, a tobacco-derived product, an electronic nicotine
- 10 delivery system, or an alternative nicotine product and is located in an
- 11 area openly accessible to a retailer's customers and from which such
- 12 customers can readily access the product without the assistance of a
- 13 salesperson. Self-service display does not include a display case that
- 14 holds tobacco products, tobacco-derived products, electronic nicotine
- 15 delivery systems, or alternative nicotine products behind locked doors;
- 16 and
- 17 (5) Tobacco specialty store means a retail store that (a) derives at
- 18 least seventy-five percent of its revenue from tobacco products, tobacco-
- 19 derived products, electronic nicotine delivery systems, or alternative
- 20 nicotine products and (b) does not permit persons under the age of
- 21 nineteen years to enter the premises unless accompanied by a parent or
- 22 legal guardian.
