New resolutions: LR4 by Senator Gragert would congratulate the Creighton Bulldogs football team for winning the 2018 Class D-1 State Football Championship. LR5CA by Senator Brewer is a proposed constitutional amendment to require that no more than thirty-three percent of the funding for the free education in the common schools shall come from property tax. LR6 by Senator Geist would extend sympathy to the family of Ruth Raymond Thone. In addition to that, Mr. President, the Judiciary Committee announces that Senator Pansing Brooks has been selected as Vice Chair, and Banking, Commerce and Insurance Committee has selected Senator Lindstrom as Vice Chair. Senator Wishart has designated LB110 as a priority bill. An announcement that the Agriculture Committee will meet at 11:30 in Room 2022, that's the Ag Committee at 11:30 in Room 2022. Referencing Committee will meet in Room 1003 upon adjournment.

And finally, Mr. President, a priority motion. Senator Walz would move to adjourn until Monday, January 14, 2019, at 10:00 a.m.
