Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change provisions relating to appointment of counsel for juveniles.

It provides that a court shall not accept a juvenile's waiver of the right to counsel unless the county or city attorney waives any possible placement outside of the juvenile's home.

If the court accepts the juvenile's waiver of counsel, any order shall show that the juvenile cannot be removed from the home.

The bill provides that on or before July 1, 2022, the Supreme Court shall provide a process to ensure that juveniles are provided the opportunity to consult with counsel to assist in making the decision to waive counsel.

The Supreme Court estimates a minimal fiscal impact to provide judicial branch education, case management modifications (JUSTICE), and to create court rules. They also estimate an unknown workload impact.

Because the bill change provisions relating to appointment of counsel for juveniles, it is possible that counties could incur costs relating to the appointment of counsel for juveniles who are indigent, either through their public defender's office if they have one or by hiring an attorney to represent an indigent juvenile.
