LB 520 allows an authority to fix and charge an application fee for the submission, processing, and review of a facilities request to collocate a new wireless facility, site a new wireless support structure, or substantially change an existing wireless facility or wireless support structure. The application fee shall be based on the authority's actual, direct, and objectively reasonable costs incurred for all aspects of an application review process. Any costs incurred by an authority for review by an outside consultant shall be included in the application fee, and be based on objectively reasonable costs. Such fees shall not exceed the usual and customary fee charged for the services provided.

Authority is defined as: "(A)ny county, city, or village whose authorization is necessary prior to the deployment of a wireless facility."
