Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB964 provides that a member of the State Patrol shall be reimbursed 100% of the per diem rate while in a travel status except when a member is providing executive protection. When providing executive protection the member shall be reimbursed in full for actual meal expenses if the expenses exceed 100% of the established per diem rate.

The Department of Administrative Services indicates they will not experience a fiscal impact. There is no basis to disagree.

The State Patrol estimates an increase in expenditures in the amount of \$32,827 each fiscal year. Of this total, \$20,325 are General Funds, \$8,932 Cash Funds, and \$3,570 Federal Funds. The minimal estimated increase in expenditures can be absorbed within the agencies existing appropriation.
