- 1 A BILL FOR AN ACT relating to the Uniform Standard Code for Manufactured
- 2 Homes and Recreational Vehicles; to amend section 71-4603, Reissue
- 3 Revised Statutes of Nebraska; to redefine terms; to repeal the
- 4 original section; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-4603, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 71-4603 For purposes of the Uniform Standard Code for Manufactured
- 4 Homes and Recreational Vehicles, unless the context otherwise requires:
- 5 (1) Camping trailer means a vehicular portable unit mounted on
- 6 wheels and constructed with collapsible partial side walls which fold for
- 7 towing by another vehicle and unfold at the campsite to provide temporary
- 8 living quarters for recreational, camping, or travel use;
- 9 (2) Commission means the Public Service Commission;
- 10 (3) Dealer means a person licensed by the state pursuant to the
- 11 Motor Vehicle Industry Regulation Act as a dealer in manufactured homes
- 12 or recreational vehicles or any other person, other than a manufacturer,
- 13 who sells, offers to sell, distributes, or leases manufactured homes or
- 14 recreational vehicles primarily to persons who in good faith purchase or
- 15 lease a manufactured home or recreational vehicle for purposes other than
- 16 resale;
- 17 (4) Defect means a failure to conform to an applicable construction
- 18 standard that renders the manufactured home or recreational vehicle or
- 19 any component of the manufactured home or recreational vehicle not fit
- 20 for the ordinary use for which it was intended but does not result in an
- 21 unreasonable risk of injury or death to occupants;
- 22 (5) Distributor means any person engaged in the sale and
- 23 distribution of manufactured homes or recreational vehicles for resale;
- 24 (6) Failure to conform means a defect, a serious defect,
- 25 noncompliance, or an imminent safety hazard related to the code;
- 26 (7) Fifth-wheel trailer means a unit mounted on wheels, designed to
- 27 provide temporary living quarters for recreational, camping, or travel
- 28 use, of such size or weight as not to require a special highway movement
- 29 permit, of gross trailer area not to exceed four hundred thirty square
- 30 feet in the setup mode, and designed to be towed by a motorized vehicle
- 31 that contains a towing mechanism that is mounted above or forward of the

- 1 tow vehicle's rear axle;
- (8) Gross trailer area means the total plan area measured on the exterior to the maximum horizontal projections of exterior wall in the setup mode and includes all siding, corner trims, moldings, storage spaces, expandable room sections regardless of height, and areas enclosed by windows but does not include roof overhangs. Storage lofts contained within the basic unit shall have ceiling heights less than five feet and shall not constitute additional square footage. Appurtenances, as defined
- 11 (9) Imminent safety hazard means a hazard that presents an imminent 12 and unreasonable risk of death or severe personal injury;

calculating the gross trailer area as provided in such subdivision;

in subdivision (2)(k) of section 60-6,288, shall not be considered in

- 13 (10) Manufactured home means a structure, transportable in one or more sections, which in the traveling mode is eight body feet or more in 14 width or forty body feet or more in length or when erected on site is 15 three hundred twenty or more square feet and which is built on a 16 permanent chassis and designed to be used as a dwelling with or without a 17 permanent foundation when connected to the required utilities and 18 includes the plumbing, heating, air conditioning, and electrical systems 19 contained in the structure, except that manufactured home includes any 20 structure that meets all of the requirements of this subdivision other 21 22 than the size requirements and with respect to which the manufacturer voluntarily files a certification required by the United States Secretary 23 24 of Housing and Urban Development and complies with the standards 25 established under the National Manufactured Housing Construction and Safety Standards Act of 1974, as such act existed on September 1, 2001, 26 27 42 U.S.C. 5401 et seq.;
- (11) Manufactured-home construction means all activities relating to the assembly and manufacture of a manufactured home, including, but not limited to, activities relating to durability, quality, and safety;
- 31 (12) Manufactured-home safety means the performance of a

- 1 manufactured home in such a manner that the public is protected against
- 2 any unreasonable risk of the occurrence of accidents due to the design or
- 3 construction of such manufactured home or any unreasonable risk of death
- 4 or injury to the user or to the public if such accidents do occur;
- 5 (13) Manufacturer means any person engaged in manufacturing,
- 6 assembling, or completing manufactured homes or recreational vehicles;
- 7 (14) Motor home means a vehicular unit primarily designed to provide
- 8 temporary living quarters which are built into an integral part of, or
- 9 permanently attached to, a self-propelled motor vehicle chassis or van,
- 10 containing permanently installed independent life-support systems that
- 11 meet the state standard for recreational vehicles and providing at least
- 12 four of the following facilities: Cooking; refrigeration or ice box;
- 13 self-contained toilet; heating, air conditioning, or both; a potable
- 14 water supply system including a faucet and sink; separate one-hundred-
- 15 twenty-nominal-volt electrical power supply; or LP gas supply;
- 16 (15) Noncompliance means a failure to comply with an applicable
- 17 construction standard that does not constitute a defect, a serious
- 18 defect, or an imminent safety hazard;
- 19 (16) Park <u>model recreational vehicle</u> trailer means a vehicular unit
- 20 which meets the following criteria:
- 21 (a) Is designed and marketed as temporary living quarters for
- 22 recreational, camping, travel, or seasonal use;
- 23 (b) Is not permanently affixed to real property for use as a
- 24 permanent dwelling;
- 25 (c) Is built on a single chassis mounted on wheels with a gross
- 26 <u>trailer area not exceeding four hundred square feet in the set up mode;</u>
- 27 and
- 28 (d) Is certified by the manufacturer as complying with the ANSI
- 29 A119.5 Park Model Recreational Vehicle Standard of the American National
- 30 Standards Institute, 2020 edition;
- 31 (a) Built on a single chassis mounted on wheels;

- 1 (b) Designed to provide seasonal or temporary living quarters which
- 2 may be connected to utilities necessary for operation of installed
- 3 fixtures and appliances;
- 4 (c) Constructed to permit setup by persons without special skills
- 5 using only hand tools which may include lifting, pulling, and supporting
- 6 devices; and
- 7 (d) Having a gross trailer area not exceeding four hundred thirty
- 8 square feet when in the setup mode;
- 9 (17) Person means any individual, partnership, limited liability
- 10 company, company, corporation, or association engaged in manufacturing,
- 11 selling, offering to sell, or leasing manufactured homes or recreational
- 12 vehicles;
- 13 (18) Purchaser means the first person purchasing a manufactured home
- 14 or recreational vehicle in good faith for purposes other than resale;
- 15 (19) Recreational vehicle means a vehicular type unit primarily
- 16 designed as temporary living quarters for recreational, camping, or
- 17 travel use, which unit either has its own motive power or is mounted on
- 18 or towed by another vehicle. Recreational vehicle includes, but is not
- 19 limited to, travel trailer, park model recreational vehicle trailer,
- 20 camping trailer, truck camper, motor home, and van conversion;
- 21 (20) Seal means a device or insignia issued by the Department of
- 22 Health and Human Services Regulation and Licensure prior to May 1, 1998,
- 23 or by the Public Service Commission on or after May 1, 1998, to be
- 24 displayed on the exterior of a manufactured home or recreational vehicle
- 25 to evidence compliance with state standards. The federal manufactured-
- 26 home label shall be recognized as a seal;
- 27 (21) Serious defect means a failure to conform to an applicable
- 28 construction standard that renders the manufactured home or recreational
- 29 vehicle or any component of the manufactured home or recreational vehicle
- 30 not fit for the ordinary use for which it was intended and which results
- 31 in an unreasonable risk of injury or death to the occupants;

- 1 (22) Travel trailer means a vehicular unit mounted on wheels,
- 2 designed to provide temporary living quarters for recreational, camping,
- 3 or travel use of such size or weight as not to require special highway
- 4 movement permits when towed by a motorized vehicle—and of gross trailer
- 5 area less than four hundred thirty square feet;
- 6 (23) Truck camper means a portable unit constructed to provide
- 7 temporary living quarters for recreational, travel, or camping use,
- 8 consisting of a roof, floor, and sides and designed to be loaded onto and
- 9 unloaded from the bed of a pickup truck; and
- 10 (24) Van conversion means a completed vehicle permanently altered
- 11 cosmetically, structurally, or both which has been recertified by the
- 12 state as a multipurpose passenger vehicle but which does not conform to
- 13 or otherwise meet the definition of a motor home in this section and
- 14 which contains at least one plumbing, heating, or one-hundred-twenty-
- 15 nominal-volt electrical component subject to the provisions of the state
- 16 standard for recreational vehicles. Van conversion does not include any
- 17 such vehicle that lacks any plumbing, heating, or one-hundred-twenty-
- 18 nominal-volt electrical system but contains an extension of the low-
- 19 voltage automotive circuitry.
- 20 Sec. 2. Original section 71-4603, Reissue Revised Statutes of
- 21 Nebraska, is repealed.
- 22 Sec. 3. Since an emergency exists, this act takes effect when
- 23 passed and approved according to law.
