- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated \$500,000 Federal Funds for
- 2 FY2022-23 to the Department of Health and Human Services, for Program 33,
- 3 to aid in carrying out the provisions of Legislative Bill 376, One
- 4 Hundred Seventh Legislature, Second Session, 2022. The Federal Funds
- 5 appropriated in this section are from the funds allocated to the State of
- 6 Nebraska pursuant to the federal American Rescue Plan Act of 2021, Public
- 7 Law 117-2, Subtitle J-Medicaid, Sec. 9817.
- 8 Sec. 2. There is hereby appropriated \$1,508,507 from the General
- 9 Fund and \$6,055,913 Federal Funds for FY2023-24 to the Department of
- 10 Health and Human Services, for Program 424, to aid in carrying out the
- 11 provisions of Legislative Bill 376, One Hundred Seventh Legislature,
- 12 <u>Second Session, 2022. The Federal Funds appropriated in this section are</u>
- 13 <u>from the funds allocated to the State of Nebraska pursuant to the federal</u>
- 14 American Rescue Plan Act of 2021, Public Law 117-2, Subtitle J-Medicaid,
- 15 Sec. 9817.
- There is included in the appropriation to this program for FY2023-24
- 17 \$1,508,507 General Funds and \$6,055,913 Federal Funds for state aid,
- 18 which shall only be used for such purpose.
- 19 Sec. 3. <u>There is hereby appropriated \$510,131 from the General Fund</u>
- 20 and \$1,660,224 from federal funds for FY2023-24 to the Department of
- 21 Health and Human Services, for Program 33, to aid in carrying out the
- 22 provisions of Legislative Bill 376, One Hundred Seventh Legislature,
- 23 Second Session, 2022.
- 24 Sec. 4. There is hereby appropriated \$8,288,373 from federal funds
- 25 for FY2023-24 to the Department of Health and Human Services, for Program
- 26 348, to aid in carrying out the provisions of Legislative Bill 376, One
- 27 <u>Hundred Seventh Legislature, Second Session, 2022.</u>
- 28 Total expenditures for permanent and temporary salaries and per
- 29 <u>diems from funds appropriated in this section shall not exceed \$2,044,738</u>
- 30 <u>for FY2023-24.</u>
