- A BILL FOR AN ACT relating to the State Athletic Commissioner; to amend sections 81-8,134 and 81-8,138, Reissue Revised Statutes of Nebraska, and sections 81-8,129, 81-8,130.01, 81-8,132, 81-8,133, 81-8,133.01, 81-8,135, and 81-8,139, Revised Statutes Cumulative Supplement, 2020; to authorize the regulation of professional kickboxing and professional bare-knuckle boxing; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-8,129, Revised Statutes Cumulative Supplement,

- 2 2020, is amended to read:
- 3 81-8,129 The State Athletic Commissioner shall have sole direction,
- 4 management, control, and jurisdiction over all professional mixed martial
- 5 arts, professional boxing, professional kickboxing, professional bare-
- 6 <u>knuckle boxing</u>, and professional sparring matches and exhibitions and all
- 7 amateur mixed martial arts matches and exhibitions to be held within the
- 8 state, except such as are conducted by universities, colleges, high
- 9 schools, the military, and recognized amateur associations for
- 10 contestants under sixteen years of age. No professional boxers,
- 11 professional mixed martial arts contestants, professional kickboxers,
- 12 professional bare-knuckle boxers, or amateur mixed martial arts
- 13 contestants who have attained the age of sixteen, shall participate in a
- 14 match or exhibition for a prize or purse, or at which an admission fee is
- 15 charged, either directly or indirectly, in the form of dues or otherwise,
- 16 in this state except by a club, association, organization, or person
- 17 licensed by the commissioner, as provided in section 81-8,130, and in
- 18 pursuance of a license granted by the commissioner for such match or
- 19 exhibition under section 81-8,130.01.
- Sec. 2. Section 81-8,130.01, Revised Statutes Cumulative Supplement,
- 21 2020, is amended to read:
- 22 81-8,130.01 Licenses and permits may be issued to professional mixed
- 23 martial arts, or professional boxing, professional kickboxing, or
- 24 <u>professional bare-knuckle boxing</u> promoters, whether persons, clubs, or
- 25 associations, for the sole purpose of conducting professional matches
- 26 under such rules and regulations as the State Athletic Commissioner shall
- 27 adopt. Each application for such license shall be accompanied by a fee
- 28 set by the commissioner in rule and regulation. Such fee shall be not
- 29 less than one hundred dollars and not more than three hundred dollars. If
- 30 the promoter is an individual, the application shall include his or her
- 31 social security number.

- 7 professional kickboxing, or professional bare-knuckle boxing. The license

- 15 81-8,133 The State Athletic Commissioner is authorized to grant
- 16 licenses to competent referees, upon an application and the payment of a
- 17 fee set by the commissioner in rule and regulation. Such fee shall be not
- 18 less than ten dollars and not more than forty dollars per annum. The
- 19 commissioner may revoke any license so granted for such cause as may be
- 20 deemed sufficient. At every professional boxing, professional mixed
- 21 martial arts, professional kickboxing, professional bare-knuckle boxing,
- 22 amateur mixed martial arts, or professional sparring match or exhibition,
- 23 there shall be in attendance a duly licensed referee, who shall direct
- 24 and control the match. The referee shall stop the match whenever he or
- 25 she deems it advisable, (1) because of the physical condition of the
- 26 contestants or one of them, (2) when one of the contestants is clearly
- 27 outclassed by his or her opponent, or (3) for any other sufficient
- 28 reason. The referee shall, at the termination of every professional
- 29 boxing, professional mixed martial arts, professional kickboxing,
- 30 <u>professional bare-knuckle boxing,</u> amateur mixed martial arts, or
- 31 professional sparring match or exhibition, indicate a winner. The fees of

1 the referee and other licensed officials may be fixed by the commissioner

- 4 2020, is amended to read:
- 5 81-8,133.01 The State Athletic Commissioner may grant licenses to
- 6 qualified physicians, managers, matchmakers, and professional mixed
- 7 martial arts, professional boxing, professional kickboxing, professional
- 8 <u>bare-knuckle boxing</u>, or professional sparring match or exhibition judges
- 9 upon an application and payment of an annual fee set by the commissioner
- in rule and regulation. Such fee for matchmakers shall be not less than
- 11 ten dollars and not more than one hundred dollars. Such fee for
- 12 physicians, managers, and professional mixed martial arts, professional
- 13 boxing, professional kickboxing, professional bare-knuckle boxing, or
- 14 professional sparring match or exhibition judges shall be not less than
- ten dollars and not more than twenty dollars. The commissioner may also
- 16 grant licenses to qualified timekeepers, contestants, and seconds upon an
- 17 application and payment of an annual fee set by the commissioner in rule
- 18 and regulation. Such fee shall be not less than ten dollars and not more
- 19 than twenty dollars. The application shall include the applicant's social
- 20 security number. No person shall serve as physician, manager, matchmaker,
- 21 or judge at any professional mixed martial arts, professional boxing,
- 22 professional kickboxing, professional bare-knuckle boxing, or
- 23 professional sparring match or exhibition who is not licensed as such. No
- 24 person shall serve as timekeeper or contestant at any professional mixed
- 25 martial arts, or professional boxing, professional kickboxing, or
- 26 professional bare-knuckle boxing match who is not licensed as such. The
- 27 commissioner shall have summary authority to stop any match at which any
- 28 person is serving in violation of the provisions of this section. Any
- 29 license granted under the provisions of this section may be revoked for
- 30 cause.

- 23 arts contestant, professional kickboxing contestant, professional bare-
- 24 <u>knuckle boxing contestant,</u> or amateur mixed martial arts contestant shall
- 25 be allowed to participate or take part in any contest in this state
- 26 unless a duly licensed physician shall certify in writing that such
- 27 contestant has taken a physical examination the day of the contest and is
- 28 physically fit to engage in the proposed contest.

martial arts, amateur mixed martial arts, or professional boxing, 1 2 professional kickboxing, or professional bare-knuckle boxing match shall furnish to the State Athletic Commissioner a written report showing the 3 articles of agreement between the contestants, the number of tickets sold 4 for each contest, the amount of the gross receipts thereof, the gross 5 receipts from sale of any television rights, and such other matters as 6 7 the commissioner shall prescribe. Within such time the licensee shall pay to the commissioner a tax of five percent of the total gross receipts of 8 9 any professional mixed martial arts, or professional boxing, professional kickboxing, or professional bare-knuckle boxing match or exhibition, 10 exclusive of state and federal taxes, except the gross receipts from sale 11 of television rights, and five percent of such rights, and five percent 12 13 of the total gross receipts of any amateur mixed martial arts match or exhibition, exclusive of state and federal taxes, except that if such 14 match or exhibition is conducted as an incidental feature in any event or 15 16 entertainment of a different character, such portion of the total 17 receipts shall be paid to the state as the commissioner may determine, or as may be fixed by rule adopted under section 81-8,139. 18

81-8,138 No contestant in any match or exhibition shall be paid for 21 services until the same are rendered, and should it be determined by the 22 State Athletic Commissioner that a contestant did not give an honest 23 24 exhibition of his or her skill, he or she shall not be paid. Any 25 contestant who shall participate in any sham or fake professional boxing, professional mixed martial arts, professional kickboxing, professional 26 27 bare-knuckle boxing, or amateur mixed martial arts match or exhibition shall be disqualified and shall not thereafter be permitted to contend in 28 any match or exhibition in this state, and any contestant who shall 29 participate in any sham or fake professional boxing, professional mixed 30 martial arts, professional kickboxing, professional bare-knuckle boxing, 31

1 or amateur mixed martial arts match or exhibition shall be guilty of a

- 2 violation of sections 81-8,128 to 81-8,142.01.
- 3 Sec. 9. Section 81-8,139, Revised Statutes Cumulative Supplement,
- 4 2020, is amended to read:
- 5 81-8,139 (1) Except as provided in subsection (2) of this section,
- 6 the State Athletic Commissioner shall adopt and promulgate such rules and
- 7 regulations for the administration and enforcement of sections 81-8,128
- 8 to 81-8,142.01 as he or she may deem necessary. Such rules and
- 9 regulations shall include, but not be limited to, the establishment of
- 10 written criteria for the granting and revoking of licenses, the setting
- 11 of license fees, and the qualification requirements for those to be
- 12 licensed as referees, physicians, managers, matchmakers, and professional
- 13 boxing, professional mixed martial arts, professional kickboxing,
- 14 <u>professional bare-knuckle boxing,</u> or professional sparring match or
- 15 exhibition judges. He or she shall have the power and may control and

- 21 contestants, an amount not to exceed one thousand dollars and may suspend
- 22 for a period, not to exceed one year, any licensee's right to participate
- 23 in or conduct any match or exhibition for unsportsmanlike conduct while
- 24 engaged in or arising directly from any match or exhibition, failure to
- 25 compete in good faith, engaging in any sham match or exhibition, or the
- 26 use of threatening and abusive language toward officials, other
- 27 contestants, or spectators.
- 28 (2) The State Athletic Commissioner may adopt and promulgate rules
- 29 and regulations to identify a list of substances banned for use by any
- 30 amateur or professional contestant and may require any contestant to
- 31 submit to a test for banned substances as a condition for allowing the

- 1 contestant's participation in a match or exhibition.
- 2 (3) The State Athletic Commissioner may suspend an amateur or professional contestant from competition for a period not to exceed one 3 4 year and may fine a professional contestant an amount not to exceed one 5 thousand five hundred dollars or forty percent of the prize or purse, whichever is greater, for a first offense of failing a test for a banned 6 7 substance on the list developed pursuant to subsection (2) of this section or for refusing to submit to such a test. He or she may suspend 8 9 an amateur or professional contestant from competition for a period not to exceed three years and may fine a professional contestant an amount 10 not to exceed three thousand dollars or seventy percent of the prize or 11 purse, whichever is greater, for any second such offense. He or she may 12 13 suspend an amateur or professional contestant from competition for life and may fine a professional contestant an amount not to exceed five 14 thousand dollars or one hundred percent of the prize or purse, whichever 15 16 is greater, for any third or subsequent such offense. For purposes of 17 determining if an offense under this subsection is a first, second, third, or subsequent offense, failing a test for banned substances and 18 refusing to submit to such a test shall be considered the same offense. 19
- (4) Before levying an administrative fine pursuant to this section,
  the State Athletic Commissioner shall set the matter for hearing.
  Proceedings to levy an administrative fine shall be contested cases
  prosecuted and appealable pursuant to the Administrative Procedure Act.
  At least ten days before the hearing, the State Athletic Commissioner
  shall serve notice of the time, date, and place of the hearing upon the
  licensee or other violator by personal or certified mail service.
- (5) The State Athletic Commissioner shall remit any administrative fines collected under this section to the State Treasurer for distribution in accordance with Article VII, section 5, of the Constitution of Nebraska.
