- 1 A BILL FOR AN ACT relating to appropriations; to appropriate federal
- funds to the Department of Health and Human Services; and to declare
- 3 an emergency.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) There is hereby appropriated \$60,000,000 from
- 2 Federal Funds for FY2022-23 to the Department of Health and Human
- 3 Services, for Program 348, for the purposes described in subsection (2)
- 4 of this section. The Federal Funds appropriated in this section are from
- 5 the funds allocated to the State of Nebraska from the federal Coronavirus
- 6 State Fiscal Recovery Fund pursuant to the federal American Rescue Plan
- 7 Act of 2021, Public Law 117-2, Subtitle M, Sec. 9901.
- 8 (2)(a) The Department of Health and Human Services shall provide
- 9 money to licensed and medicaid-certified nursing facilities in the
- 10 following manner:
- 11 (i) \$45,000,000 to medicaid-certified nursing facilities divided
- 12 proportionately by the medicaid-certified beds at such facilities; and
- 13 (ii) \$15,000,000 divided equally among the medicaid-certified
- 14 nursing facilities that were in the top twenty-five percent of medicaid-
- 15 <u>certified nursing facilities with the highest percentage of bed-days paid</u>
- 16 by medicaid in fiscal year 2021-22.
- 17 <u>(b) The money provided to the licensed and medicaid-certified</u>
- 18 nursing facilities by the Department of Health and Human Services shall
- 19 <u>be used to provide supplemental incentive payments for direct care staff</u>
- 20 <u>members employed at licensed and medicaid-certified nursing facilities.</u>
- 21 Such payments are intended to enhance employee recruitment and retention
- 22 and be provided in accordance with the requirements of the federal
- 23 American Rescue Plan Act of 2021.
- 24 (c) It is the intent of the Legislature that the money paid to the
- 25 licensed and medicaid-certified nursing facilities pursuant to this
- 26 <u>section be expended by such facilities for the purpose of enhancing</u>
- 27 <u>employee recruitment and retention of direct care staff during fiscal</u>
- 28 years 2022-23, 2023-24, and 2024-25.
- 29 <u>(d) For purposes of this section, direct care staff means nursing</u>
- 30 facility employees who regularly perform in-person work with residents,
- 31 interact with residents, or physically handle items handled by residents.

LB1089 2022

- 1 The term includes nurses, medication aides, therapists, therapy aides,
- 2 <u>dietary staff, social service and activity staff, housekeeping and</u>
- 3 <u>maintenance staff</u>, and other medical staff.
- 4 Sec. 2. Since an emergency exists, this act takes effect when
- 5 passed and approved according to law.
