## **LEGISLATIVE BILL 1125**

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate federal
- funds to the Department of Economic Development; and to declare an
- 3 emergency.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The Legislature hereby finds and declares that:
- 2 (a) Transportation, manufacturing, and related industries in
- 3 <u>Nebraska have been adversely impacted by the COVID-19 public health</u>
- 4 emergency in rural areas;
- 5 (b) Supply chain disruptions and restrictions in getting
- 6 <u>manufactured goods from factories to consumers caused product shortages</u>
- 7 and price inflation for consumers;
- 8 (c) The primary reasons for the supply chain disruptions are due to
- 9 (i) logistical bottlenecks caused by time and distance factors between
- 10 raw materials, manufacturers, and consumers, (ii) the lack of access for
- 11 manufacturers to rail facilities in Nebraska, (iii) mitigation efforts
- 12 <u>related to the COVID-19 public health emergency, (iv) the lack of</u>
- 13 production at manufacturing plants outside the state, and (v) delays in
- 14 transportation networks due to public health policies implemented by
- 15 local governments in response to the COVID-19 public health emergency;
- 16 (d) New railyard industrial access parks with spur access to main
- 17 rail lines and local workers are needed to increase the efficiency of
- 18 Nebraska's supply chain; and
- 19 (e) Recent price inflation for construction costs have hindered
- 20 construction efforts to address the issues described in this subsection.
- 21 (2) There is hereby appropriated \$75,000,000 from Federal Funds for
- 22 FY2022-23 to the Department of Economic Development for the purposes
- 23 described in subsection (3) of this section. The Federal Funds
- 24 appropriated in this section are from the funds allocated to the State of
- 25 Nebraska from the federal Coronavirus State Fiscal Recovery Fund pursuant
- 26 to the federal American Rescue Plan Act of 2021, Public Law 117-2,
- 27 Subtitle M, Sec. 9901.
- 28 <u>(3)(a) The Department of Economic Development shall provide grants</u>
- 29 <u>for new construction of industrial rail yards.</u>
- 30 (b) Any award of a grant pursuant to this section shall be
- 31 coordinated and administered by the Department of Economic Development in

- 1 <u>compliance with the federal American Rescue Plan Act of 2021.</u>
- 2 (c) The recipient of a grant pursuant to this section shall only
- 3 spend the grant in compliance with the federal American Rescue Plan Act
- 4 <u>of 2021.</u>
- 5 Sec. 2. Since an emergency exists, this act takes effect when
- 6 passed and approved according to law.
