## **LEGISLATIVE BILL 1167**

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate federal
- 2 funds to the Department of Economic Development and to the
- 3 Department of Labor; and to declare an emergency.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The Legislature hereby finds and declares that:
- 2 (a) The COVID-19 public health emergency (i) affected the economic
- 3 <u>well-being of workers, households, and businesses, (ii) impacted the</u>
- 4 demand for labor, and (iii) changed the skills required for the
- 5 workforce; and
- 6 (b) It is the policy of this state to respond to harmful economic
- 7 disruptions resulting from the COVID-19 public health emergency, which
- 8 caused disruptions in job retention and household and business
- 9 stabilization, by increasing (i) opportunities, placements, and retention
- 10 of internships across Nebraska, (ii) apprenticeship and workforce
- 11 <u>training programs across Nebraska, (iii) employment opportunities for</u>
- 12 <u>skilled workers in Nebraska, and (iv) wages for Nebraska workers.</u>
- 13 (2) There is hereby appropriated \$30,000,000 from Federal Funds for
- 14 FY2021-22 to the Department of Economic Development for enhancing and
- 15 <u>retaining Nebraska's workforce</u>. The Federal Funds appropriated in this
- 16 section are from the funds allocated to the State of Nebraska from the
- 17 federal Coronavirus State Fiscal Recovery Fund pursuant to the federal
- 18 American Rescue Plan Act of 2021, Public Law 117-2, Subtitle M, Sec.
- 19 9901.
- 20 (3)(a) The Department of Economic Development shall use thirty
- 21 million dollars of the funds appropriated in this section for an
- 22 internship grant program.
- 23 (b) The Department of Economic Development may create a program to
- 24 <u>administer the grants awarded pursuant to this section.</u>
- 25 (c) Any program created by the Department of Economic Development
- 26 pursuant to this subsection shall be coordinated and administered in
- 27 <u>compliance with the federal American Rescue Plan Act of 2021.</u>
- 28 Sec. 2. <u>(1) The Legislature hereby finds and declares that:</u>
- 29 <u>(a) The COVID-19 public health emergency (i) affected the economic</u>
- 30 well-being of workers, households, and businesses, (ii) impacted the
- 31 demand for labor, and (iii) changed the skills required for the

- 2 (b) It is the policy of this state to respond to harmful economic

- 8 <u>skilled workers in Nebraska, and (iv) wages for Nebraska workers.</u>
- 9 (2) There is hereby appropriated \$20,000,000 from Federal Funds for
- 10 FY2021-22 to the Department of Labor for enhancing and retaining
- 11 Nebraska's workforce. The Federal Funds appropriated in this section are
- 12 <u>from the funds allocated to the State of Nebraska from the federal</u>
- 13 <u>Coronavirus State Fiscal Recovery Fund pursuant to the federal American</u>
- 14 Rescue Plan Act of 2021, Public Law 117-2, Subtitle M, Sec. 9901.
- 15 (3)(a) The Department of Labor shall use the funds appropriated in
- 16 this section for a grant program to expand Nebraska's workforce.
- 17 (b) The Department of Labor may create a program to administer the
- 18 grants pursuant to this section to Nebraska businesses, economic
- 19 development or workforce organizations, political subdivisions, nonprofit
- 20 organizations, and education partners to support training, upskilling,
- 21 apprenticeship, and apprenticeship program development proposals.
- (c) Any program created by the Department of Labor pursuant to this
- 23 subsection shall be coordinated and administered in compliance with the
- 24 federal American Rescue Plan Act of 2021.
- 25 Sec. 3. Since an emergency exists, this act takes effect when
- 26 passed and approved according to law.
