1 A BILL FOR AN ACT relating to conversion therapy; to amend sections
2 38-101, 38-178, and 38-2894, Revised Statutes Cumulative Supplement,
3 2020; to prohibit conversion therapy and provide for disciplinary
4 sanctions under the Uniform Credentialing Act as prescribed; to
5 provide for a deceptive trade practice; to define terms; to prohibit
6 the use of funds for conversion therapy as prescribed; to eliminate
7 a duty of the Revisor of Statutes; to harmonize provisions; and to
8 repeal the original sections.
9 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 38-101, Revised Statutes Cumulative Supplement,
2 2020, is amended to read:

3 38-101 Sections 38-101 to 38-1,145 and section 3 of this act and the
4 following practice acts shall be known and may be cited as the Uniform
5 Credentialing Act:

19 Sec. 2. Section 38-178, Revised Statutes Cumulative Supplement,
20 2020, is amended to read:

21 38-178 Except as otherwise provided in sections 38-1,119 to
22 38-1,123, a credential to practice a profession may be denied, refused
23 renewal, or have other disciplinary measures taken against it in
24 accordance with section 38-185 or 38-186 on any of the following grounds:

25 (1) Misrepresentation of material facts in procuring or attempting
26 to procure a credential;

27 (2) Immoral or dishonorable conduct evidencing unfitness to practice
28 the profession in this state;

29 (3) Abuse of, dependence on, or active addiction to alcohol, any
30 controlled substance, or any mind-altering substance;

31 (4) Failure to comply with a treatment program or an aftercare

1 program, including, but not limited to, a program entered into under the
2 Licensee Assistance Program established pursuant to section 38-175;

3 (5) Conviction of (a) a misdemeanor or felony under Nebraska law or
4 federal law, or (b) a crime in any jurisdiction which, if committed
5 within this state, would have constituted a misdemeanor or felony under
6 Nebraska law and which has a rational connection with the fitness or
7 capacity of the applicant or credential holder to practice the
8 profession;

9 (6) Practice of the profession (a) fraudulently, (b) beyond its
10 authorized scope, (c) with gross incompetence or gross negligence, or (d)
11 in a pattern of incompetent or negligent conduct;

12 (7) Practice of the profession while the ability to practice is
13 impaired by alcohol, controlled substances, drugs, mind-altering
14 substances, physical disability, mental disability, or emotional
15 disability;

16 (8) Physical or mental incapacity to practice the profession as
17 evidenced by a legal judgment or a determination by other lawful means;

18 (9) Illness, deterioration, or disability that impairs the ability
19 to practice the profession;

20 (10) Permitting, aiding, or abetting the practice of a profession or
21 the performance of activities requiring a credential by a person not
22 credentialed to do so;

23 (11) Performing or offering to perform scleral tattooing as defined
24 in section 38-10,172 by a person not credentialed to do so;

25 (12) Having had his or her credential denied, refused renewal,
26 limited, suspended, revoked, or disciplined in any manner similar to
27 section 38-196 by another state or jurisdiction based upon acts by the
28 applicant or credential holder similar to acts described in this section;

29 (13) Use of untruthful, deceptive, or misleading statements in
30 advertisements, including failure to comply with section 38-124;

31 (14) Conviction of fraudulent or misleading advertising or

1 conviction of a violation of the Uniform Deceptive Trade Practices Act;

2 (15) Distribution of intoxicating liquors, controlled substances, or
3 drugs for any other than lawful purposes;

4 (16) Violations of the Uniform Credentialing Act or the rules and
5 regulations relating to the particular profession;

6 (17) Unlawful invasion of the field of practice of any profession
7 regulated by the Uniform Credentialing Act which the credential holder is
8 not credentialed to practice;

9 (18) Violation of the Uniform Controlled Substances Act or any rules
10 and regulations adopted pursuant to the act;

11 (19) Failure to file a report required by section 38-1,124,
12 38-1,125, or 71-552;

13 (20) Failure to maintain the requirements necessary to obtain a
14 credential;

15 (21) Violation of an order issued by the department;

16 (22) Violation of an assurance of compliance entered into under
17 section 38-1,108;

18 (23) Failure to pay an administrative penalty;

19 (24) Unprofessional conduct as defined in section 38-179;~~or~~

20 (25) Violation of the Automated Medication Systems Act;or ~~or~~

21 (26) Providing conversion therapy in violation of section 3 of this
22 act.

23 Sec. 3. (1) Except as provided in subsection (3) of this section, a
24 person holding a credential under the Medicine and Surgery Practice Act,
25 the Mental Health Practice Act, the Nurse Practice Act, the Pharmacy
26 Practice Act, or the Psychology Practice Act shall not provide conversion
27 therapy to any individual under nineteen years of age.

28 (2) A violation of subsection (1) of this section shall constitute a
29 deceptive trade practice under the Uniform Deceptive Trade Practices Act
30 and shall be subject to any remedies or penalties available for a
31 violation of such act.

1 (3) This section does not apply to a practice or treatment conducted
2 by a clergy member or religious counselor who is acting in a pastoral or
3 religious capacity and not in the capacity of a health care professional.

4 (4) For purposes of this section:

5 (a)(i) Conversion therapy means a practice or treatment that seeks
6 to change an individual's sexual orientation or gender identity,
7 including efforts to change behaviors or gender expressions or to
8 eliminate or reduce sexual or romantic attractions or feelings toward
9 individuals of the same gender; and

10 (ii) Conversion therapy does not mean a practice or treatment that
11 does not seek to change an individual's sexual orientation or gender
12 identity and that:

13 (A) Is neutral with respect to sexual orientation and gender
14 identity;

15 (B) Provides assistance to a patient or client undergoing gender
16 transition;

17 (C) Provides acceptance, support, and understanding to a patient or
18 client;

19 (D) Facilitates a patient's or client's ability to cope, develop
20 social support, and explore or understand the patient or client; or

21 (E) Addresses unlawful or unsafe sexual activities in a manner that
22 is neutral with respect to sexual orientation and gender identity; and

23 (b) Gender identity means an individual's internal sense of the
24 individual's own gender, regardless of the sex the individual was
25 assigned at birth.

26 Sec. 4. (1) No state funds nor any funds belonging to a political
27 subdivision of this state shall be expended for the purpose of:

28 (a) Conducting conversion therapy;

29 (b) Referring a person for conversion therapy; or

30 (c) Providing health benefits coverage for conversion therapy.

31 (2) For purposes of this section, conversion therapy has the same

1 meaning as in section 3 of this act.

2 Sec. 5. Section 38-2894, Revised Statutes Cumulative Supplement,
3 2020, is amended to read:

4 38-2894 (1) A registration to practice as a pharmacy technician may
5 be denied, refused renewal, removed, or suspended or have other
6 disciplinary measures taken against it by the department, with the
7 recommendation of the board, for failure to meet the requirements of or
8 for violation of any of the provisions of subdivisions (1) through (18)
9 and (20) through (26) ~~(25)~~ of section 38-178 and sections 38-2890 to
10 38-2897 or the rules and regulations adopted under such sections.

11 (2) If the department proposes to deny, refuse renewal of, or remove
12 or suspend a registration, it shall send the applicant or registrant a
13 notice setting forth the action to be taken and the reasons for the
14 determination. The denial, refusal to renew, removal, or suspension shall
15 become final thirty days after mailing the notice unless the applicant or
16 registrant gives written notice to the department of his or her desire
17 for an informal conference or for a formal hearing.

18 (3) Notice may be served by any method specified in section
19 25-505.01, or the department may permit substitute or constructive
20 service as provided in section 25-517.02 when service cannot be made with
21 reasonable diligence by any of the methods specified in section
22 25-505.01.

23 (4) Pharmacy technicians may participate in the Licensee Assistance
24 Program described in section 38-175.

26 Statutes Cumulative Supplement, 2020, are repealed.
