- 5 (1) Such person's activity consists of teaching in regularly
- established and recognized postsecondary educational institutions, 6
- 7 galleries, or libraries, or the publication or use of standard textbooks,
- films, tapes or visual aids of any such institution, or the practice of 8
- 9 licensed practitioners of medicine or of pharmacy in their regular
- 10 business or profession, or the possession by established postsecondary
- schools teaching art, or by public art galleries, or artists or models in 11
- the necessary line of their art, or to relevant references to, or 12

- process, law enforcement, postsecondary education, public libraries, or 15

- (2) Such person has no financial interest in an activity, product, 18
- or event entitling such person to participate in the promotion, 19
- management, proceeds, or profits of the activity, product, or event, and 20

- film shall not apply to a motion picture projectionist, usher, or ticket 26
- taker acting within the scope of <u>such person's</u> his employment if such 27
- projectionist, usher, or ticket taker has no financial interest in the 28
- place wherein such person he is so employed. Such person shall be 29
- required to give testimony regarding such employment in all judicial 30
- proceedings brought under sections 28-807 to 28-829 when granted immunity 31
