1 A BILL FOR AN ACT relating to the Sex Offender Registration Act; to amend 2 sections 29-4004, 29-4005, and 29-4006, Reissue Revised Statutes of 29-4007, 3 Nebraska, and section Revised Statutes Cumulative Supplement, 2020; to amend sections 29-4004, 29-4005, 29-4006, and 4 5 29-4007, Reissue Revised Statutes of Nebraska; to provide for 6 alternative methods of appearance and change provisions relating to 7 the registration period; to harmonize provisions; and to repeal the 8 original sections.

- 1 Section 1. Section 29-4004, Reissue Revised Statutes of Nebraska, is
- 29-4004 (1) Any person subject to the Sex Offender Registration Act shall register within three working days after becoming subject to the act at a location designated by the Nebraska State Patrol for purposes of
- 7 (2) Except as provided in subsection (12) of this section, any Any person required to register under the act shall inform the sheriff of the 8 9 county in which he or she resides, in person, and complete a form as prescribed by the Nebraska State Patrol for such purpose, if he or she 10 has a new address, temporary domicile, or habitual living location, 11 within three working days before the change. The sheriff shall submit 12 13 information to the sex offender registration and community notification division of the Nebraska State Patrol on the day it is 14 received and in a manner prescribed by the Nebraska State Patrol for such 15
- 17 (3) Except as provided in subsection (12) of this section, any Any person required to register under the act shall inform the sheriff of the 18 county in which he or she resides, in person, and complete a form as 19 prescribed by the Nebraska State Patrol for such purpose, if he or she 20 has a new address, temporary domicile, or habitual living location in a 21 different county in this state, within three working days before the 22 23 address change. The sheriff shall submit such information to the sex 24 offender registration and community notification division of the Nebraska 25 State Patrol on the day it is received and in a manner as prescribed by the Nebraska State Patrol for such purpose. If the change in address, 26 temporary domicile, or habitual living location is to a location within 27 the State of Nebraska, the division shall notify the sheriff of each 28 affected county of the new address, temporary domicile, or habitual 29 living location, within three working days. The person shall report to 30 the county sheriff of his or her new county of residence and register 31

with such county sheriff within three working days after the address
change.

- 3 (4) Except as provided in subsection (12) of this section, any Any person required to register under the act shall inform the sheriff of the 4 5 county in which he or she resides, in person, and complete a form as prescribed by the Nebraska State Patrol for such purpose, if he or she 6 moves to a new out-of-state address, within three working days before the 7 address change. The sheriff shall submit such information to the sex 8 9 offender registration and community notification division of the Nebraska State Patrol on the day it is received and in a manner as prescribed by 10 the Nebraska State Patrol for such purpose. If the change in address, 11 temporary domicile, or habitual living location is to a location outside 12 13 of the State of Nebraska, the division shall notify the sheriff of each affected county in Nebraska and the other state's, country's, 14 territory's central repository for sex offender registration of the new 15 out-of-state address, temporary domicile, or habitual living location, 16 17 within three working days.
- (5) Except as provided in subsection (12) of this section, any Any 18 19 person required to register under the act who is employed, carries on a vocation, or attends school shall inform, in person, the sheriff of the 20 county in which he or she is employed, carries on a vocation, or attends 21 22 school and complete a form as prescribed by the Nebraska State Patrol for such purpose, within three working days after becoming employed, carrying 23 24 on a vocation, or attending school. Except as provided in subsection (12) of this section, the The person shall also notify the sheriff, in person, 25 of any changes in employment, vocation, or school of attendance, and 26 complete a form as prescribed by the Nebraska State Patrol for such 27 28 purpose, within three working days after the change. The sheriff shall submit such information to the sex offender registration and community 29 notification division of the Nebraska State Patrol on the day it is 30 received and in a manner as prescribed by the Nebraska State Patrol for 31

1 such purpose.

- 2 (6) Except as provided in subsection (12) of this section, any Any person required to register under the act who is residing, has a 3 temporary domicile, or is habitually living in another state, and is 4 5 employed, carries on a vocation, or attends school in this state, shall report and register, in person, with the sheriff of the county in which 6 he or she is employed, carries on a vocation, or attends school in this 7 state and complete a form as prescribed by the Nebraska State Patrol for 8 9 such purpose, within three working days after becoming employed, carrying on a vocation, or attending school. Except as provided in subsection (12) 10 of this section, the The person shall also notify the sheriff of any 11 changes in employment, vocation, or school of attendance, in person, and 12 13 complete a form as prescribed by the Nebraska State Patrol for such 14 purpose, within three working days after the change. The sheriff shall submit such information to the sex offender registration and community 15 16 notification division of the Nebraska State Patrol on the day it is 17 received and in a manner as prescribed by the Nebraska State Patrol for such purpose. For purposes of this subsection: 18
- 19 (a) Attends school means enrollment in any educational institution 20 in this state on a full-time or part-time basis; and
- (b) Is employed or carries on a vocation means any full-time or part-time employment, with or without compensation, which lasts for a duration of more than fourteen days or for an aggregate period exceeding thirty days in a calendar year.
- (7) Any person incarcerated for a registrable offense under section 29-4003 in a jail, penal or correctional facility, or other public or private institution shall be registered by the jail, penal or correctional facility, or public or private institution prior to his or her discharge, parole, furlough, work release, or release. The person shall be informed and information shall be obtained as required in section 29-4006.

- 1 (8) Any person required to register or who is registered under the act, but is incarcerated for more than three working days, shall inform 2 the sheriff of the county in which he or she is incarcerated, in writing, 3 4 within three working days after incarceration, of his 5 incarceration and his or her expected release date, if any such date is sheriff shall forward information 6 available. The the 7 incarceration to the sex offender registration and community notification division of the Nebraska State Patrol immediately on the day on which it 8 9 was received and in a manner prescribed by the Nebraska State Patrol for 10 such purpose.
- (9) Except as provided in subsection (12) of this section, any Any 11 person required to register or who is registered under the act who no 12 longer has a residence, temporary domicile, or habitual living location 13 shall report such change in person to the sheriff of the county in which 14 he or she is located, within three working days after such change in 15 16 residence, temporary domicile, or habitual living location. Except as provided in subsection (12) of this section, such Such person shall 17 update his or her registration, in person, to the sheriff of the county 18 in which he or she is located, on a form approved by the sex offender 19 registration and community notification division of the Nebraska State 20 Patrol at least once every thirty calendar days during the time he or she 21 22 remains without residence, temporary domicile, or habitual living 23 location.
- (10) Each registering entity shall forward all written information, photographs, and fingerprints obtained pursuant to the act to the sex offender registration and community notification division of the Nebraska State Patrol on the day it is received and in a manner prescribed by the Nebraska State Patrol for such purpose. The information shall be forwarded on forms furnished by the division. The division shall maintain a central registry of sex offenders required to register under the act.

- 1 (11) The sex offender registration and community notification 2 division of the Nebraska State Patrol shall determine whether a namechange order received from the clerk of a district court pursuant to 3 4 section 25-21,271 is for a person in the central registry of sex 5 offenders and, if so, shall include the changed name with the former name in the registry, file or cross-reference the information under both 6 7 names, and notify the sheriff of the county in which such person then 8 resides.
- 9 (12) The Nebraska State Patrol may develop an alternative process to be used instead of appearing in person under subsections (2), (3), (4), 10 (5), (6), and (9) of this section when natural disasters, public health 11 considerations, or other factors make appearing in person difficult, 12 impossible, or unsafe as determined by the sex offender registration and 13 14 community notification division of the Nebraska State Patrol. Such alternative process may include electronic or telephonic notification to 15 the sheriff or appearing at a different location. 16
- 17 Sec. 2. Section 29-4005, Reissue Revised Statutes of Nebraska, is 18 amended to read:
- 19 29-4005 (1)(a) Except as provided in subsection (2) of this section, any person to whom the Sex Offender Registration Act applies shall be 20 required to register during any period of supervised release, probation, 21 22 or parole and shall continue to comply with the act for the period of time after the date of discharge from probation, parole, or supervised 23 24 release or release from incarceration, whichever date is most recent, as 25 set forth in subdivision (b) of this subsection. A sex offender shall keep the registration current for the full registration period but shall 26 not be subject to verification procedures during any time the sex 27 28 offender is in custody or under an inpatient civil commitment, unless the sex offender is allowed a reduction in his or her registration period 29 under subsection (2) of this section. 30
 - (b) The full registration period is as follows:

- 1 (i) Fifteen years, if the sex offender was convicted of a
- 2 registrable offense under section 29-4003 not punishable by imprisonment
- 3 for more than one year;
- 4 (ii) Twenty-five years, if the sex offender was convicted of a
- 5 registrable offense under section 29-4003 punishable by imprisonment for
- 6 more than one year; or
- 7 (iii) Life, if the sex offender was convicted of a registrable
- 8 offense under section 29-4003 punishable by imprisonment for more than
- 9 one year and was convicted of an aggravated offense or had a prior sex
- 10 offense conviction or has been determined to be a lifetime registrant in
- 11 another state, territory, commonwealth, or other jurisdiction of the
- 12 United States, by the United States Government, by court-martial or other
- 13 military tribunal, or by a foreign jurisdiction.
- 14 (2) A sex offender who is required to register for fifteen years may
- 15 request a reduction in the registration period to seven ten years upon
- 16 completion of seven ten years of the registration period after the date
- 17 of discharge from probation, parole, supervised release, or
- 18 incarceration, whichever date is most recent. The sex offender shall make
- 19 the request to the Nebraska State Patrol. The sex offender shall provide
- 20 proof that, during such registration period, he or she:
- 21 (a) Was not convicted of any offense for which imprisonment for more
- than one year could have been imposed;
- 23 (b) Was not convicted of any sex offense;
- 24 (c) Successfully completed any period of probation, parole,
- 25 supervised release, or incarceration; and
- 26 (d) Successfully completed an appropriate sex offender treatment
- 27 program.
- 28 (3) Any time period when any person who is required to register
- 29 under the act knowingly or willfully fails to comply with such
- 30 registration requirement shall not be counted as completed registration
- 31 time and shall be used to recalculate the registration period. The

- 11 (2) Except as provided in section 29-4005, the registration
- 12 information shall be verified as provided in subsections (3), (4), and
- 13 (5) of this section for the duration of the registration period. The
- 14 person shall appear in person or as developed in subsection (12) of
- 15 <u>section 29-4004</u> for such verification at the office of the sheriff of the
- 16 county in which he or she resides, has a temporary domicile, or is
- 17 habitually living for purposes of accepting verifications and shall have
- 18 his or her photograph and fingerprints taken upon request of verification
- 19 personnel.
- 20 (3) A person required to register under the act for fifteen years
- 21 shall report every twelve months in the month of his or her birth, in
- 22 person or as developed in subsection (12) of section 29-4004, to the
- 23 office of the sheriff of the county in which he or she resides for
- 24 purposes of accepting verifications, regardless of the original
- 25 registration month. The sheriff shall submit such verification
- 26 information to the sex offender registration and community notification
- 27 division of the Nebraska State Patrol on the day it is received and in a
- 28 manner prescribed by the Nebraska State Patrol for such purpose.
- 29 (4) A person required to register under the act for twenty-five
- 30 years shall report, in person or as developed in subsection (12) of
- 31 section 29-4004, every six months to the office of the sheriff of the

- 1 county in which he or she resides for purposes of accepting verification.
- 2 The person shall report, in person or as developed in subsection (12) of
- 3 section 29-4004, in the month of his or her birth and in the sixth month
- 4 following the month of his or her birth, regardless of the original
- 5 registration month. The sheriff shall submit such verification
- 6 information to the sex offender registration and community notification
- 7 division of the Nebraska State Patrol on the day it is received and in a
- 8 manner prescribed by the Nebraska State Patrol for such purpose.
- 9 (5) A person required to register under the act for life shall
- 10 report, in person or as developed in subsection (12) of section 29-4004,
- 11 every three months to the office of the sheriff of the county in which he
- or she resides for purposes of accepting verification. The person shall
- 13 report, in person or as developed in subsection (12) of section 29-4004,
- 14 in the month of his or her birth and every three months following the
- 15 month of his or her birth, regardless of the original registration month.
- 16 The sheriff shall submit such verification information to the sex
- 17 offender registration and community notification division of the Nebraska
- 18 State Patrol on the day it is received and in a manner prescribed by the
- 19 Nebraska State Patrol for such purpose.
- 20 (6) The verification form shall be signed by the person required to
- 21 register under the act and state whether the address last reported to the
- 22 division is still correct.
- 23 (7) Upon receipt of registration and confirmation of the registry
- 24 requirement, the sex offender registration and community notification
- 25 division of the Nebraska State Patrol shall notify the person by
- 26 certified mail of his or her registry duration and verification schedule.
- 27 (8) If the person required to register under the act fails to report
- 28 in person or as developed in subsection (12) of section 29-4004 as
- 29 required in subsection (3), (4), or (5) of this section, the person shall
- 30 be in violation of this section.
- 31 (9) If the person required to register under the act falsifies the

- 1 registration or verification information or form or fails to provide or
- 2 timely update law enforcement of any of the information required to be
- 3 provided by the Sex Offender Registration Act, the person shall be in
- 4 violation of this section.
- 5 (10) The verification requirements of a person required to register
- 6 under the act shall not apply during periods of such person's
- 7 incarceration or inpatient civil commitment. Verification shall be
- 8 resumed as soon as such person is placed on any type of supervised
- 9 release, parole, or probation or outpatient civil commitment or is
- 10 released from incarceration or civil commitment. Prior to any type of
- 11 release from incarceration or inpatient civil commitment, the person
- 12 shall report a change of address, in writing, to the sheriff of the
- 13 county in which he or she is incarcerated and the sheriff of the county
- in which he or she resides, has a temporary domicile, or has a habitual
- 15 living location. The sheriff shall submit the change of address to the
- 16 sex offender registration and community notification division of the
- 17 Nebraska State Patrol on the day it is received and in a manner
- 18 prescribed by the Nebraska State Patrol for such purpose.
- 19 (11) Any person required to register under the act shall, in person
- 20 or as developed in subsection (12) of section 29-4004, inform the sheriff
- 21 of any legal change in name within three working days after such change
- 22 and provide a copy of the legal documentation supporting the change in
- 23 name. The sheriff shall submit the information to the sex offender
- 24 registration and community notification division of the Nebraska State
- 25 Patrol, in writing, immediately after receipt of the information and in a
- 26 manner prescribed by the Nebraska State Patrol for such purpose.
- 27 (12) At any time that a person required to register under the act
- 28 violates the registry requirements and cannot be located, the registry
- 29 information shall reflect that the person has absconded, a warrant shall
- 30 be sought for the person's arrest, and the United States Marshals Service
- 31 shall be notified.
