- 1 A BILL FOR AN ACT relating to aeronautics; to amend sections 3-103 and
- 2 11-201, Revised Statutes Cumulative Supplement, 2020; to remove a
- 3 requirement that the appointment of the Director of Aeronautics be
- 4 subject to confirmation by the Legislature; to eliminate obsolete
- 5 provisions; to harmonize provisions; and to repeal the original
- 6 sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 3-103, Revised Statutes Cumulative Supplement,

- 2 2020, is amended to read:
- 3 3-103 (1) The Division of Aeronautics shall be a division of the
- 4 Department of Transportation. The (2)(a) Until December 31, 2017, the
- 5 chief administrative officer of the division shall be the director, to be
- 6 known as the Director of Aeronautics, and shall be appointed by the
- 7 Governor, subject to confirmation by the Legislature, with due regard to
- 8 his or her fitness through aeronautical education and by knowledge of and
- 9 recent practical experience in aeronautics. The director shall devote
- 10 full time to the performance of his or her official duties and shall not
- 11 have any pecuniary interest in, stock in, or bonds of any civil
- 12 aeronautics enterprise. The director shall, before assuming the duties of
- 13 the office, take and subscribe an oath, such as is required by state
- 14 officers. The director shall be bonded or insured as required by section
- 15 11-201. The director shall receive such compensation as the Governor,
- 16 with the approval of the commission, shall determine, subject to the
- 17 provisions of the legislative appropriations bill. (b) Beginning January
- 18 $\frac{1}{2018}$, the chief administrative officer of the division shall be the
- 19 Director of Aeronautics who shall be appointed by and report directly to
- 20 the Director-State Engineer, subject to confirmation by the Legislature,
- 21 with due regard to his or her fitness through aeronautical education and
- 22 by knowledge of and recent practical experience in aeronautics. The
- 23 director shall report directly to the Director-State Engineer, shall
- 24 devote full time to the performance of his or her official duties, and
- 25 shall not have any pecuniary interest in, stock in, or bonds of any civil
- 26 aeronautics enterprise. The director shall, before assuming the duties of
- 27 the office, take and subscribe an oath, such as is required by state
- 28 officers.
- 29 Sec. 2. Section 11-201, Revised Statutes Cumulative Supplement,
- 30 2020, is amended to read:
- 31 11-201 It shall be the duty of the Risk Manager:

- 1 (1) To prescribe the amount, terms, and conditions of any bond or
- 2 equivalent commercial insurance when the amount or terms are not fixed by
- 3 any specific statute. The Risk Manager, in prescribing the amount,
- 4 deductibles, conditions, and terms, shall consider the type of risks, the
- 5 relationship of the premium to risks involved, the past and projected
- 6 trends for premiums, the ability of the Tort Claims Fund, the State Self-
- 7 Insured Property Fund, and state agencies to pay the deductibles, and any
- 8 other factors the manager may, in his or her discretion, deem necessary
- 9 in order to accomplish the provisions of sections 2-1201, $\frac{3-103}{7}$ 8-104,
- 10 8-105, 9-807, 11-119, 11-121, 11-201, 11-202, 37-110, 48-158, 48-609,
- 11 48-618, 48-804.03, 53-109, 54-191, 55-123, 55-126, 55-127, 55-150,
- 12 57-917, 60-1303, 60-1502, 71-222.01, 72-1241, 77-366, 80-401.02, 81-111,
- 13 81-151, 81-5,167, 81-8,128, 81-8,141, 81-1108.14, 81-2002, 83-128,

- 15 (2) To pass upon the sufficiency of and approve the surety on the
- 16 bonds or equivalent commercial insurance of all officers and employees of
- 17 the state, when approval is not otherwise prescribed by any specific
- 18 statute;
- 19 (3) To arrange for the writing of corporate surety bonds or
- 20 equivalent commercial insurance for all the officers and employees of the
- 21 state who are required by statute to furnish bonds;
- 22 (4) To arrange for the writing of the blanket corporate surety bond
- 23 or equivalent commercial insurance required by this section; and
- (5) To order the payment of corporate surety bond or equivalent
- 25 commercial insurance premiums out of the State Insurance Fund created by
- 26 section 81-8,239.02.
- 27 All state employees not specifically required to give bond by
- 28 section 11-119 shall be bonded under a blanket corporate surety bond or
- 29 insured under equivalent commercial insurance for faithful performance
- 30 and honesty in an amount determined by the Risk Manager.
- 31 The Risk Manager may separately bond any officer, employee, or group

- 1 thereof under a separate corporate surety bond or equivalent commercial
- 2 insurance policy for performance and honesty pursuant to the standards
- 3 set forth in subdivision (1) of this section if the corporate surety or
- 4 commercial insurer will not bond or insure or excludes from coverage any
- 5 officer, employee, or group thereof under the blanket bond or commercial
- 6 insurance required by this section, or if the Risk Manager finds that the
- 7 reasonable availability or cost of the blanket bond or commercial
- 8 insurance required under this section is adversely affected by any of the
- 9 following factors: The loss experience, types of risks to be bonded or
- 10 insured, relationship of premium to risks involved, past and projected
- 11 trends for premiums, or any other factors.
- 12 Surety bonds of collection agencies, as required by section 45-608,
- 13 and detective agencies, as required by section 71-3207, shall be approved
- 14 by the Secretary of State. The Attorney General shall approve all bond
- 15 forms distributed by the Secretary of State.
