- 1 A BILL FOR AN ACT relating to appropriations; to amend Laws 2021, LB380,
- 2 section 167; to appropriate funds to carry out the provisions of
- 3 Legislative Bill 902, One Hundred Seventh Legislature, Second
- 4 Session, 2022; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Laws 2021, LB 380, section 167 is amended to read:

- (1) There is included in the appropriation to this program for 13 FY2021-22 \$2,000,000 General Funds for state aid for Nebraska Career 14 Scholarships, which shall only be used for such purpose. There is 15 16 included in the appropriation to this program for FY2022-23 \$3,050,000 \$3,000,000 General Funds for state aid for Nebraska Career Scholarships, 17 which shall only be used for such purpose. There is included in the 18 amount shown as aid for Nebraska Career Scholarships \$50,000 for 19 FY2022-23 for cooperative programs with Wayne State College. 20
- 21 (2) The unexpended General Fund appropriation balance existing on 22 June 30, 2021, from the appropriation for the Nebraska Career Scholarship 23 Program, as authorized in Laws 2020, LB 1008, section 60, is hereby 24 reappropriated.
- (3) It is the intent of the Legislature that upon the approval of
 the Board of Trustees of the Nebraska State Colleges, the System Office
 of the Nebraska State Colleges may divide and distribute the funds
 appropriated to this program among Chadron State College, Peru State
 College, Wayne State College, and the System Office of the Nebraska State
 Colleges.
- 31 (4) It is the intent of the Legislature that Cash Fund revenue from

- 1 resident tuition, nonresident tuition, off-campus tuition, and fees
- 2 separately assessed shall be individually accounted for on the Nebraska
- 3 Information System.
- 4 (5) The Legislature reaffirms its intent to utilize the Nebraska
- 5 Educational Data System created by Laws 1978, LB 897, to support the
- 6 appropriations and oversight process for postsecondary education. It is
- 7 further the intent of the Legislature that all institutions provide the
- 8 data in the precise formats required by the Coordinating Commission for
- 9 Postsecondary Education.
- 10 (6) The Legislature reaffirms its commitment to long-range and
- 11 short-range computer planning by the Nebraska state colleges. It is the
- 12 intent of the Legislature that comprehensive computer plans of the
- 13 Nebraska state colleges be updated biennially and submitted to the
- 14 Legislative Fiscal Analyst, the Department of Administrative Services,
- 15 and the Coordinating Commission for Postsecondary Education on or before
- 16 October 15 of each odd-numbered year. The plans required to be submitted
- 17 to the Legislative Fiscal Analyst by this section shall be submitted
- 18 electronically.
- 19 (7) The Department of Administrative Services shall monitor the
- 20 appropriations and expenditures of the Board of Trustees of the Nebraska
- 21 State Colleges, Agency No. 50-0, and the Nebraska State Colleges, Agency
- 22 Nos. 50-1, 50-3, and 50-4, according to NCHEMS-Program Classification
- 23 Structure, Second Edition. Expenditure authority shall be limited to
- 24 program appropriations.
- 25 (8) It is intended that:
- 26 (a) The Board of Trustees of the Nebraska State Colleges shall award
- 27 scholarships that shall not exceed a maximum of fifteen thousand dollars
- 28 per year to an eligible student who achieved a score on the ACT of 18 or
- 29 higher and enrolled in a program of study in rangeland management,
- 30 industrial technology, criminal justice, business administration,
- 31 education, communication, and computer information systems;

- 1 (b) The Board of Trustees of the Nebraska State Colleges, acting as
- 2 agents of the state, shall allocate Nebraska Career Scholarship funds
- 3 between the campuses, determine eligibility of students, receive and
- 4 process applications for awards to individual students, and disperse any
- 5 award directly to eligible students during the fiscal year. Eligibility
- 6 criteria shall include being a first-time freshman or a transfer student
- 7 enrolled in an eligible program of study;
- 8 (c) A scholarship recipient shall be automatically renewed if the
- 9 student remains eligible. No student shall receive a scholarship after
- 10 four years of participation in the program;
- 11 (d) The Board of Trustees of the Nebraska State Colleges shall
- 12 collect information on each scholarship recipient;
- 13 (e) Nebraska Career Scholarship funds may be used for tuition, fees,
- 14 required tools and equipment, room, and board. Each student who receives
- 15 a Nebraska Career Scholarship shall register with the appropriate campus
- 16 office to obtain a Nebraska-based internship, apprenticeship, clinical
- 17 position, or major-related field of employment prior to completion of the
- 18 program of study;
- 19 (f) Every four years, the Board of Trustees of the Nebraska State
- 20 Colleges, in collaboration with the Department of Economic Development,
- 21 shall evaluate which programs of study are needed to meet the workforce
- 22 needs of the State of Nebraska; and
- 23 (g) The Board of Trustees of the Nebraska State Colleges shall
- 24 report electronically to the Clerk of the Legislature and the Governor by
- 25 December 1 of each year the following information:
- 26 (i) Total number of students enrolled in each eligible program of
- 27 study in the prior school year and such program's enrollment as of
- 28 September 30 each year thereafter;
- 29 (ii) The starting number of scholarship recipients in each program
- 30 of study;
- 31 (iii) The total number of students retained year-over-year in each

- 1 program of study;
- 2 (iv) A comparison of the retention rate of scholarship recipients
- 3 and nonscholarship recipients;
- 4 (v) The number of students in each program of study participating in
- 5 an internship, apprenticeship, clinical position, or major-related field
- 6 of employment during enrollment and comparing participation rates for
- 7 scholarship and nonscholarship recipients;
- 8 (vi) The total number of graduates in each program of study, stating
- 9 the number of scholarship recipients and comparing the graduation rate
- 10 versus nonscholarship students;
- 11 (vii) The number of students in each program of study obtaining jobs
- 12 in Nebraska within four months of graduation; and
- 13 (viii) The average starting salary.
- 14 (9) It is the intent of the Legislature for the Board of Trustees of
- 15 the Nebraska State Colleges to utilize a trust fund to record revenue and
- 16 expenses for the Corrections Workforce Development Pathway program at
- 17 Peru State College.
