- 1 A BILL FOR AN ACT relating to the Nebraska County and City Lottery Act;
- 2 to amend sections 9-607, 9-646.01, and 9-651, Reissue Revised
- 3 Statutes of Nebraska, and sections 9-601 and 9-603, Revised Statutes
- 4 Cumulative Supplement, 2020; to change provisions relating to the
- 5 game of keno; to provide for the sale of digital-on-premises
- 6 tickets; to harmonize provisions; and to repeal the original
- 7 sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 9-601, Revised Statutes Cumulative Supplement,

- 2 2020, is amended to read:
- 3 9-601 Sections 9-601 to 9-653 and sections 3 and 7 of this act shall
- 4 be known and may be cited as the Nebraska County and City Lottery Act.
- 5 Sec. 2. Section 9-603, Revised Statutes Cumulative Supplement, 2020,
- 6 is amended to read:
- 7 9-603 For purposes of the Nebraska County and City Lottery Act, the
- 8 definitions found in sections 9-603.02 to 9-618 and section 3 of this act
- 9 shall be used.
- 10 Sec. 3. Digital-on-premises ticket means a digital ticket purchased
- 11 in person on a mobile or other electronic device verified to be present
- 12 <u>at the location of the lottery operator or a licensed sales outlet</u>
- 13 <u>location in accordance with subdivision (3)(b) of section 7 of this act.</u>
- 14 Sec. 4. Section 9-607, Reissue Revised Statutes of Nebraska, is
- 15 amended to read:
- 16 9-607 (1) Lottery shall mean a gambling scheme in which:
- 17 (a) The players pay or agree to pay something of value for an
- 18 opportunity to win;
- 19 (b) Winning opportunities are represented by tickets;
- 20 (c) Winners are solely determined by one of the following two
- 21 methods:
- 22 (i) By a random drawing of tickets differentiated by sequential
- 23 enumeration from a receptacle by hand whereby each ticket has an equal
- 24 chance of being chosen in the drawing; or
- 25 (ii) By use of a game known as keno in which a player selects up to
- 26 twenty numbers from a total of eighty numbers on a paper ticket and a
- 27 computer, other electronic selection device, or electrically operated
- 28 blower machine which is not player-activated randomly selects up to
- 29 twenty numbers from the same pool of eighty numbers and the winning
- 30 players are determined by the correct matching of the numbers on the
- 31 paper ticket selected by the players with the numbers randomly selected

- 1 by the computer, other electronic selection device, or electrically
- 2 operated blower machine, except that (A) no keno game shall permit or
- 3 require player activation of lottery equipment and (B) the random
- 4 selection of numbers by the computer, other electronic selection device,
- 5 or electrically operated blower machine shall not occur within five
- 6 minutes of the completion of the previous selection of random numbers;
- 7 and
- 8 (d) The holders of the winning paper tickets are to receive cash or
- 9 prizes redeemable for cash. Selection of a winner or winners shall be
- 10 predicated solely on chance; and -
- 11 (e) Tickets shall be issued either (i) on paper or (ii) digitally to
- 12 <u>a mobile or other device of a person verified to be present at the</u>
- 13 <u>location of the lottery operator or a licensed sales outlet location in</u>
- 14 accordance with subdivision (3)(b) of section 7 of this act.
- 15 (2) Lottery shall not include:
- 16 (a) Any gambling scheme which uses any mechanical gaming device,
- 17 computer gaming device, electronic gaming device, or video gaming device
- 18 which has the capability of awarding something of value, free games
- 19 redeemable for something of value, or tickets or stubs redeemable for
- 20 something of value;
- (b) Any activity authorized or regulated under the Nebraska Bingo
- 22 Act, the Nebraska Lottery and Raffle Act, the Nebraska Pickle Card
- 23 Lottery Act, the Nebraska Small Lottery and Raffle Act, the State Lottery
- 24 Act, section 9-701, or Chapter 2, article 12; or
- (c) Any activity prohibited under Chapter 28, article 11.
- 26 (3) Notwithstanding the requirement in subdivision (1)(c)(ii) of
- 27 this section that a player select up to twenty numbers, a player may
- 28 select more than twenty numbers on a paper ticket when a top or bottom,
- 29 left or right, edge, or way ticket is played. For a top or bottom ticket,
- 30 the player shall select all numbers from one through forty or all numbers
- 31 from forty-one through eighty. For a left or right ticket, the player

- 1 shall select all numbers ending in one through five or all numbers ending
- 2 in six through zero. For an edge ticket, the player shall select all of
- 3 the numbers comprising the outside edge of the ticket. For a way ticket,
- 4 the player shall select a combination of groups of numbers in multiple
- 5 ways on a single ticket.
- 6 (4) A county, city, or village conducting a keno lottery shall
- 7 designate the method of winning number selection to be used in the
- 8 lottery and submit such designation in writing to the department prior to
- 9 conducting a keno lottery. Only those methods of winning number selection
- 10 described in subdivision (1)(c)(ii) of this section shall be permitted,
- 11 and the method of winning number selection initially utilized may only be
- 12 changed once during that business day as set forth in the designation. A
- 13 county, city, or village shall not change the method or methods of
- 14 winning number selection filed with the department or allow it to be
- 15 changed once such initial designation has been made unless (a) otherwise
- 16 authorized in writing by the department based upon a written request from
- 17 the county, city, or village or (b) an emergency arises in which case a
- 18 ball draw method of number selection would be switched to a number
- 19 selection by a random number generator. An emergency situation shall be
- 20 reported by the county, city, or village to the department within twenty-
- 21 four hours of its occurrence.
- 22 Sec. 5. Section 9-646.01, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 9-646.01 No person or licensee, or any employee or agent thereof,
- 25 accepting wagers on a lottery conducted pursuant to the Nebraska County
- 26 and City Lottery Act shall extend credit from the gross proceeds of a
- 27 lottery to participants in the lottery for the purchase of lottery
- 28 tickets. No person shall purchase or be allowed to purchase any lottery
- 29 ticket or make or be allowed to make any wager pursuant to the act unless
- 30 he or she pays for such ticket or wager with cash, coins, a debit card,
- 31 or a direct link to an account with a financial institution in the name

- 1 of the player. For purposes of this section, cash shall mean United
- 2 States currency having the same face value as the price of the ticket or
- 3 wager. A credit card shall not be accepted as payment for any wager on
- 4 keno.
- 5 Sec. 6. Section 9-651, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 9-651 Each county, city, or village conducting a lottery shall have
- 8 its name clearly associated with printed on each ticket used in the
- 9 lottery. No such ticket shall be sold unless the name of the county,
- 10 city, or village is clearly identified with such ticket printed thereon.
- 11 Sec. 7. (1) Any purchase of a ticket for a keno game shall be made
- 12 <u>in person at the location of the lottery operator or a licensed sales</u>
- 13 <u>outlet location.</u>
- 14 (2) The lottery operator shall file with the department the address
- of each location where digital-on-premises tickets are sold. The lottery
- 16 operator shall use reasonable safeguards approved by the department to
- 17 <u>ensure that digital-on-premises tickets are only accessible to</u>
- 18 <u>individuals nineteen years of age or older.</u>
- 19 (3) The lottery operator shall submit controls, for approval by the
- 20 <u>department</u>, that include the following at the location of the lottery
- 21 operator or its associated licensed sales outlet locations at which
- 22 <u>digital-on-premises tickets are sold:</u>
- 23 (a) Any specific procedure and any technology partner used to
- 24 <u>fulfill the requirements set forth by the department;</u>
- 25 (b) Any location detection procedure to reasonably detect and
- 26 <u>dynamically monitor the location of a player attempting to purchase a</u>
- 27 <u>digital-on-premises ticket for a keno game. A player outside the</u>
- 28 permitted boundary shall be rejected, and the player shall be notified.
- 29 The permitted boundary shall be established such that access is not
- 30 regularly available outside the property on which the licensed premises
- 31 is situated and as closely limited to the precise boundaries of the

- 1 <u>licensed premises as reasonably possible;</u>
- 2 (c) Any other specific controls as designated by the department;
- 3 (d) A process to prominently display and easily impose any
- 4 limitation parameters relating to the purchase of a digital-on-premises
- 5 <u>ticket for a keno game; and</u>
- 6 (e) An easy and obvious method for a player to make a complaint and
- 7 <u>to enable the player to notify the department if such complaint has not</u>
- 8 <u>been or cannot be addressed by the lottery operator.</u>
