HUGHES: Thank you, Senator Erdman. I call to order the tenth day of the One Hundred Seventh Legislature, First Session. Senators, please record your presence. Roll call. Mr. Clerk, please record.

ASSISTANT CLERK: I have a quorum present, Mr. President.

HUGHES: Thank you, Mr. Clerk. Are there any corrections to the Journal?

LB595, introduced by Senator Albrecht, is a bill for an act relating to revenue and taxation; provides a sales and use tax exemption for certain products used in the process of manufacturing ethyl alcohol; harmonize provisions; provides an operative date; and repeals the original section. LB596, introduced by Senator Albrecht, is a bill for an act relating to revenue and taxation; adopts the Nebraska Higher Blend Tax Credit Act; harmonize provisions; repeals the original section. LB597, introduced by Senator Albrecht, is a bill for an act relating to income taxes; provides a tax credit for parents of stillborn children; and repeals the original section. LB598, introduced by Senator Wishart, is a bill for an act relating to Department of Edu-- Economic Development; adopts the Small Business Stabilization Grant Program Act; and declares an emergency. LB599, introduced by Senator Lindstrom, is a bill for an act relating to revenue and taxation; changes an exemption from the documentary stamp tax; and repeals the original section. LB600, introduced by Senator Brandt, is a bill for an act relating to broadband; redefines terms, changes of bond issuance provision under
