**HILGERS:** Morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the thirteenth day of the One Hundred Seventh Legislature, First Session. Our chaplain for today is Senator Bostelman. Please rise.

**BOSTELMAN:** Good morning, colleagues and Nebraska. This morning's message, this morning's prayer, words come from Pastor Wilson Metz, who's pastor of Word of Hope Lutheran Church in Ashland, Nebraska. Please join me in prayer. To the trine God, God the Father, Son and Holy Spirit, in the scriptures we discover what God's divine power offers. May each member receive everything God offers. The apostle Peter writes: His divine power has given us everything we need for a godly life through our knowledge of him, who called us by his own glory and goodness. Through these, he has given us his very great and precious promises so that through them you may participate in the divine nature, having escaped the corruption in the world caused by evil desires. And in the scriptures we discover all authority is given by God. And the apostle Paul writes: Let everyone be subject to the governing of authorities, for there is no authority except that which God has established. The authorities that exist have been established by God. And in the scriptures we discover we are called to pray for those in authority, for those over us in leadership. Many across our great state are praying for each of you today. The apostle Paul writes in Timothy-- to Timothy: I urge, then, first of all, that petitions, prayers, intercessions and thanksgiving be made for all people, for kings and all those in authority, that we may live peacefully and quiet lives in all godliness and holiness. In the scriptures we read about acquiring wisdom. And James writes: If any of you lacks wisdom, you should ask God, who gives generously to all without finding fault and will be given to you. Pastor Metz writes: My prayer for this Unicameral body of Legislatures [SIC] is that they would govern using the wisdom you offer them, the compassion of your heart, the justice of your righteousness, and the knowledge that ultimately each of them is accountable to you and the one true God. Amen.
