LR27CA, by Senator Matt Hansen, is a proposed constitutional amendment providing for legislative authority in emergencies resulting from a pandemic. LR28 is a resolution that pertains to federal constitutional conventions being rescinded and deemed null and void; that will be referred to the Reference Committee for reference to the appropriate standing committees.
