

a. All Children


Percentage by Service Area

Data extracted is from the DHHS N-FOCUS system. Number of children served is an unduplicated count.



Expenditures by Service Area



b. State Wards


Percentage by Service Area

Data does not include expenditures paid by Medicaid. Data includes expenditures for services paid from N-FOCUS and payments made outside of N-FOCUS. The following chart shows the breakout by service area for Program 354, including Subprograms 30 and 48. Data may not match NIS (Enterprise One) data due to refunds, cancellations, and/or other payments made through NIS that did not originate in N-FOCUS. The Eastern Service Area (ESA) expenditures include Initial Assessment (IA) and Alternative Response (AR) services managed by CFS, and Saint Francis Ministries case management sub-award, which includes both administrative and service expenses to Saint Francis Ministries. Expenditure data for the other service areas does not include administrative costs such as staffing and office space.

a. Number of Children Receiving Mental Health and Substance Abuse Services

Youth age is calculated using the youth's date of birth to the first day of the fiscal year. The chart shows individuals receiving Mental Health (MH) Services, Substance Use Disorder (SUD) Services, and those receiving both MH and SUD Services.

For all reported years, youth ages were calculated as the middle day of the fiscal year (12/31/20xx), minus date of birth to align with federal reporting rules for calculating age to align with defined SED age range, only youth ages 3 to 18 years old were included.

† The increase in the number of youth served since FY16 is due in part to expanded data collection for existing family services with the 2016 implementation of the CDS.

b. Number of Children Receiving Behavioral Health Services at the Hastings Regional Center

The Hastings Regional Center was closed twenty years ago; therefore, the Division of Behavioral Health no longer serves children at the Hastings Regional Center, including during SFY 2024.

c. Number of State Wards Receiving Behavioral Health Service

Division of Behavioral Health: Youth Served Who Were Wards of the State = 14. Data from the CFS N-FOCUS system shows 220 state wards received behavioral health services paid for by CFS during SFY 2024. Data also shows 4,550 state wards received behavioral services paid for by Nebraska Medicaid through the Division of Medicaid and Long-Term Care.

d. SFY24 Funding Sources for Children's Behavioral Health Services

Children's behavioral health services during SFY 2024 were funded by state General Funds, the Community Mental Health Services Block Grant, and the Substance Abuse Prevention and Treatment Block Grant.

e. SFY24 Expenditures by Category of Behavioral Health Service and by Behavioral Health Region

Data provided for SFY 2024 (July 2023 – June 2024) for the Six Behavioral Health Regions in Nebraska. For the purposes of this report, a service is the type of work performed and the Service Category is a Child's service. The chart below is broken down by funds paid for Mental Health (MH) versus Substance Abuse (SA) services in each state Behavioral Health Region, as well as by funding type (Federal versus State funds). Expenditures are the total dollars paid in SFY 2024. Payments pending or in-process are not included. Data extracted is from the Division of Behavioral Health SFY 2024 Children's Services.




b. Caseload per Case Manager



In those areas, a transfer from initial assessment to ongoing shows as two case managers early in the life of the case. Other areas have the same case manager conduct both initial assessments and ongoing case management Cases that do not progress beyond the initial assessment phase are excluded. This data includes the average number of CFS Specialists per child's case for children who have been in the child welfare system for three, six, twelve, and eighteen months and the consecutive yearly average for children until the age of majority or permanency is attained.

For the Eastern Service Area, the case manager count includes DHHS case managers who conduct initial assessments and contracted agency staff who provided ongoing case management. Data after June 2022 does not include contracted agency staff.






Chart 1 for f & g: Statewide Percentage of Monthly Visits with Parent, Child, and Provider






















Wards in Residential Treatment Settings by Age


Wards in Residential Treatment Settings by Gender




Wards in Residential Treatment Settings by Race/Ethnicity




Average Cost of Residential Treatment Placements


Length of Residential Treatment Placements



h. Referral Data
