# Allocation Plan 2023-2024



The Nebraska Child Abuse Prevention Fund Board was created in 1986 by the Nebraska Legislature to provide prevention information, education, and resources to parents, professionals, and the public. Board members are appointed by the Governor and approved by the Legislature. The Board is administered by the Nebraska Department of Health and Human Services.

The board's Allocation Plan for 2023-2024 includes the following priorities:

- Supporting evidence-informed programs and resources for community grantees focused on families with children from infancy through adolescence.
- Administering a statewide public awareness campaign with local child abuse prevention collaboratives.
- Promoting parent engagement and leadership.
- Providing training and technical assistance on evidence-informed child abuse prevention strategies to community collaboratives and other partners.

### Programs, Resources, and Services being funded in 2023-2024:

Circle of Security Parenting (COSP) is an 8-week program that builds strong relationships between parent and child. It helps parents learn how to respond to their child's need in a way that reduces their stress and enhances healthy attachment. Families participating in COSP have often experienced trauma or other factors that can disrupt attachment security.

Community Response coordinates existing local resources to help children, young adults, and families address immediate needs before crises occur and higher end systems of care are involved. Core elements of Community Response include Central Navigation, Support Service Funds, and Coaching.

Plans of Safe Care (POSC) builds on the federal Comprehensive Addiction and Recovery Act and extends the work to include working with moms prenatally. Through technical assistance provided through the National Center on Substance Abuse and Child Welfare, state partners and two Nebraska communities are piloting an approach to help moms work with substance abuse services providers and help keep their children safely with them.

Youth and Families Thrive training helps service providers understand apply evidence-informed Protective and Promotive Factors for children, youth, and families. This investment will focus on a culturally adapted version for Native American communities.

#### **Mental Health Interpreter Collaboration**

**Training** increases access to mental health services for limited or non-English speaking people. This training addresses interpretation concerns within a mental health setting. It includes practice for providers and interpreters to work through language barriers, and work with interpreters on foundational terminology, therapeutic modalities, and issues that are unique to mental health services.

Community Cafés are a parent engagement and leadership approach to strengthen families and communities. Locally based Community Café teams learn and apply core principles of World Cafés, Promotive and Protective Factors, and Appreciative Inquiry in each series of connected conversations. The conversations explore and build on strengths in families, organizations, and communities.

Public Awareness and Education investments include radio and digital ads across the state. An online prevention store and toolkit are included for use by over twenty community-based prevention collaboratives and other local and state partners. Focal efforts include April Child Abuse Prevention Month and other opportunities to promote strong families and community ownership of prevention.

#### Training, Technical Assistance, and

Assessment for all strategies is provided through Nebraska Children and Families Foundation. All grantees received support for initial training, implementation, and evaluation in NCAPF-supported strategies, including COSP and Community Cafés. Additional support was provided for development of community systems to support and use these strategies, including, but not limited to, Community Well-Being and Community Response. An annual evaluation is required that includes the outcomes of all funded projects.
