Summary of purpose and/or changes:

LB425, brought by Sen. Bostelman, would amend provisions of the Game Law found in Chapter 37 to raise nonresident hunting and fishing permit fees for persons sixteen years and older, to raise the cap on fees for nonresident single, multiple day, and annual fishing permits, permits issued for special depredation seasons. The bill also expands the percentage of land in a county that is for breeding and controlled shooting and increases the number of permits the commission to "as many as necessary" that may issue for the harvest of animal predators in areas of a state game refuge.

Explanation of amendments:

AM1010 is a white copy amendment to LB425 that also incorporates two other bills into LB425: LB400 (As amended by AM878) and LB281 (As amended by AM911).

The Committee voted to adopt AM1010 on a 8-0 vote.

LB400, introduced by Sen. Brewer, and amended by AM878 would replace the seasonal Pheasant Bounty Program with provisions for the reduction of nest predators year-round by authorizing landowners, their tenants, or agent, to destroy or have destroyed any predator preying on livestock or poultry or suspected of causing other damage on their land. It also would authorize landowners, their tenants or agents to kill a mountain lion if encountered and the mountain lion is in the process of stalking, killing, or consuming livestock on the person's property and requires the person responsible for killing the mountain lion to notify the Commission immediately and to arrange to transfer the mountain lion to the Commission.

LB281 introduced by Sen. Jacobson, and amended by AM911, would direct the Department of Economic Development (DED) to make a matching grant of up to \$15 million to a non-profit sponsored project to rebuild a youth outdoor education camp facility if damaged due to a natural or manmade disaster. The grant would be matched dollar for dollar by the applicant and require proof of matching funds prior to disbursement of any portion, and also require proof of expenses consistent with the grant's purpose and within the grant's approved expense categories.

Sec. 3 Amends section 37-447 limiting and raising non-resident permit fees for deer hunting

Sec. 4 Amends section 37-448 special seasons may be designated, with the only limitations on nonresident permits

Sec. 5 Amends section 37-449, (2) to raise caps on permits issued from one hundred ninety eight dollars to two hundred fifty-seven dollars for a nonresident deer permit.

Sec. 6 Amends section 37-449, section 37-327 to raise caps on non-resident permit fees for antelope hunting from \$198 to \$257

Sec. 7 Amends 37-453 to increase limit on number of applications for special permits from two to six.
