Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1204 would add the definition of "rickhouse" to the Nebraska Liquor Control Act. Rickhouse would mean an offsite bonded warehouse which is kept and maintained for the purpose of storing spirits in barrels for aging in order to impart flavor from the barrel into the spirits.

The bill would also add that a holder of a manufacturer's license to manufacture spirits and a holder of a microdistillery license could operate a rickhouse that meets the requirements for a distilled spirit plant pursuant to 26 U.S.C. 5178, as such section existed on January 1, 2024, if the manufacturer/licensee receives authorization from the Nebraska Liquor Control Commission (NLCC) and notifies the NLCC of the location of the rickhouse in a manner prescribed by the NLCC.

The NLCC estimates no fiscal impact as a result of this bill. There is no basis to disagree with this estimate.
