LB 279 proposes changes and eliminate provisions relating to executive officers of banks.

As amended by AM 86, the proposed bill would create the ability for the board of directors of a bank to obtain a credit report from a recognized credit agency, on an annual basis, for any or all of its executive officers. The amendment also provides exemptions from obtaining a credit report of any executive officer if such officer is excluded by a resolution of the board of directors or by the bylaws of the bank from participating in the major policymaking functions of the bank and does not actually participate in the major policymaking functions of the bank.
