Explanation of Estimate:

LB 650 would modify public records law to add a provision allowing the lawful custodian of public records to withhold records relating to the nature, location, or function of cybersecurity by the State of Nebraska or any of its political subdivisions to be withheld from the public. LB 650 would require the Nebraska Information Technology Commission (NITC) to adopt and promulgate rules and regulations to implement the provisions.

The Department of Administrative Services – Office of the Chief Information Officer (DAS-OCIO) provides administrative support and funding for the NITC. This proposed legislation would impose no fiscal impact; therefore no additional resources would be required.
