Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 713 amends provisions related to the Legislature's Committee on Justice Reinvestment Oversight to require the committee to contract with an academic institution located within Nebraska to assist with development of a correctional forecasting tool to monitor trends and forecast future correctional populations.

The Nebraska Commission on Law Enforcement and Criminal Justice, Department of Correctional Services, Office of Probation Administration, and Board of Parole must provide the contractor with data necessary. The contractor must maintain the same confidentiality and data security protection required of agency staff.

The Nebraska Commission on Law Enforcement and Criminal Justice estimates a programming cost to provide an automated data system of \$13,000 in FY23-24 and \$3,000 in FY24-25.

The Legislature updated its estimate to reflect updated costs for the contract with the academic institution, which would include estimated personnel costs and operating costs of \$171,105 in FY 23-24 and \$122,895 in FY24-25.

The Board of Parole and Nebraska Department of Correctional Services estimate no fiscal impact. The Supreme Court estimates minimal impact, which can be absorbed within current resources.
