Be it enacted by the people of the State of Nebraska,

A BILL FOR AN ACT relating to veterans; to amend sections 80-401.03, 1 2 80-401.11, 80-404, and 80-412, Reissue Revised Statutes of Nebraska, and sections 80-315, 80-322.01, 80-411, and 81-1316, Revised 3 Statutes Cumulative Supplement, 2022; to change references to a 4 5 veterans' home; to change provisions relating to the Department of Veterans' Affairs Cash Fund, veterans aid, Department of Veterans' 6 7 Affairs offices, gifts to the Department of Veterans' Affairs, 8 waiver of tuition and fees for dependents of certain veterans, and 9 duties of the Director of Veterans' Affairs; to eliminate an 10 obsolete provision; to repeal the original sections; and to outright repeal section 80-336, Revised Statutes Cumulative Supplement, 2022. 11

1 Section 1. Section 80-315, Revised Statutes Cumulative Supplement,

- 2 2022, is amended to read:
- 3 80-315 The <u>Central Nebraska</u> Grand Island Veterans' Home, the Norfolk
- 4 Veterans' Home, the Eastern Nebraska Veterans' Home, and the Western
- 5 Nebraska Veterans' Home are established. The State of Nebraska shall
- 6 maintain the homes as provided in the Nebraska Veterans Services Act.
- 7 Sec. 2. Section 80-322.01, Revised Statutes Cumulative Supplement,
- 8 2022, is amended to read:
- 9 80-322.01 The Department of Veterans' Affairs Cash Fund is created.
- 10 The fund shall include any transfers by the Legislature, any gifts,
- 11 grants, bequests, contributions, or donations received by the department,
- 12 <u>and</u>money transferred pursuant to section 80-322. The department shall
- 13 administer the fund. <u>Disbursements from the fund shall be used by the</u>
- 14 <u>department for the purposes of supporting veteran services, carrying out</u>
- 15 the duties and functions of the department, paying administrative costs
- 16 of the department, or for the specific purposes designated by acceptance
- 17 of any gift, grant, bequest, contribution, or donation. Any money in the
- 18 fund available for investment shall be invested by the state investment
- 19 officer pursuant to the Nebraska Capital Expansion Act and the Nebraska
- 20 State Funds Investment Act.
- Sec. 3. Section 80-401.03, Reissue Revised Statutes of Nebraska, is
- 22 amended to read:
- 23 80-401.03 (1) The Director of Veterans' Affairs shall be responsible
- 24 for the administration of the income funds from the Nebraska Veterans'
- 25 Aid Fund for the aid of needy veterans and their dependents.
- 26 (2) The <u>Director of Veterans' Affairs</u> director, the deputy director,
- 27 or a designee of the director shall receive and approve for payment or
- 28 disapprove applications for aid which shall originate in any local post
- 29 of any recognized veterans organization or with a county veterans service
- 30 officer. Any person eligible for such aid shall make application for the
- 31 same through such local post or county veterans service officer in the

- 1 community nearest his or her place of residence. If there are two or more
- 2 local posts of one or more recognized veterans organizations in any
- 3 community, no claimant can originate a claim in more than one such post
- 4 at any given time and a period of at least thirty days shall elapse
- 5 between the filing of claims. An application shall not be deemed to be
- 6 filed until it has been received and filed in the office of the Director
- 7 of Veterans' Affairs. The director may adopt and promulgate such rules
- 8 and regulations as may be necessary for administering such aid.
- 9 (3) No part of the interest accumulation of the Nebraska Veterans' 10 Aid Fund shall be expended for the purpose of organizing and maintaining any veterans organization. There shall be expended under the direction of 11 the <u>Director of Veterans' Affairs</u> director such sum or sums as may be 12 13 specifically appropriated by the Legislature for the employment of 14 necessary assistants or deputies and clerical employees reasonable compensation as may be fixed by the director in 15 particular case and for the maintenance and expenses of a state service 16 17 office with necessary service officers and assistants to prepare and present meritorious cases of ex-servicemen and ex-servicewomen for 18 19 benefits before the United States Department of Veterans Affairs. Such cases shall be accepted by the state service officer on behalf of any 20 claimant when a proper power of attorney is given by such claimant to the 21 office of the <u>Director of Veterans'</u> Affairs director or to a state 22 service officer, if he or she is so designated by any recognized veterans 23 24 organization as its sole representative, and regardless of where the 25 cases originate. No part of such sum or sums is to be paid out of the twelve-million-dollar trust fund or the income therefrom. Upon the 26 completion of the trust, the principal fund so held by the State 27 28 Treasurer shall revert to the treasury of the state.
 - (4) For purposes of this section, veteran means any person who:
- 30 (a) Served on active duty in the armed forces of the United States, 31 other than active duty for training, and who:

- 1 (i) Was discharged or otherwise separated with a characterization of 2 honorable or general (under honorable conditions) from such service; or
- 3 (ii) Died while in service or as a direct result of such service; or
- (b) Being a citizen of the United States at the time of his or her entry into such service, served with the military forces of any government allied with the United States during any period identified in section 80-401.01 and was discharged or otherwise separated with a
- 8 characterization of honorable or general (under honorable conditions).
- 9 Sec. 4. Section 80-401.11, Reissue Revised Statutes of Nebraska, is 10 amended to read:
- Necessary offices at such other places in the state as it may designate
 and may incur the necessary expense for office furniture, stationery,
 printing and other incidental or necessary expenses and . It may employ
 such clerical and other employees and assistants as the department deems
 it may deem necessary for the proper transaction of its business.
- Sec. 5. Section 80-404, Reissue Revised Statutes of Nebraska, is amended to read:
- 80-404 The Department of Veterans' Affairs may (1) receive gifts, 20 grants, bequests, contributions, or donations from public or private 21 22 sources or hold in trust testamentary or other gifts, (2) and may purchase or receive gifts of such real estate as may be necessary or 23 24 advantageous for the carrying out the duties and functions of the 25 department, and (3) contract with public or private groups to conduct department business of the provisions of sections 80-401 to 80-405. All 26 27 property of the department so held or owned by it shall be free from taxation during the period of time <u>such property is</u> it shall be held or 28 used by the department it for the purpose of furnishing aid to such 29 30 veterans and their dependents authorized by the provisions of section 80-403. 31

- 4 met, the University of Nebraska, the state colleges, and the community
- 5 colleges shall waive the following for a dependent of a veteran:
- 6 (a) All tuition; and
- 7 (b) All fees remaining due after subtracting awarded federal
- 8 financial aid grants and state scholarships and grants.
- 9 (2) A person shall be eligible for the waiver of tuition and such
- 10 fees if he or she meets the following requirements:
- 11 (a) He or she is a resident of this state and meets the appropriate
- 12 institution's requirements for establishing residency for the purpose of
- 13 paying instate tuition;
- 14 (b) He or she has a parent, stepparent, or spouse who was a member
- of the armed forces of the United States and who:
- 16 (i) Died while on active duty;
- 17 (ii) (i) Died of a service-connected disability;
- 18 <u>(iii)</u> Died subsequent to discharge as a result of injury or
- 19 illness sustained while a member of the armed forces which may or may not
- 20 have resulted in total disability;
- 21 (iv) (iii) Is permanently and totally disabled as a result of
- 22 military service. Permanent and total disability does not include total
- 23 ratings or other temporary ratings except total ratings based on
- 24 individual unemployability if permanent; or
- 25 (v) (iv) While a member of the armed forces of the United States, is
- 26 classified as missing in action or as a prisoner of war during armed
- 27 hostilities; and
- 28 (c) If he or she is a child or stepchild of a person described in
- 29 subdivision (2)(b) of this section, he or she is under the age of twenty-
- 30 six years unless he or she serves on active duty with the armed forces
- 31 after his or her eighteenth birthday but before his or her twenty-sixth

- 1 birthday, in which case such period shall end five years after his or her
- 2 first discharge or release from such duty with the armed forces, but in
- 3 no event shall such period be extended beyond the thirty-first birthday.
- 4 (3) An application for a waiver shall be submitted on a form to be
- 5 prescribed by the Director of Veterans' Affairs.
- 6 (4) If the <u>Director of Veterans' Affairs or the director's designee</u>
- 7 director determines that the applicant is eligible for the waiver, the
- 8 director or the director's designee shall so certify to the institution
- 9 in which the applicant desires to enroll. The decision of the director \underline{or}
- 10 the director's designee shall, in the absence of fraud or
- 11 misrepresentation on the part of the applicant, be final and shall be
- 12 binding upon the applicant and upon the institutions specified in this
- 13 section. The director shall adopt and promulgate reasonable rules and
- 14 regulations for the administration of this section.
- 15 (5) The waiver shall be valid for one degree, diploma, or
- 16 certificate from a community college and one baccalaureate degree.
- 17 Receipt of such degree, diploma, or certificate from a community college
- 18 shall precede receipt of such baccalaureate degree.

- 25 shall be charged with securing the information requested by the <u>director</u>

- 28 office of the <u>Director of Veterans' Affairs</u> director. Such information
- 29 shall be secured from the undertaker in charge of the burial and shall be

- 10 (b) All personnel of the office of the Lieutenant Governor;
- 11 (c) All personnel of the office of the Secretary of State;

1 (2) At each agency head's discretion, up to the following number of 2 additional positions may be exempted from the State Personnel System, 3 based on the following agency size categories:

16 The purpose of having such noncovered positions shall be to allow agency heads the opportunity to recruit, hire, and supervise critical, 17 confidential, or policymaking personnel without restrictions from 18 selection procedures, compensation rules, career protections, 19 and 20 grievance privileges. Persons holding the noncovered positions shall serve at the pleasure of the agency head and shall be paid salaries set 21 by the agency head. An agency with over five thousand employees shall 22 provide notice in writing to the Health and Human Services Committee of 23 the Legislature when forty noncovered positions have been filled by the 24 agency head pursuant to this subsection. 25

26 (3) No changes to this section or to the number of noncovered 27 positions within an agency shall affect the status of personnel employed 28 on the date the changes become operative without their prior written 29 agreement. A state employee's career protections or coverage by personnel 29 rules and regulations shall not be revoked by redesignation of the 29 employee's position as a noncovered position without the prior written
