- 1 A BILL FOR AN ACT relating to the Medicine and Surgery Practice Act; to
- 2 amend sections 38-2044 and 38-2045, Reissue Revised Statutes of
- 3 Nebraska; to correct the name of a commission; and to repeal the
- 4 original sections.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 38-2044, Reissue Revised Statutes of Nebraska, is

2 amended to read:

3 38-2044 A temporary educational permit may be issued to graduates of foreign schools or colleges of medicine or to individuals if the 4 5 applicant, in addition to meeting the other requirements for the issuance of such permit, presents to the department a copy of a permanent 6 7 certificate of the Educational Commission for on Foreign Medical Graduates currently effective and relating to such applicant or, in lieu 8 9 thereof, such credentials as are necessary to certify to successful 10 passage of the Visa Qualifying Examination, or its successor equivalent examination, required by the United States Department of 11 Health and Human Services and the United States Citizenship and 12 Immigration Services or, if a graduate of a foreign medical school who 13 has successfully completed a program of American medical training 14 designated as the Fifth Pathway and who additionally has successfully 15 passed the Educational Commission for on Foreign Medical Graduates 16 17 examination but has not yet received a permanent certificate attesting to the same, and provides such credentials as are necessary to certify the 18 19 same to the department, at such time as the department, with the recommendation of the board, determines, and, if so directed by the 20 department, passes an examination approved by the board to measure his or 21 her clinical competence to proceed to advanced training before advancing 22 23 beyond the initial phase of the training program, and if such examination is required, pays the required fee. 24

Sec. 2. Section 38-2045, Reissue Revised Statutes of Nebraska, is amended to read:

38-2045 A visiting faculty permit may be issued to graduates of foreign schools or colleges of medicine or to individuals if an accredited college or school of medicine in the State of Nebraska has requested that such permit be issued. It shall not be necessary for such applicant to provide a certificate of the Educational Commission for on

- 1 Foreign Medical Graduates as required in the case of temporary
- 2 educational permits. If directed by the department an applicant for a
- 3 visiting faculty permit may be required to pass an examination approved
- 4 by the board to measure his or her clinical competence to practice
- 5 medicine and if such examination is required the applicant shall pay the
- 6 required fee.
- 7 Sec. 3. Original sections 38-2044 and 38-2045, Reissue Revised
- 8 Statutes of Nebraska, are repealed.
