- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 227, One Hundred
- 3 Eighth Legislature, First Session, 2023; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$450,913 from the
- 2 General Fund and \$32,181 from federal funds for FY2023-24 and (2)
- 3 \$631,277 from the General Fund and \$45,054 from federal funds for
- 4 FY2024-25 to the Department of Health and Human Services, for Program 33,
- 5 to aid in carrying out the provisions of Legislative Bill 227, One
- 6 Hundred Eighth Legislature, First Session, 2023.
- 7 Total expenditures for permanent and temporary salaries and per
- 8 <u>diems from funds appropriated in this section shall not exceed \$302,728</u>
- 9 for FY2023-24 or \$420,770 for FY2024-25.
- 10 Sec. 2. There is hereby appropriated (1) \$97,864 from the
- 11 Professional and Occupational Credentialing Cash Fund for FY2023-24 and
- 12 (2) \$119,688 from the Professional and Occupational Credentialing Cash
- 13 Fund for FY2024-25 to the Department of Health and Human Services, for
- 14 Program 178, to aid in carrying out the provisions of Legislative Bill
- 15 227, One Hundred Eighth Legislature, First Session, 2023.
- 16 Total expenditures for permanent and temporary salaries and per
- 17 diems from funds appropriated in this section shall not exceed \$63,564
- 18 for FY2023-24 or \$75,664 for FY2024-25.
- 19 Sec. 3. <u>There is hereby appropriated (1) \$2,286,020 from the</u>
- 20 General Fund and \$1,935,002 from federal funds for FY2023-24 and (2)
- 21 \$1,828,350 from the General Fund and \$2,587,953 from federal funds for
- 22 FY2024-25 to the Department of Health and Human Services, for Program
- 23 348, to aid in carrying out the provisions of Legislative Bill 227, One
- 24 <u>Hundred Eighth Legislature, First Session, 2023.</u>
- There is included in the appropriation to this program for FY2023-24
- 26 <u>\$2,286,020 General Funds and \$1,935,002 federal funds for state aid,</u>
- 27 <u>which shall only be used for such purpose. There is included in the</u>
- 28 appropriation to this program for FY2024-25 \$1,828,350 General Funds and
- 29 \$2,587,953 federal funds for state aid, which shall only be used for such
- 30 <u>purpose</u>.
- 31 No expenditures for permanent and temporary salaries and per diems

- 1 for state employees shall be made from funds appropriated in this
- 2 <u>section.</u>
- 3 Sec. 4. Since an emergency exists, this act takes effect when
- 4 passed and approved according to law.
