- A BILL FOR AN ACT relating to game and parks; to amend sections 37-104, 37-451, 37-453, 37-457, 37-492, and 37-708, Reissue Revised Statutes
- 3 of Nebraska, and sections 37-407, 37-447, 37-448, and 37-449,
- 4 Revised Statutes Cumulative Supplement, 2022; to change a quorum
- 5 requirement for a Game and Parks Commission meeting; to change
- 6 provisions relating to fees charged and permits issued by the Game
- 7 and Parks Commission as prescribed; to change provisions related to
- 8 prohibited acts in game refuges; and to repeal the original
- 9 sections.
- 10 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 37-104, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 37-104 Regular meetings of the Game and Parks Commission shall be
- 4 held quarterly. Special meetings may be held upon call of the chairperson
- 5 or pursuant to a call signed by three other members, of which the
- 6 chairperson shall have three days' written notice. No official action
- 7 shall be taken except at a public meeting at the headquarters of the
- 8 commission or at a public meeting at a location within the state as
- 9 determined by a majority of members of the commission. Five Four members
- 10 of the commission shall constitute a quorum for the transaction of
- 11 business.
- 12 All regular meetings held in Lincoln, Nebraska, shall be held in
- 13 suitable offices to be provided under the authority of Chapter 72,
- 14 article 14. The Game and Parks Commission is authorized to enter into an
- 15 agreement with the city of Lincoln providing for the supplying by the
- 16 city of Lincoln to the State of Nebraska for the commission of a
- 17 headquarters office building and related buildings and facilities
- 18 therefor, including the parking of motor vehicles, to be located on real
- 19 estate which is north of Holdrege Street and east of 33rd Street.
- 20 Sec. 2. Section 37-407, Revised Statutes Cumulative Supplement,
- 21 2022, is amended to read:
- 22 37-407 (1) The commission may offer multiple-year permits or
- 23 combinations of permits at reduced rates and may establish fees pursuant
- 24 to section 37-327 to be paid to the state for resident and nonresident
- 25 annual hunting permits, annual fishing permits, three-day fishing
- 26 permits, one-day fishing permits, combination hunting and fishing
- 27 permits, fur-harvesting permits, and nonresident two-day hunting permits
- 28 issued for periods of two consecutive days, as provided in this section.
- 29 (2) The fee for a multiple-year permit shall be established by the
- 30 commission pursuant to section 37-327 and shall not be more than the
- 31 number of years the permit will be valid times the fee required for an

- 1 annual permit as provided in subsection (3) or (4) of this section.
- 2 Payment for a multiple-year permit shall be made in a lump sum at the
- 3 time of application. A replacement multiple-year permit may be issued
- 4 under section 37-409 if the original is lost or destroyed.
- 5 (3) Resident fees shall be (a) not more than eighteen dollars for an
- 6 annual hunting permit, (b) not more than twenty-four dollars for an
- 7 annual fishing permit, (c) not more than fifteen dollars for a three-day
- 8 fishing permit, (d) not more than nine dollars for a one-day fishing
- 9 permit, (e) not more than thirty-nine dollars for an annual fishing and
- 10 hunting permit, and (f) not more than twenty dollars for an annual fur-
- 11 harvesting permit.
- 12 (4) Nonresident fees shall be (a) not more than two hundred sixty
- 13 dollars for a period of time specified by the commission for fur
- 14 harvesting one thousand or less fur-bearing animals and not more than
- 15 seventeen dollars and fifty cents additional for each one hundred or part
- of one hundred fur-bearing animals harvested, (b)(i) for persons sixteen
- 17 years of age and older, not more than one hundred <u>thirty-eight</u> six
- 18 dollars for an annual hunting permit and (ii) for persons under sixteen
- 19 years of age, not less than the fee required pursuant to subdivision (3)
- 20 (a) of this section for an annual hunting permit, (c) not more than
- 21 <u>ninety-five</u> seventy-three dollars for a two-day hunting permit plus the
- 22 cost of a habitat stamp, (d) not more than <u>fifteen</u> twelve dollars for a
- 23 one-day fishing permit, (e) not more than <u>twenty-nine</u> <del>twenty-two</del> dollars
- 24 for a three-day fishing permit, (f) not more than <u>eighty-six</u> sixty-six
- 25 dollars for an annual fishing permit, and (g)(i) for persons sixteen
- 26 years of age and older, not more than two hundred seven one hundred
- 27 fifty-nine dollars for an annual fishing and hunting permit and (ii) for
- 28 persons under sixteen years of age, not less than the fee required
- 29 pursuant to subdivision (3)(e) of this section for an annual fishing and
- 30 hunting permit.
- 31 (5) The commission may offer permits or combinations of permits at

temporarily reduced rates for specific events or during specified 1

- 2 timeframes.
- 3 Sec. 3. Section 37-447, Revised Statutes Cumulative Supplement,
- 4 2022, is amended to read:
- 5 37-447 (1) The commission may issue permits for the hunting of deer
- and adopt and promulgate rules and regulations and pass commission orders 6
- 7 pursuant to section 37-314 to prescribe limitations for the hunting,
- transportation, and possession of deer. The commission may offer permits 8
- 9 or combinations of permits at temporarily reduced rates for specific
- 10 events or during specified timeframes. The commission may specify by rule
- and regulation the information to be required on applications for such 11
- permits. Rules and regulations for the hunting, transportation, 12
- 13 possession of deer may include, but not be limited to, rules and
- regulations as to the type, caliber, and other specifications of firearms 14
- 15 and ammunition used and specifications for bows and arrows used. Such
- rules and regulations may further specify and limit the method of hunting 16
- 17 deer and may provide for dividing the state into management units or
- areas, and the commission may enact different deer hunting regulations 18
- 19 for the different management units pertaining to sex, species, and age of
- the deer hunted. 20
- (2) The number of such permits may be limited as provided by the 21
- 22 rules and regulations of the commission, and except as provided in
- section 37-454, the permits shall be allocated in an impartial manner. 23
- 24 Whenever the commission deems it advisable to limit the number of permits
- 25 issued for any or all management units, the commission shall, by rules
- and regulations, determine eligibility to obtain such permits. 26
- 27 establishing eligibility, the commission may give preference to persons
- 28 who did not receive a permit or a specified type of permit during the
- previous year or years. 29
- (3) Such permits may be issued to allow deer hunting in the Nebraska 30
- National Forest and other game reserves and such other areas as the 31

- 1 commission may designate whenever the commission deems that permitting
- 2 such hunting will not be detrimental to the proper preservation of
- 3 wildlife in Nebraska in such forest, reserves, or areas.
- 4 (4)(a) The commission may, pursuant to section 37-327, establish and
- 5 charge a nonrefundable application fee of not more than seven dollars for
- 6 deer permits in those management units awarded on the basis of a random
- 7 drawing. The commission shall, pursuant to section 37-327, establish and
- 8 charge a fee of not more than thirty-nine dollars for residents and not
- 9 more than three two hundred sixty-nine eighty-four dollars for
- 10 nonresidents for each permit issued under this section except as
- otherwise provided in subdivision (b) of this subsection and subsection
- 12 (6) of this section. The commission may, pursuant to section 37-327,
- 13 establish and charge a fee of not more than twenty-four dollars for
- 14 residents and not more than seventy-two dollars for nonresidents for the
- 15 issuance of a preference point, in addition to any application fee, in
- 16 lieu of entering the draw for a deer permit during the application period
- 17 for the random drawing.
- 18 (b) The fee for a statewide buck-only permit limited to white-tailed
- 19 deer shall be no more than two and one-half times the amount of a regular
- 20 deer permit. The fee for a statewide buck-only deer permit that allows
- 21 harvest of mule deer shall be no more than five times the amount of a
- 22 regular deer permit.
- 23 (5)(a) The commission may issue nonresident permits after preference
- 24 has been given for the issuance of resident permits as provided in rules
- 25 and regulations adopted and promulgated by the commission.
- 26 (b) In management units specified by the commission, the commission
- 27 may issue nonresident permits after resident preference has been provided
- 28 by allocating at least eighty-five percent of the available permits to
- 29 residents. The commission may require a predetermined application period
- 30 for permit applications in specified management units. Such permits shall
- 31 be issued after a reasonable period for making application, as

- 1 established by the commission, has expired. When more valid applications
- 2 are received for a designated management unit than there are permits
- 3 available, such permits shall be allocated on the basis of a random
- 4 drawing. All valid applications received during the predetermined
- 5 application period shall be considered equally in any such random drawing
- 6 without regard to time of receipt of such applications by the commission.
- 7 (6) The commission shall, pursuant to section 37-327, establish and
- 8 charge a fee of not more than twenty-five dollars for residents and not
- 9 more than forty-five dollars for nonresidents for a youth deer permit.
- 10 (7) Any person violating the rules and regulations adopted and
- 11 promulgated or commission orders passed pursuant to this section shall be
- 12 guilty of a Class II misdemeanor and shall be fined at least one hundred
- 13 dollars upon conviction.
- 14 Sec. 4. Section 37-448, Revised Statutes Cumulative Supplement,
- 15 2022, is amended to read:
- 16 37-448 (1) Subject to rules and regulations adopted and promulgated
- 17 by the commission, the secretary of the commission may designate, by
- 18 order, special deer, antelope, and elk depredation seasons or extensions
- 19 of existing hunting seasons. The secretary may designate a depredation
- 20 season or an extension of an existing hunting season whenever he or she
- 21 determines that deer, antelope, or elk are causing excessive property
- 22 damage. The secretary shall specify the number of permits to be issued,
- 23 the species, sex, and number or quota of animals allowed to be taken, the
- 24 bag limit for such species, the beginning and ending dates for the
- 25 depredation season or hunting season extension, only limitations on
- 26 nonresident permits, shooting hours, the length of the depredation season
- 27 or hunting season extension, and the geographic area in which hunting
- 28 will be permitted. The rules and regulations shall allow use of any
- 29 weapon permissible for use during the regular deer, antelope, or elk
- 30 season.
- 31 (2) The depredation season may commence not less than five days

- 1 after the first public announcement that the depredation season has been 2 established. Permits shall be issued in an impartial manner at a location determined by the secretary. The commission shall, pursuant to section 3 4 37-327, establish and charge a fee of not more than twenty-five dollars for a resident special depredation season permit and a fee of not more 5 than seventy-five dollars for a nonresident special depredation season 6 permit. The commission shall, pursuant to section 37-327, establish and 7 charge a fee of not more than ten dollars for a landowner special 8 9 depredation season permit for the taking of deer and antelope for any 10 person owning or operating at least twenty acres of farm or ranch land within the geographic area in which hunting will be permitted and to any 11 member of the immediate family of any such person as defined in 12 subdivision (2)(a) of section 37-455, and for the taking of elk for any 13 person owning or operating at least eighty acres of farm or ranch land 14 15 within the geographic area in which hunting will be permitted and to any 16 member of the immediate family of such person as defined in subdivision 17 (2)(a) of section 37-455. A special depredation season permit shall be valid only within such area and only during the designated depredation 18 season. The commission shall use the income from the sale of special 19 depredation season permits for abatement of damage caused by deer, 20 antelope, and elk. Receipt of a depredation season permit shall not in 21 any way affect a person's eligibility for a permit issued under section 22 37-447, 37-449, 37-450, or 37-455. 23
- Sec. 5. Section 37-449, Revised Statutes Cumulative Supplement, 25 2022, is amended to read:
- 37-449 (1) The commission may issue permits for hunting antelope and may adopt and promulgate separate and, when necessary, different rules and regulations therefor within the limitations prescribed in sections 37-447 and 37-452 for hunting deer. The commission may offer permits or combinations of permits at reduced rates for specific events or during specified timeframes.

- 1 (2) The commission may, pursuant to section 37-327, establish and 2 charge a nonrefundable application fee of not more than seven dollars for antelope permits in those management units awarded on the basis of a 3 4 random drawing. The commission shall, pursuant to section 37-327, establish and charge a fee of not more than thirty-nine dollars for 5 residents and not more than two one hundred fifty-seven ninety-eight 6 7 dollars for nonresidents for each permit issued under this section except as provided in subsection (4) of this section. The commission may, 8 9 pursuant to section 37-327, establish and charge a fee of not more than twenty-four dollars for residents and not more than seventy-two dollars 10 for nonresidents for the issuance of a preference point, in addition to 11 any application fee, in lieu of entering the draw for an antelope permit 12 13 during the application period for the random drawing.
- (3) The provisions for the distribution of deer permits and the authority of the commission to determine eligibility of applicants for permits as described in sections 37-447 and 37-452 shall also apply to the distribution of antelope permits.
- (4) The commission shall, pursuant to section 37-327, establish and charge a fee of not more than twenty-five dollars for residents and not more than forty-five dollars for nonresidents for a youth antelope permit.
- (5) Any person violating the rules and regulations adopted and promulgated pursuant to this section shall be guilty of a Class II misdemeanor and shall be fined at least one hundred dollars upon conviction.
- Sec. 6. Section 37-451, Reissue Revised Statutes of Nebraska, is amended to read:
- 37-451 (1) The commission may issue permits for hunting mountain sheep and may adopt and promulgate separate and, when necessary, different rules and regulations therefor within the limitations prescribed in subsection (1) of section 37-447 and section 37-452 for

- 1 hunting deer. Such rules and regulations shall include provisions
- 2 allowing persons who find dead mountain sheep, or any part of a mountain
- 3 sheep, to turn over to the commission such mountain sheep or part of a
- 4 mountain sheep. The commission may dispose of such mountain sheep or part
- 5 of a mountain sheep as it deems reasonable and prudent. Except as
- 6 otherwise provided in this section, the permits shall be issued to
- 7 residents of Nebraska.
- 8 (2) The commission shall, pursuant to section 37-327, establish and
- 9 charge a nonrefundable application fee of not more than thirty-four
- 10 dollars for permits issued only to residents. Any number of resident-only
- 11 permits, as authorized by the commission, shall be awarded by random
- 12 drawing to eligible applicants. No permit fee shall be charged in
- 13 addition to the nonrefundable application fee.
- 14 (3) No more than one additional permit may be authorized and issued
- 15 pursuant to an auction open to residents and nonresidents. The auction
- 16 shall be conducted according to rules and regulations prescribed by the
- 17 commission. Any money derived from the sale of permits by auction shall
- 18 be used only for perpetuation and management of mountain sheep, elk, and
- 19 deer.
- 20 (4) If the commission determines to limit the number of permits
- 21 issued for any or all management units, the commission shall by rule and
- 22 regulation determine eligibility requirements for the permits.
- 23 (5) A person may obtain only one mountain sheep permit in his or her
- 24 lifetime, except that an auction permit issued in accordance with
- 25 subsection (3) of this section to harvest a mountain sheep shall not
- 26 <u>count against such total</u>.
- 27 (6) Any person violating the rules and regulations adopted and
- 28 promulgated pursuant to this section shall be guilty of a Class III
- 29 misdemeanor and shall be fined at least five hundred dollars upon
- 30 conviction.
- 31 Sec. 7. Section 37-453, Reissue Revised Statutes of Nebraska, is

- 1 amended to read:
- 2 37-453 Applications for the special permits provided for in section
- 3 37-447 or 37-449 shall be made individually or on a unit basis. If such
- 4 application is made on a unit basis, not more than six two applicants may
- 5 apply for such permit in one application. If such application is granted,
- 6 such special permits shall be issued to the persons so applying. If any
- 7 one of the persons so applying shall be ineligible to receive such
- 8 special permit, the entire group so applying shall be disqualified. No
- 9 person applying for such special permit on a unit basis shall also apply
- 10 individually.
- 11 Sec. 8. Section 37-457, Reissue Revised Statutes of Nebraska, is
- 12 amended to read:
- 13 37-457 (1) The commission may issue permits for hunting wild turkey
- 14 and prescribe and establish regulations and limitations for the hunting,
- 15 transportation, and possession of wild turkey. The commission may offer
- 16 multiple-year permits or combinations of permits at reduced rates. The
- 17 number of such permits may be limited as provided by the regulations of
- 18 the commission, but the permits shall be disposed of in an impartial
- 19 manner. Such permits may be issued to allow wild turkey hunting in the
- 20 Nebraska National Forest and other game reserves and such other areas as
- 21 the commission may designate whenever the commission deems that
- 22 permitting such hunting would not be detrimental to the proper
- 23 preservation of wildlife in such forest, reserves, or areas.
- 24 (2) The commission shall, pursuant to section 37-327, establish and
- 25 charge a fee of not more than thirty-one dollars for residents and not
- 26 more than one hundred <u>sixty-four</u> twenty-six dollars for nonresidents for
- 27 each permit issued under this section except as provided in subsection
- 28 (5) of this section.
- 29 (3) The commission may issue nonresident permits after preference
- 30 has been given for the issuance of resident permits as provided in rules
- 31 and regulations adopted and promulgated by the commission. The commission

- 1 may require a predetermined application period for permit applications in
- 2 specified management units.
- 3 (4) The provisions of section 37-447 for the distribution of deer
- 4 permits also may apply to the distribution of wild turkey permits. No
- 5 permit to hunt wild turkey shall be issued without payment of the fee
- 6 required by this section.
- 7 (5) The commission shall, pursuant to section 37-327, establish and
- 8 charge a fee of not more than twenty-five dollars for residents and not
- 9 more than forty-five dollars for nonresidents for a youth wild turkey
- 10 permit.
- 11 Sec. 9. Section 37-492, Reissue Revised Statutes of Nebraska, is
- 12 amended to read:
- 13 37-492 The commission may adopt and promulgate rules and regulations
- 14 and pass commission orders for carrying out, administering, and enforcing
- 15 the provisions of sections 37-484 to 37-496. The commission shall limit
- 16 the number of areas proposed for licensing so that the total acreage
- 17 licensed for game breeding and controlled shooting areas in any one
- 18 county does not exceed <u>five</u> two percent of the total acreage of the
- 19 county in which the areas are sought to be licensed. The commission shall
- 20 not require distances between boundaries of game breeding and controlled
- 21 shooting areas to be greater than two miles. No license shall be issued
- 22 for any area whereon mallard ducks are shot or to be shot if the area
- 23 lies within three miles of any river or within three miles of any lake
- 24 with an area exceeding three acres, except that a license may be issued
- 25 for such area for the shooting of upland game birds only, and the rearing
- 26 or shooting of mallard ducks thereon is prohibited.
- 27 Sec. 10. Section 37-708, Reissue Revised Statutes of Nebraska, is
- 28 amended to read:
- 29 37-708 (1) It shall be unlawful within the boundaries of the state
- 30 game refuges designated in section 37-706 for any person (a) to hunt or
- 31 chase with dogs any game birds, game animals, or other birds or animals

- 1 of any kind or description whatever, (b) to carry firearms of any kind,
- 2 or (c) from October 15 through January 15 each year to operate a
- 3 motorboat as defined in section 37-1204.
- 4 (2) This section shall not prevent highway or railroad transport of
- 5 firearms or dogs across the refuge, retrieval of game birds lawfully
- 6 killed from such refuge, or the taking of fur-bearing animals by the use
- 7 of traps during lawful open seasons on the refuge.
- 8 (3) This section shall not prevent the commission from issuing such
- 9 permits as may be necessary for the killing of animal or bird predators
- 10 that may endanger game birds or game animals or the domestic property of
- 11 adjacent landowners or from issuing permits as provided in sections
- 12 37-447 to 37-452 for the taking of deer or elk from such refuges whenever
- 13 the number of deer or elk on such refuges is deemed detrimental to
- 14 habitat conditions on the refuges or to adjacent privately owned real or
- 15 personal property.
- 16 (4) This section shall not prevent the owners of land or dwellings
- 17 or their relatives or invitees from operating any motorboat within the
- 18 boundaries of the refuge for purposes of access by the most direct route
- 19 to and from such land or dwellings.
- 20 Sec. 11. Original sections 37-104, 37-451, 37-453, 37-457, 37-492,
- 21 and 37-708, Reissue Revised Statutes of Nebraska, and sections 37-407,
- 22 37-447, 37-448, and 37-449, Revised Statutes Cumulative Supplement, 2022,
- 23 are repealed.
