- 1 A BILL FOR AN ACT relating to firearms; to amend sections 69-2406,
- 2 69-2407, and 69-2439, Reissue Revised Statutes of Nebraska, and
- 3 section 25-2740, Revised Statutes Cumulative Supplement, 2022; to
- 4 adopt the Suicide Risk Protection Order Act; to harmonize
- 5 provisions; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Sections 1 to 17 of this act shall be known and may be

- 2 cited as the Suicide Risk Protection Order Act.
- 3 Sec. 2. For purposes of the Suicide Risk Protection Order Act:
- 4 (1) Ex parte suicide risk protection order means a temporary
- 5 protection order issued on an ex parte basis under section 5 of this act;
- 6 (2) Family or household member includes spouses or former spouses,
- 7 children, persons who are presently residing together or who have resided
- 8 together in the past, persons who have a child in common whether or not
- 9 they have been married or have lived together at any time, other persons
- 10 related by consanguinity or affinity, and persons who are presently
- 11 involved in a dating relationship with each other or who have been
- 12 <u>involved in a dating relationship with each other. For purposes of this</u>
- 13 <u>subdivision</u>, <u>dating relationship means frequent</u>, <u>intimate associations</u>
- 14 primarily characterized by the expectation of affectional or sexual
- 15 <u>involvement</u>, but does not include a casual relationship or an ordinary
- 16 association between persons in a business or social context;
- 17 (3) Final suicide risk protection order means an order issued under
- 18 section 4 of this act or an ex parte suicide risk protection order that
- 19 is deemed final under section 5 of this act and includes renewals of such
- 20 orders;
- 21 (4) Firearm has the same meaning as in section 28-1201;
- 22 (5) Firearm permit means a permit to carry a concealed handgun
- 23 issued under the Concealed Handgun Permit Act, a certificate issued under
- 24 section 69-2404, or any other permit, certificate, or written
- 25 authorization under the laws of this state or another jurisdiction that
- 26 <u>authorizes the purchase, receipt, possession, or concealment of a</u>
- 27 firearm;
- 28 (6) Law enforcement agency means the police department or town
- 29 <u>marshal in incorporated municipalities</u>, the office of the sheriff in
- 30 <u>unincorporated areas, and the Nebraska State Patrol;</u>
- 31 (7) Law enforcement officer means any officer or employee of a law

- 1 enforcement agency authorized by law to make arrests;
- 2 (8) Petitioner means the person who petitions for a suicide risk
- 3 <u>protection order; and</u>
- 4 (9) Respondent means the person who is identified as the respondent
- 5 in a petition filed under the act.
- 6 Sec. 3. (1) Beginning January 1, 2024, a law enforcement agency or
- 7 law enforcement officer may file a petition for a suicide risk protection
- 8 order.
- 9 (2) A petition for a suicide risk protection order shall be filed
- 10 with the clerk of the district court of the county where the respondent
- 11 <u>resides, and the proceeding may be heard by the county court or the</u>
- 12 <u>district court as provided in section 25-2740. A petition may not be</u>
- 13 <u>withdrawn except upon order of the court.</u>
- 14 (3) A petition for a suicide risk protection order shall:
- 15 (a) Allege that the respondent poses a significant risk of causing
- 16 personal injury to self or others by having in the respondent's custody
- 17 or control, purchasing, possessing, or receiving a firearm;
- 18 (b) Be accompanied by an affidavit made under oath stating the
- 19 <u>specific statements, actions, or facts that give rise to a reasonable</u>
- 20 <u>fear of future dangerous acts by the respondent;</u>
- 21 (c) Identify the number, types, and locations of any firearms the
- 22 petitioner believes to be in the respondent's current ownership,
- 23 possession, custody, or control;
- 24 (d) If known by the petitioner, identify any existing harassment
- 25 protection order, sexual assault protection order, domestic violence
- 26 <u>protection order, or other similar protection order governing the</u>
- 27 respondent, whether from this state or another jurisdiction;
- 28 (e) Identify any relevant pending lawsuit, complaint, petition, or
- 29 <u>other action against the respondent under the laws of Nebraska or any</u>
- 30 <u>other jurisdiction; and</u>
- 31 (f) In the case of a petition filed by a law enforcement agency,

- 1 state the agency's address of record, and in the case of a petition filed
- 2 by a law enforcement officer, state the address of the law enforcement
- 3 <u>agency employing such officer.</u>
- 4 (4) The court shall verify the terms of any existing Nebraska court
- 5 order governing the respondent and, if reasonably practicable, the terms
- 6 of any such existing court order from another jurisdiction. The court
- 7 shall not delay granting relief in order to verify the terms of an
- 8 <u>existing order.</u>
- 9 (5) The petitioner shall make a good faith effort to provide notice
- 10 to any known family or household member of the respondent who may be at
- 11 <u>risk of violence and to any known third party who may be at risk of</u>
- 12 <u>violence. If such family or household member or third party is a minor,</u>
- 13 <u>notice to such minor's parent or quardian, other than the respondent,</u>
- 14 shall be sufficient. The notice shall state that the petitioner intends
- 15 to petition the court for a suicide risk protection order or has already
- 16 done so, and include referrals to appropriate resources, including mental
- 17 <u>health, domestic violence, and counseling resources. The petitioner shall</u>
- 18 attest in the petition to having provided such notice or attest to the
- 19 <u>steps that will be taken to provide such notice.</u>
- 20 <u>(6) No fees for filing or service of process shall be charged by a</u>
- 21 court or any public agency to petitioners seeking relief under the
- 22 Suicide Risk Protection Order Act, except that a court may assess such
- 23 fees and costs if the court finds, by clear and convincing evidence, that
- 24 the statements contained in the petition were false and that the suicide
- 25 risk protection order was sought in bad faith.
- 26 <u>(7) Petitioners shall be provided the necessary number of certified</u>
- 27 copies, forms, and instructional brochures free of charge.
- 28 <u>(8) A petitioner shall not be required to post a bond to obtain</u>
- 29 relief in any proceeding under the Suicide Risk Protection Order Act.
- 30 Sec. 4. (1) If a suicide risk protection order is not issued ex
- 31 parte under section 5 of this act, upon receipt of the petition, the

- 1 court shall immediately schedule an evidentiary hearing to be held within
- 2 <u>fourteen days after the filing of the petition, and the court shall cause</u>
- 3 notice of the hearing to be given to the petitioner and the respondent.
- 4 The clerk of the district court shall cause a copy of the notice of
- 5 hearing and petition to be forwarded on or before the next judicial day
- 6 to the appropriate law enforcement agency for service upon the
- 7 respondent. Service issued under this section takes precedence over the
- 8 service of other documents, unless the other documents are of a similar
- 9 emergency nature.
- 10 (2) Subject to court rules, a hearing under the Suicide Risk
- 11 Protection Order Act, including an evidentiary hearing, may be held
- 12 <u>telephonically or by videoconferencing or similar means at any location</u>
- 13 within the judicial district as ordered by the court and in a manner that
- 14 ensures the preservation of an accurate record, when doing so is
- 15 necessary to reasonably accommodate a disability or in exceptional
- 16 circumstances to protect a petitioner or witness from potential harm. The
- 17 court shall require assurances of the identity of the petitioner and any
- 18 witness before conducting a hearing in such manner.
- 19 (3) Upon hearing the matter, if the court finds by a preponderance
- 20 of the evidence that the respondent poses a significant risk of causing
- 21 personal injury to self or others by having in the respondent's custody
- 22 or control, purchasing, possessing, or receiving a firearm, the court
- 23 <u>shall issue a suicide risk protection order that shall be effective for</u>
- 24 <u>one year.</u>
- 25 (4) In determining whether grounds for issuing a suicide risk
- 26 protection order exist, the court may consider any relevant evidence,
- 27 including, but not limited to:
- 28 (a) A recent act or threat of violence by the respondent against
- 29 <u>self or others, whether or not such violence or threat of violence</u>
- 30 <u>involves a firearm;</u>
- 31 (b) A pattern of acts or threats of violence by the respondent,

1 including, but not limited to, acts or threats of violence by the

- 2 respondent against self or others;
- 3 (c) Evidence of the respondent being seriously mentally ill or
- 4 having recurring mental health issues;
- 5 (d) A violation by the respondent of a harassment protection order,
- 6 sexual assault protection order, domestic violence protection order, or
- 7 other similar protection order, whether from this state or another
- 8 jurisdiction;
- 9 (e) The existence of any previous or current suicide risk protection
- 10 order issued against the respondent, whether from this state or another
- 11 jurisdiction, and whether the respondent has violated such order;
- 12 <u>(f) Whether the respondent has been civilly committed under the</u>
- 13 Nebraska Mental Health Commitment Act, the Sex Offender Commitment Act,
- 14 section 29-1823, sections 29-3701 to 29-3704, or under any other similar
- 15 law of this state or another jurisdiction;
- 16 (g) Whether the respondent, in this state or any other jurisdiction,
- 17 has been convicted of, had adjudication withheld or deferred on, or pled
- 18 <u>nolo contendere to a crime in which any victim was a family or household</u>
- 19 member of the respondent;
- 20 <u>(h) The respondent's ownership of, access to, or intent to possess</u>
- 21 firearms;
- 22 <u>(i) The unlawful or reckless use, display, or brandishing of a</u>
- 23 firearm by the respondent;
- 24 (j) The history of use, attempted use, or threatened use of physical
- 25 force by the respondent against another person;
- 26 (k) Any history of stalking by the respondent;
- 27 (1) Whether the respondent, in this state or any other jurisdiction,
- 28 has been arrested for, convicted of, had adjudication withheld or
- 29 <u>deferred on, or pled nolo contendere to a crime involving violence or a</u>
- 30 <u>threat of violence;</u>
- 31 (m) Corroborated evidence of the abuse of controlled or intoxicating

- 1 substances or alcohol by the respondent;
- 2 (n) Evidence of recent acquisition of firearms by the respondent;
- 3 (o) Evidence of the respondent's oral or written statement of hatred
- 4 for or animus toward any person or group, including because of the actual
- 5 or perceived race, color, religion, ancestry, national origin, gender,
- 6 gender expression, gender identity, sexual orientation, age, disability,
- 7 citizenship status, military status, or political affiliation of any
- 8 person or group or because of a person's or group's association with a
- 9 person or group of any such classification or status; and
- 10 (p) Evidence that the respondent has previously acted or may act in
- 11 <u>a threatening manner towards a peace officer or other public safety</u>
- 12 officer with the intent to provoke a lethal response by such officer.
- 13 <u>(5) The court may:</u>
- 14 (a) Examine under oath the petitioner, the respondent, and any
- 15 witnesses they may produce, or, in lieu of examination, consider sworn
- 16 <u>affidavits of the petitioner, the respondent, and any witnesses they may</u>
- 17 produce;
- 18 (b) Conduct a search for criminal history record information related
- 19 to the respondent, including sealed records; and
- 20 <u>(c) Request that a criminal justice agency as defined in section</u>
- 21 29-3509 conduct a search of criminal history record information related
- 22 to the respondent, including sealed records. In such case the court shall
- 23 identify the type of records to be searched.
- 24 (6) In a hearing under the Suicide Risk Protection Order Act, the
- 25 rules of evidence apply to the same extent as in proceedings for a
- 26 domestic protection order under the Protection from Domestic Abuse Act.
- 27 (7) During the hearing, the court shall consider whether a mental
- 28 <u>health evaluation or substance or alcohol dependency evaluation of the</u>
- 29 respondent is appropriate and, if appropriate, may order such evaluation.
- 30 <u>(8) If the court issues a suicide risk protection order, such order</u>
- 31 shall include:

1 (a) A statement of the grounds supporting the issuance of the order;

- 2 (b) The date and time the order was issued;
- 3 (c) The date and time the order expires;
- 4 (d) Whether a mental health evaluation or substance or alcohol
- 5 <u>dependency evaluation of the respondent is required;</u>
- 6 (e) The address of the court in which any responsive pleading should
- 7 be filed;
- 8 (f) A description of the requirements for relinquishment of firearms
- 9 under section 9 of this act; and
- 10 (g) A statement in substantially the following form: "To (name of
- 11 respondent): This order will continue in effect until (date and time of
- 12 expiration of order). If you have not done so already, you must
- immediately surrender to the (name of local law enforcement agency) all
- 14 firearms in your custody, control, or possession, any permit to carry a
- 15 concealed handgun issued to you under the Concealed Handgun Permit Act,
- 16 any certificate issued to you under section 69-2404, and any other
- 17 permit, certificate, or written authorization under the law of this state
- 18 or another jurisdiction that authorizes the purchase, receipt,
- 19 possession, or concealment of a firearm. While this order is in effect
- 20 you shall not have a firearm in your custody or control or purchase,
- 21 possess, receive, or attempt to purchase, possess, or receive a firearm.
- 22 You have the sole responsibility to avoid or refrain from violating this
- 23 order. Only the court can terminate this order and only upon written
- 24 request. You have the right to request a hearing to terminate this order
- 25 once during every twelve-month period that this order is in effect,
- 26 starting from the date of this order and continuing through any renewals.
- 27 You may seek the advice of an attorney as to any matter connected with
- 28 this order."
- 29 (9) When the court issues a suicide risk protection order following
- 30 a hearing under this section, the court shall inform the respondent that
- 31 the respondent is entitled to request termination of the order in the

- 1 manner prescribed by section 7 of this act. The court shall provide the
- 2 <u>respondent with a form to request a termination hearing.</u>
- 3 (10) If the court declines to issue a suicide risk protection order,
- 4 the court shall state on the record the particular reasons for the
- 5 denial.
- 6 Sec. 5. (1) Beginning January 1, 2024, a law enforcement agency or
- 7 law enforcement officer may request that a suicide risk protection order
- 8 be issued ex parte to the respondent and without prior notice to the
- 9 respondent by including in the petition detailed allegations based on
- 10 personal knowledge that the respondent poses a significant risk of
- 11 causing personal injury to self or others in the near future by having in
- 12 the respondent's custody or control, purchasing, possessing, or receiving
- 13 <u>a firearm.</u>
- 14 (2) In considering whether to issue an ex parte suicide risk
- 15 protection order under this section, the court shall consider all
- 16 relevant evidence, including the evidence described in subsection (4) of
- 17 section 4 of this act.
- 18 (3) The court shall hold a hearing for a petition for an ex parte
- 19 suicide risk protection order on the day the petition is filed or on the
- 20 judicial day immediately following the day the petition is filed. Subject
- 21 to court rules, such hearing may be held telephonically or by
- 22 videoconferencing or similar means at any location within the judicial
- 23 district as ordered by the court when doing so is necessary. The court
- 24 shall require assurances of the identity of the petitioner and any
- 25 witness before conducting a hearing in such manner.
- 26 (4) If a court finds there is reasonable cause to believe that the
- 27 respondent poses a significant risk of causing personal injury to self or
- 28 others in the near future by having in the respondent's custody or
- 29 control, purchasing, possessing, or receiving a firearm, the court shall
- 30 issue an ex parte suicide risk protection order. The order shall contain
- 31 the matters required by subsection (8) of section 4 of this act.

1 (5)(a) If a suicide risk protection order is issued ex parte, such 2 order is a temporary order and the court shall forthwith cause notice of 3 the petition and ex parte protection order to be given to the respondent. 4 The court shall also cause a form to request a show-cause hearing to be 5 served upon the respondent. If the respondent wishes to appear and show cause why the order should not remain in effect, the respondent shall 6 7 affix the respondent's current address, telephone number, and signature to the form and return it to the clerk of the district court within ten 8 9 business days after service upon the respondent. Upon receipt of the 10 request for a show-cause hearing, the request of the petitioner, or upon the court's own motion, the court shall immediately schedule a show-cause 11 12 hearing, to be held no later than fourteen days after the receipt of any 13 request for a show-cause hearing, and shall notify the petitioner and 14 respondent of the hearing date. The petition and affidavit shall be deemed to have been offered into evidence at any show-cause hearing. The 15 16 petition and affidavit shall be admitted into evidence unless 17 specifically excluded by the court. (b) If the respondent appears at the hearing and the court finds by 18 19 a preponderance of the evidence that the respondent poses a significant risk of causing personal injury to self or others by having in the 20 respondent's custody or control, purchasing, possessing, or receiving a 21 22 firearm, the ex parte suicide risk protection order shall be affirmed, 23 shall be deemed the final suicide risk protection order, and shall be 24 effective for one year from its initial issuance as an ex parte 25 protection order. In such case, service of the ex parte protection order shall be notice of the final protection order for purposes of prosecution 26 27 under subsection (2) of section 12 of this act. 28 (c) If the respondent appears at the hearing and the court does not find by a preponderance of the evidence that the respondent poses a 29

significant risk of causing personal injury to self or others by having

in the respondent's custody or control, purchasing, possessing, or

1 receiving a firearm, the court shall rescind the ex parte suicide risk

- 2 <u>protection order.</u>
- 3 (d) If the respondent has been properly served with the ex parte
- 4 suicide risk protection order and the respondent was properly notified of
- 5 the hearing date, and the respondent fails to appear at the hearing, the
- 6 order shall be affirmed, shall be deemed the final suicide risk
- 7 protection order, and shall be effective for one year from its initial
- 8 <u>issuance as an ex parte protection order. In such case, service of the ex</u>
- 9 parte protection order shall be notice of the final protection order for
- 10 purposes of prosecution under subsection (2) of section 12 of this act.
- 11 <u>(e) If the respondent fails to request a show-cause hearing within</u>
- 12 ten business days after service of the ex parte suicide risk protection
- 13 order, and no hearing was requested by the petitioner or set on the
- 14 <u>court's own motion, the order shall be affirmed, shall be deemed the</u>
- 15 <u>final suicide risk protection order, and shall be effective for one year</u>
- 16 from its initial issuance as an ex parte protection order. In such case,
- 17 service of the ex parte protection order shall be notice of the final
- 18 protection order for purposes of prosecution under subsection (2) of
- 19 section 12 of this act.
- 20 (6) If the court declines to issue an ex parte suicide risk
- 21 protection order, the court shall state on the record the particular
- 22 reasons for the denial.
- 23 Sec. 6. (1)(a) Upon the issuance of an ex parte suicide risk
- 24 protection order or final suicide risk protection order, the clerk of the
- 25 district court shall, on or before the next judicial day, provide,
- 26 without charge:
- 27 <u>(i) The petitioner with two certified copies of such order;</u>
- 28 (ii) The local law enforcement agency and the Nebraska State Patrol
- 29 with an electronic copy of such order and the sheriff's return thereon;
- 30 and
- 31 (iii) A copy of the suicide risk protection order to the sheriff's

- 1 office in the county where the respondent may be personally served
- 2 together with instructions for service. Upon receipt of the order and
- 3 instructions for service, such sheriff's office shall forthwith serve the
- 4 order upon the respondent and file its return thereon with the clerk of
- 5 the district court within ten days after the issuance of the order.
- 6 (b) If any protection order is dismissed or modified by the court,
- 7 the clerk of the district court shall, on or before the next judicial
- 8 day, provide the local law enforcement agency and the Nebraska State
- 9 Patrol, without charge, with an electronic copy of the order of dismissal
- 10 or modification.
- 11 (c) If the respondent has notice as described in subsection (2) of
- 12 this section, further service under this subsection is unnecessary.
- 13 (2) If the respondent was present at a hearing under section 5 of
- 14 this act and the suicide risk protection order was not dismissed, the
- 15 respondent shall be deemed to have notice by the court at such hearing
- 16 that the protection order will be granted and remain in effect and
- 17 further service of notice described in subsection (1) of this section is
- 18 not required for purposes of prosecution under subsection (2) of section
- 19 12 of this act.
- 20 (3) If the sheriff's office cannot complete service upon the
- 21 respondent within ten days, the sheriff's office shall notify the
- 22 petitioner. The petitioner shall provide information sufficient to permit
- 23 such notification.
- 24 Sec. 7. (1) A respondent may submit a written request for a hearing
- 25 to terminate a final suicide risk protection order once during every
- 26 <u>twelve-month period that the order is in effect, starting from the date</u>
- 27 <u>of issuance of the order and continuing through any renewals.</u>
- 28 (2) Upon receipt of a request for a hearing to terminate a suicide
- 29 risk protection order, the court shall set a date for a hearing to be
- 30 held within fourteen days after receipt of the request. The court may
- 31 also schedule such a hearing on its own motion. The court shall notify

- 1 the petitioner and respondent of the hearing date.
- 2 (3) At a hearing requested by the respondent, the respondent shall
- 3 have the burden of proving by a preponderance of the evidence that the
- 4 respondent does not pose a significant risk of causing personal injury to
- 5 self or others by having in the respondent's custody or control,
- 6 purchasing, possessing, or receiving a firearm. The court may consider
- 7 any relevant evidence, including evidence of the considerations listed in
- 8 subsection (4) of section 4 of this act.
- 9 (4) The court shall terminate the order if the court finds by a
- 10 preponderance of the evidence that the respondent does not pose a
- 11 <u>significant risk of causing personal injury to self or others by having</u>
- 12 <u>in the respondent's custody or control, purchasing, possessing, or</u>
- 13 <u>receiving a firearm.</u>
- 14 Sec. 8. (1) The court shall notify the petitioner of the impending
- 15 expiration of a final suicide risk protection order. The court shall
- 16 provide such notice on or before forty-five days before the date the
- 17 order expires.
- 18 (2) A law enforcement agency or law enforcement officer, including
- 19 one other than the petitioner, may file a motion requesting renewal of a
- 20 <u>final suicide risk protection order at any time within forty-five days</u>
- 21 prior to the date the order is set to expire, including the date the
- 22 order expires.
- 23 (3) Upon receipt of a motion to renew, the court shall immediately
- 24 schedule an evidentiary hearing to be held within fourteen days after the
- 25 filing of the motion, and the court shall cause notice of the hearing to
- 26 <u>be given to the petitioner; the movant, if other than the petitioner; and</u>
- 27 the respondent. The clerk of the district court shall cause a copy of the
- 28 notice of hearing and motion to be forwarded no later than the next
- 29 judicial day to the appropriate law enforcement agency for service upon
- 30 the respondent and the petitioner, if other than the movant. Service
- 31 issued under this section takes precedence over the service of other

- 1 documents, unless the other documents are of a similar emergency nature.
- 2 (4) In determining whether to renew a final suicide risk protection
- 3 order, the court shall consider all relevant evidence presented by the
- 4 parties and follow the same procedure as provided in section 4 of this
- 5 <u>act.</u>
- 6 (5) A final suicide risk protection order may be renewed on the
- 7 basis of the petitioner's or movant's motion or affidavit stating that
- 8 there has been no material change in relevant circumstances since entry
- 9 of the order and stating the reason for the requested renewal if:
- 10 <u>(a) The petitioner and movant seek no modification of the order; and</u>
- 11 (b)(i) The respondent has been properly served under subsection (3)
- of this section and fails to appear at the hearing; or
- (ii) The respondent indicates that the respondent does not contest
- 14 the renewal.
- 15 (6) If the court finds by a preponderance of the evidence that the
- 16 requirements for issuance of a final suicide risk protection order as
- 17 provided in subsection (3) of section 4 of this act continue to be met,
- 18 the court shall renew the order. On or before the next judicial day, the
- 19 <u>clerk of the district court shall, without charge, provide:</u>
- 20 <u>(a) The petitioner, and the movant, if other than the petitioner,</u>
- 21 <u>with two certified copies of such order;</u>
- 22 (b) The local law enforcement agency and the Nebraska State Patrol
- 23 with an electronic copy of such order and with one copy of such order and
- 24 <u>the sheriff's return thereon; and</u>
- 25 (c) A copy of the suicide risk protection order to the sheriff's
- 26 office in the county where the respondent may be personally served
- 27 <u>together with instructions for service. Upon receipt of the order and</u>
- 28 instructions for service, such sheriff's office shall forthwith serve the
- 29 order upon the respondent and file its return thereon with the clerk of
- 30 the district court within ten days after the issuance of the order. If
- 31 the respondent has notice as described in subsection (7) of this section,

- 1 <u>further service under this subsection is unnecessary.</u>
- 2 (7) If the respondent was present at a hearing under this section
- 3 and the suicide risk protection order was renewed, the respondent shall
- 4 be deemed to have notice by the court at such hearing that the protection
- 5 order will remain in effect and further service of notice described in
- 6 subsection (6) of this section is not required for purposes of
- 7 prosecution under subsection (2) of section 12 of this act.
- 8 (8) If the sheriff's office cannot complete service upon the
