- 2 section 73-502, Reissue Revised Statutes of Nebraska; to define and
- 3 redefine terms; to provide for applicability of provisions to

- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 73-502, Reissue Revised Statutes of Nebraska, is

- 3 73-502 For purposes of sections 73-501 to 73-510:
- 4 (1) Contract for services means any contract that directly engages
- 5 the time or effort of an independent contractor whose purpose is to
- 6 perform an identifiable task, study, or report rather than to furnish an
- 7 end item of supply, goods, equipment, or material;
- 8 (2) Division means the materiel division of the Department of
- 9 Administrative Services;
- 10 (3) Emergency means necessary to meet an urgent or unexpected
- 11 requirement or when health and public safety or the conservation of
- 12 public resources is at risk;
- 13 (4) Occasional means seasonal, irregular, or fluctuating in nature;
- 14 (5) Sole source means of such a unique nature that the contractor
- 15 selected is clearly and justifiably the only practicable source to
- 16 provide the service. Determination that the contractor selected is
- 17 justifiably the sole source is based on either the uniqueness of the
- 18 service or sole availability at the location required;
- 19 (6) State agency means any agency, board, or commission of this
- 20 state, including any officer or state agency established by the
- 21 Constitution of Nebraska other than the University of Nebraska, the
- 22 Nebraska state colleges, the courts, or the Legislature; , or any officer
- 23 or state agency established by the Constitution of Nebraska; and
- 24 (7) State agency director means (a) for contracts entered into by a
- 25 state agency other than an officer or agency established by the
- 26 <u>Constitution of Nebraska, the director or executive head of the agency,</u>
- 27 (b) for contracts entered into by a board, commission, or department
- 28 established by the Constitution of Nebraska, the designee of the board,
- 29 <u>commission</u>, or <u>department</u>, and <u>(c)</u> for <u>contracts</u> entered into by any
- 30 other state constitutional officer, the state constitutional officer or
- 31 the designee of the state constitutional officer; and
