- 1 A BILL FOR AN ACT relating to firearms; to amend sections 14-102, 15-255, 2 16-227, 17-556, 18-1703, 69-2429, 69-2435, 69-2439, 69-2440, 69-2441, 69-2442, 69-2443, and 69-2445, Reissue Revised Statutes of 3 Nebraska, and sections 28-101, 28-1201, 4 28-1202, 28-1351, 5 69-2436, Revised Statutes Cumulative Supplement, 2022; to prohibit regulation of weapons by cities, villages, and counties; to provide 6 for the carrying of a concealed handgun without a permit; to change 7 8 provisions relating to other concealed weapons; to provide for requirements, limits, and offenses relating to carrying a concealed 9 handgun; to provide an affirmative defense; to change provisions of 10 the Concealed Handqun Permit Act; to provide penalties; to change, 11 provide, and eliminate definitions; to harmonize provisions; and to 12 13 repeal the original sections.
- 14 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 18-1703, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 18-1703 (1) The Legislature finds and declares that the regulation
- 4 of the ownership, possession, storage, transportation, sale, and transfer
- 5 of firearms and other weapons is a matter of statewide concern.
- 6 (2) Notwithstanding the provisions of any home rule charter,
- 7 counties, cities, and villages shall not have the power to:
- 8 (a) Regulate the ownership, possession, storage, transportation,
- 9 sale, or transfer of firearms or other weapons, except as expressly
- 10 provided by state law; or
- 11 (b) Require registration of firearms or other weapons.
- 12 (3) Any county, city, or village ordinance, permit, or regulation in
- 13 violation of subsection (2) of this section is declared to be null and
- 14 void.
- 15 Cities and villages shall not have the power to regulate the
- 16 ownership, possession, or transportation of a concealed handgun, as such
- 17 ownership, possession, or transportation is authorized under the
- 18 Concealed Handgun Permit Act, except as expressly provided by state law,
- 19 and shall not have the power to require registration of a concealed
- 20 handgun owned, possessed, or transported by a permitholder under the act.
- 21 Any existing city or village ordinance, permit, or regulation regulating
- 22 the ownership, possession, or transportation of a concealed handgun, as
- 23 such ownership, possession, or transportation is authorized under the
- 24 act, except as expressly provided under state law, and any existing city
- 25 or village ordinance, permit, or regulation requiring the registration of
- 26 a concealed handgun owned, possessed, or transported by a permitholder
- 27 under the act, is declared to be null and void as against any
- 28 permitholder possessing a valid permit under the act.
- 29 Sec. 2. Section 14-102, Reissue Revised Statutes of Nebraska, is
- 30 amended to read:
- 31 14-102 In addition to the powers granted in section 14-101, cities

- 1 of the metropolitan class shall have power by ordinance:
- 2 (1) To levy any tax or special assessment authorized by law;
- 3 (2) To provide a corporate seal for the use of the city, and also
- 4 any official seal for the use of any officer, board, or agent of the
- 5 city, whose duties require an official seal to be used. Such corporate
- 6 seal shall be used in the execution of municipal bonds, warrants,
- 7 conveyances, and other instruments and proceedings as required by law;
- 8 (3) To provide all needful rules and regulations for the protection
- 9 and preservation of health within the city, including providing for the
- 10 enforcement of the use of water from public water supplies when the use
- of water from other sources shall be deemed unsafe;
- 12 (4) To appropriate money and provide for the payment of debts and
- 13 expenses of the city;
- 14 (5) To adopt all such measures as may be deemed necessary for the
- 15 accommodation and protection of strangers and the traveling public in
- 16 person and property;
- 17 (6) To punish and prevent the carrying of concealed weapons, except
- 18 the carrying of a concealed handgun in compliance with the Concealed
- 19 Handgun Permit Act, and the discharge of firearms, fireworks, or
- 20 explosives of any description within the city, other than the discharge
- 21 of firearms at a shooting range pursuant to the Nebraska Shooting Range
- 22 Protection Act;
- 23 (7) To regulate the inspection and sale of meats, flour, poultry,
- 24 fish, milk, vegetables, and all other provisions or articles of food
- 25 exposed or offered for sale in the city;
- 26 (8) To require all elected or appointed officers to give bond and
- 27 security for the faithful performance of their duties, except that no
- 28 officer shall become bonded and secured upon the official bond of another
- 29 or upon any bond executed to the city;
- 30 (9) To require from any officer of the city at any time a report, in
- 31 detail, of the transactions of his or her office or any matter connected

- 1 with such office;
- 2 (10) To provide for the prevention of cruelty to children and 3 animals;
- 4 (11) To regulate, license, or prohibit the running at large of dogs 5 and other animals within the city as well as in areas within the 6 extraterritorial zoning jurisdiction of the city; to guard against
- 7 injuries or annoyance from such dogs and other animals; and to authorize
- 8 the destruction of such dogs and other animals when running at large
- 9 contrary to the provisions of any ordinance. Any licensing provision
- 10 shall comply with subsection (2) of section 54-603 for service animals;
- 11 (12) To provide for keeping sidewalks clean and free from 12 obstructions and accumulations; to provide for the assessment and
- 13 collection of taxes on real estate and for the sale and conveyance
- 14 thereof; and to pay the expenses of keeping the sidewalk adjacent to such
- 15 real estate clean and free from obstructions and accumulations as
- 16 provided by law;
- 17 (13) To provide for the planting and protection of shade or
- 18 ornamental and useful trees upon streets or boulevards; to assess the
- 19 cost of such trees to the extent of benefits upon the abutting property
- 20 as a special assessment; to provide for the protection of birds and
- 21 animals and their nests; to provide for the trimming of trees located
- 22 upon streets and boulevards or when the branches of trees overhang
- 23 streets and boulevards when in the judgment of the mayor and city council
- 24 such trimming is made necessary to properly light such street or
- 25 boulevard or to furnish proper police protection; and to assess the cost
- 26 of such trimming upon the abutting property as a special assessment;
- 27 (14) To provide for, regulate, and require the numbering or
- 28 renumbering of houses along public streets or avenues; and to care for
- 29 and control and to name and rename streets, avenues, parks, and squares
- 30 within the city;
- 31 (15) To require weeds and worthless vegetation growing upon any lot

- 1 or piece of ground within the city or its extraterritorial zoning
- 2 jurisdiction to be cut and destroyed so as to abate any nuisance
- 3 occasioned by such vegetation; to prohibit and control the throwing,
- 4 depositing, or accumulation of litter on any lot or piece of ground
- 5 within the city or its extraterritorial zoning jurisdiction; to require
- 6 the removal of such litter so as to abate any nuisance occasioned
- 7 thereby. If the owner fails to cut and destroy weeds and worthless
- 8 vegetation or remove litter, or both, after notice as required by
- 9 ordinance, the city may assess the cost of such destruction or removal
- 10 upon the lots or lands as a special assessment. The required notice may
- 11 be by publication in the official newspaper of the city and may be
- 12 directed in general terms to the owners of lots and lands affected
- 13 without naming such owners;
- 14 (16) To prohibit and regulate the running at large or the herding or
- 15 driving of domestic animals, such as hogs, cattle, horses, sheep, goats,
- 16 fowls, or animals of any kind or description within the corporate limits;
- 17 to provide for the impounding of all animals running at large, herded, or
- 18 driven contrary to such prohibition and regulations; and to provide for
- 19 the forfeiture and sale of animals impounded to pay the expense of taking
- 20 up, caring for, and selling such impounded animals, including the cost of
- 21 advertising and fees of officers;
- 22 (17) To regulate the transportation of articles through the streets
- 23 and to prevent injuries to the streets from overloaded vehicles;
- 24 (18) To prevent or regulate any amusement or practice having a
- 25 tendency to annoy persons passing in the streets or on the sidewalks; and
- 26 to regulate the use of vehicles propelled by steam, gas, electricity, or
- 27 other motive power, operated on the streets of the city;
- 28 (19) To regulate or prohibit the transportation and keeping of
- 29 gunpowder, oils, and other combustible and explosive articles;
- 30 (20) To regulate, license, or prohibit the sale of domestic animals
- 31 or of goods, wares, and merchandise at public auction on the streets,

- 1 alleys, highways, or any public ground within the city;
- 2 (21) To regulate and prevent the use of streets, sidewalks, and
- 3 public grounds for signs, posts, awnings, awning posts, scales, or other
- 4 like purposes; and to regulate and prohibit the exhibition or carrying or
- 5 conveying of banners, placards, advertisements, or the distribution or
- 6 posting of advertisements or handbills in the streets or public grounds
- 7 or upon the sidewalks;
- 8 (22) To provide for the punishment of persons disturbing the peace
- 9 by noise, intoxication, drunkenness, or fighting, or otherwise violating
- 10 the public peace by indecent or disorderly conduct or by lewd and
- 11 lascivious behavior;
- 12 (23) To provide for the punishment of vagrants, tramps, street
- 13 beggars, prostitutes, disturbers of the peace, pickpockets, gamblers,
- 14 burglars, thieves, persons who practice any game, trick, or device with
- 15 intent to swindle, and trespassers upon private property;
- 16 (24) To prohibit, restrain, and suppress houses of prostitution,
- 17 opium joints, gambling houses, prize fighting, dog fighting, cock
- 18 fighting, and other disorderly houses and practices, all games and
- 19 gambling, and all kinds of indecencies; to regulate and license or
- 20 prohibit the keeping and use of billiard tables, bowling alleys, shooting
- 21 galleries except as provided in the Nebraska Shooting Range Protection
- 22 Act, and other similar places of amusement; and to prohibit and suppress
- 23 all lotteries and gift enterprises of all kinds under whatsoever name
- 24 carried on, except that nothing in this subdivision shall be construed to
- 25 apply to bingo, lotteries, lotteries by the sale of pickle cards, or
- 26 raffles conducted in accordance with the Nebraska Bingo Act, the Nebraska
- 27 Lottery and Raffle Act, the Nebraska Pickle Card Lottery Act, the
- 28 Nebraska Small Lottery and Raffle Act, or the State Lottery Act;
- 29 (25) To make and enforce all police regulations for the good
- 30 government, general welfare, health, safety, and security of the city and
- 31 the citizens of the city in addition to the police powers expressly

- 1 granted by law; in the exercise of the police power, to pass all needful
- 2 and proper ordinances and impose fines, forfeitures, and penalties for
- 3 the violation of any ordinance; to provide for the recovery, collection,
- 4 and enforcement of such fines; and in default of payment to provide for
- 5 confinement in the city or county prison or other place of confinement as
- 6 may be provided by ordinance;
- 7 (26) To prevent immoderate driving on the street;
- 8 (27) To establish and maintain public libraries, art galleries, and
- 9 museums and to provide the necessary grounds or buildings for such
- 10 libraries, galleries, and museums; to purchase books, papers, maps,
- 11 manuscripts, works of art, and objects of natural or of scientific
- 12 curiosity and instruction for such libraries, galleries, and museums; to
- 13 receive donations and bequests of money or property for such libraries,
- 14 galleries, and museums in trust or otherwise; and to pass necessary
- 15 bylaws and regulations for the protection and government of such
- 16 libraries, art galleries, and museums;
- 17 (28) To erect, designate, establish, maintain, and regulate
- 18 hospitals, houses of correction, jails, station houses, fire engine
- 19 houses, asphalt repair plants, and other necessary buildings; to erect,
- 20 designate, establish, maintain, and regulate plants for the removal,
- 21 disposal, or recycling of garbage and refuse or to make contracts for
- 22 garbage and refuse removal, disposal, or recycling, or all of the same;
- 23 and to charge equitable fees for such removal, disposal, or recycling, or
- 24 all of the same, except as provided by law. The fees collected pursuant
- 25 to this subdivision shall be credited to a single fund to be used
- 26 exclusively by the city for the removal, disposal, or recycling of
- 27 garbage and refuse, or all of the same, including any costs incurred for
- 28 collecting the fee. Before any contract for such removal, disposal, or
- 29 recycling is let, the city council shall make specifications for such
- 30 contract, bids shall be advertised for as now provided by law, and the
- 31 contract shall be let to the lowest and best bidder, who shall furnish

- 1 bond to the city conditioned upon his or her carrying out the terms of
- 2 the contract, the bond to be approved by the city council. Nothing in
- 3 this section, and no contract or regulation made by the city council,
- 4 shall be so construed as to prohibit any person, firm, or corporation
- 5 engaged in any business in which garbage or refuse accumulates as a
- 6 byproduct from selling, recycling, or otherwise disposing of his, her, or
- 7 its garbage or refuse or hauling such garbage or refuse through the
- 8 streets and alleys under such uniform and reasonable regulations as the
- 9 city council may by ordinance prescribe for the removal and hauling of
- 10 garbage or refuse;
- 11 (29) To erect and establish market houses and market places and to
- 12 provide for the erection of all other useful and necessary buildings for
- 13 the use of the city and for the protection and safety of all property
- 14 owned by the city. Such market houses, market places, and buildings may
- 15 be located on any street, alley, or public ground or on land purchased
- 16 for such purpose;
- 17 (30) To prohibit the establishment of additional cemeteries within
- 18 the limits of the city; to regulate the registration of births and
- 19 deaths; to direct the keeping and returning of bills of mortality; and to
- 20 impose penalties on physicians, sextons, and others for any default in
- 21 the premises;
- 22 (31) To provide for the inspection of steam boilers, electric light
- 23 appliances, pipefittings, and plumbings; to regulate their erection and
- 24 construction; to appoint inspectors; and to declare their powers and
- 25 duties, except as otherwise provided by law;
- 26 (32) To enact a fire code and regulate the erection of all buildings
- 27 and other structures within the corporate limits; to provide for the
- 28 removal of any buildings or structures or additions to buildings or
- 29 structures erected contrary to such code or regulations and to provide
- 30 for the removal of dangerous buildings; but no such code or regulation
- 31 shall be suspended or modified by resolution, nor shall exceptions be

made by ordinance or resolution in favor of any person, firm, or 1 2 corporation or concerning any particular lot or building; to direct that when any building has been damaged by fire, decay, or otherwise, to the 3 extent of fifty percent of the value of a similar new building above the 4 foundation, shall be torn down or removed; to prescribe the manner of 5 ascertaining such damages and to assess the cost of removal of any 6 7 building erected or existing contrary to such code or regulations against 8 the lot or real estate upon which such building or structure is located 9 or shall be erected or to collect such costs from the owner of any such building or structure; and to enforce the collection of such costs by 10 civil action in any court of competent jurisdiction; 11

(33) To regulate the construction, use, and maintenance of party 12 walls, to prescribe and regulate the thickness, strength, and manner of 13 constructing stone, brick, wood, or other buildings and the size and 14 shape of brick and other material placed in such buildings; to prescribe 15 16 and regulate the construction and arrangement of fire escapes and the placing of iron and metallic shutters and doors in or on such fire 17 escapes; to provide for the inspection of elevators; to prescribe, 18 regulate, and provide for the inspection of all plumbing, pipefitting, or 19 sewer connections in all houses or buildings now or hereafter erected; to 20 regulate the size, number, and manner of construction of halls, doors, 21 stairways, seats, aisles, and passageways of theaters and buildings of a 22 23 public character, whether now built or hereafter to be built, so that there may be convenient, safe, and speedy exit in case of fire; to 24 25 prevent the dangerous construction and condition of chimneys, fireplaces, hearths, stoves, stovepipes, ovens, boilers, and heating appliances used 26 in or about any building and to cause such appliances to be removed or 27 28 placed in safe condition when they are considered dangerous; to prevent the deposit of ashes in unsafe places and to cause such buildings and 29 enclosures as may be in a dangerous state to be put in a safe condition; 30 to prevent the disposing of and delivery or use in any building or other 31

- 1 structure of unsuitable building material within the city limits and
- 2 provide for the inspection of building materials; to provide for the
- 3 abatement of dense volumes of smoke; to regulate the construction of
- 4 areaways, stairways, and vaults and to regulate partition fences; and to
- 5 enforce proper heating and ventilation of buildings used for schools or
- 6 other buildings where large numbers of persons are liable to congregate;
- 7 (34) To regulate levees, depots and depot grounds, and places for
- 8 storing freight and goods and to provide for and regulate the laying of
- 9 tracks and the passage of railways through the streets, alleys, and
- 10 public grounds of the city;
- 11 (35) To require the lighting of any railway within the city and to
- 12 fix and determine the number, size, and style of all fixtures and
- 13 apparatus necessary for such lighting and the points of location for such
- 14 lampposts. If any company owning or operating such railways shall fail to
- 15 comply with such requirements, the city council may cause such lighting
- 16 to be done and may assess the expense of such lighting against such
- 17 company. Such expense shall constitute a lien upon any real estate
- 18 belonging to such company and lying within such city and may be collected
- 19 in the same manner as taxes for general purposes;
- 20 (36) To provide for necessary publicity and to appropriate money for
- 21 the purpose of advertising the resources and advantages of the city;
- 22 (37) To erect, establish, and maintain offstreet parking areas on
- 23 publicly owned property located beneath any elevated segment of the
- 24 National System of Interstate and Defense Highways or portion thereof, or
- 25 public property title to which is in the city on May 12, 1971, or
- 26 property owned by the city and used in conjunction with and incidental to
- 27 city-operated facilities; and to regulate parking on such property by
- 28 time limitation devices or by lease;
- 29 (38) To acquire, by the exercise of the power of eminent domain or
- 30 otherwise, lease, purchase, construct, own, maintain, operate, or
- 31 contract for the operation of public passenger transportation systems,

1 excluding taxicabs, transportation network companies and railroad systems, including all property and facilities required for such public 2 passenger transportation systems, within and without the limits of the 3 city; to redeem such property from prior encumbrance in order to protect 4 5 or preserve the interest of the city in such property; to exercise all powers granted by the Constitution of Nebraska and laws of the State of 6 Nebraska or exercised by or pursuant to a home rule charter adopted 7 8 pursuant thereto, including, but not limited to, receiving and accepting 9 from the government of the United States or any agency thereof, from the State of Nebraska or any subdivision thereof, and from any person or 10 corporation donations, devises, gifts, beguests, loans, or grants for or 11 in aid of the acquisition, operation, and maintenance of such public 12 passenger transportation systems; to administer, hold, use, and apply 13 14 such donations, devises, gifts, bequests, loans, or grants for the purposes for which such donations, devises, gifts, bequests, loans, or 15 16 grants may have been made; to negotiate with employees and enter into contracts of employment; to employ by contract or otherwise individuals 17 singularly or collectively; to enter into agreements authorized under the 18 19 Interlocal Cooperation Act or the Joint Public Agency Act; to contract with an operating and management company for the purpose of operating, 20 servicing, and maintaining any public passenger transportation systems 21 the city shall acquire; and to exercise such other and further powers as 22 may be necessary, incident, or appropriate to the powers of the city; and 23 24 (39) In addition to powers conferred elsewhere in the laws of the state, to implement and enforce an air pollution control program within 25 the corporate limits of the city under subdivision (23) of section 26 81-1504 or subsection (1) of section 81-1528, which program shall be 27 consistent with the federal Clean Air Act, as amended, 42 U.S.C. 7401 et 28 seq. Such powers shall include without limitation those involving 29 injunctive relief, civil penalties, criminal fines, and burden of proof. 30 31 Nothing in this section shall preclude the control of air pollution by

- 8 material, (3) prohibit carrying of concealed weapons, except the carrying
- 9 of a concealed handgun in compliance with the Concealed Handgun Permit
- 10 Act, (4) regulate and prevent the transportation of gunpowder or
- 11 combustible articles, tar, pitch, resin, coal oil, benzine, turpentine,
- 12 hemp, cotton, nitroglycerine, dynamite, petroleum or its products, or
- 13 other explosives or inflammables, (4) (5) regulate use of lights in
