17          The unexpended General Fund appropriation balance existing on June  
18          30, 2025, is hereby reappropriated.

19          The budget division of the Department of Administrative Services  
20          shall administratively transfer General Fund appropriations or Salary  
21          Limits or both among Program Nos. 52, 67, 420, 434, 435, and 437 within  
22          Agency 5, upon written certification by the State Court Administrator  
23          that the Supreme Court has determined that such transfer is necessary for  
24          the efficient functioning of statewide court operations and the proper  
25          administration of justice.

1        There is included in the appropriation to this program for FY2025-26  
2        \$270,000 General Funds and \$270,000 Cash Funds for state aid, which shall  
3        only be used for such purpose. There is included in the appropriation to  
4        this program for FY2026-27 \$270,000 General Funds and \$270,000 Cash Funds  
5        for state aid, which shall only be used for such purpose.

6        There is included in the appropriation to this program for FY2025-26  
7        \$500,000 Cash Funds for parenting plan mediation for indigent and lower-  
8        income persons involved in Parenting Act cases, as state aid, which shall  
9        only be used for such purpose. There is included in the appropriation to  
10       this program for FY2026-27 \$500,000 Cash Funds for parenting plan  
11       mediation for indigent and lower-income persons involved in Parenting Act  
12       cases, as state aid, which shall only be used for such purpose.

13       There is included in the appropriation to this program for FY2025-26  
14       \$550,000 General Funds and for FY2026-27 \$550,000 General Funds to  
15       increase the payments for interpreter services for deaf and hard of  
16       hearing persons and for persons unable to communicate the English  
17       language, which shall only be used for such purpose.

18       Cash Fund expenditures for this program shall not be limited to the  
19       amounts shown.
