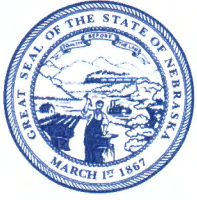

Rules and Procedure for Applying for Authorization for the Construction of Electric Generation Facilities, Electric Transmission Lines and/or Related Facilities, Wheeling, or Complaints

Brief explanation of the reason for the Rule / Regulation:

Chapter 2 sets out the requirements for how to prepare and file an application for authority to construct an electric generation facility, an electric transmission line, or a complaint against an electric utility. The rule provides forms to use for the applications, for other utilities to indicate their consent to the Board's approval of an application and waiver of a hearing, for use when a power supplier wishes to Protest the Board's approval of an application, for customers to use when filing a complaint against a utility, for a utility to reply to a complaint, and a completion statement on which utilities notify the Board of the actual final cost of a generation or transmission project.

Chapter 3 sets out the many rules and procedures for how hearings will be conducted before the Board, including timelines, notice requirements, prehearing conferences, opening and closing statements, how to mark exhibits, order of evidence, subpoenas, depositions, and interrogatories. Chapter 3 also describes how informal and formal investigations of possible violations will be conducted, and what must be included in a public power district's petition for creation or a petition to amend the district's charter.
