- LB 135 (*Holdcroft*) Provide, change, and eliminate provisions relating to elections for certain purposes related to bonds and tax levies
- LB 529 (*Jacobson*) Provide certain exemptions relating to contracts for the Nebraska Investment Council under the State Procurement Act and the Taxpayer Transparency Act
- LB 326 (*Jacobson*) Change provisions relating to the Unfair Insurance Trade Practices Act, the Nebraska Property and Liability Insurance Guaranty Association Act, and mutual insurance holding companies and eliminate the provisions of the Health Insurance Access Act and the Health Care Purchasing Pool Act
- LB 457 (*Bostar*) Require anaphylaxis policies for school districts and licensed child care facilities and provide a limit on the amount an insured is required to pay by an insurance policy or benefit plan for epinephrine injectors
- LB 84 (*Rountree*) Adopt the School Psychologist Interstate Licensure Compact
- LB 355 (*Andersen*) Change provisions relating to census data used for certain tax and economic development programs
- LB 97 (*Fredrickson*) Change provisions relating to deferred judgments, the State Boat Act, the Motor Vehicle Certificate of Title Act, the Motor Vehicle Registration Act, the Motor Vehicle Operator's License Act, the Nebraska Rules of the Road, the Department of Motor Vehicles Cash Fund, the Uniform Motor Vehicle Records Disclosure Act, the Motor Carrier Services Division Distributive Fund, and the State Treasurer

- LB 245 (*DeKay*) Change provisions of the Nebraska Pure Food Act
