## Summary of purpose and/or changes:

LB 261, introduced by the Speaker at the request of the Governor, is a part of the Governor's biennial budget



recommendations. This bill is the mainline appropriations bill for the biennium that begins July 1, 2025, and ends on June 30, 2027. This measure includes the budget recommendations for all State operations and State aid programs. The bill includes the appropriate transfers from cash funds to the General Fund, as well as between specified cash funds. Finally, it provides the necessary definitions for the proper administration of appropriations and personal service limitations. This legislative bill contains the emergency clause and becomes operative on July 1, 2025.

## **Explanation of amendments:**

The amendment, AM832, becomes the bill. The amendment contains the Appropriations Committee's recommendation for the bulk of appropriations to be made during the budget biennium for state operations and state aid. Statutorily authorized transfers among funds are made in conformance with budget requirements as are transfers from the General Fund.

The Appropriations Committee report "State of Nebraska FY 2025-26 and FY 2026-27 Biennial Budget, As Proposed by the Appropriations Committee 109th Legislature, First Session" published April 2025 contains additional details. Significant increases and reductions in General Fund appropriations from the current year are listed on page 19 of such report. A narrative description of General Fund appropriations begins on page 20 for agency operations and on page 25 for state aid. Discussion of cash fund appropriations begins on page 34, with subsequent sections on cash fund agency operations and state aid, as well as sections for federal or revolving fund appropriations and capital construction (page 50). Tabular data follows in additional sections, itemizing the recommendation by agency, aid program, and all fund sources. A narrative description of the recommendation by each state agency begins on page 73.

AM832 also adds LB55, LB57, LB173, LB452, LB505, LB580, LB581, LB621, and LB627 to LB261.

LB 55 (Dorn) – The bill appropriates \$1.5 million for FY2025-26 from the Hospital Quality Assurance and Access Assessment Fund to the Department of Health and Human Services (DHHS) for reimbursement to mental health providers who do not practice in a hospital and who provide services to Medicaid-eligible participants who are eligible for both Medicaid and Medicare, if there is a lower rate paid under Medicare compared to rates paid at the time for Medicaid rates for behavioral health services.
