Summary of purpose and/or changes:

LB 426 amends section 79-724 to require that all public, private, denominational, and parochial schools offer a one-hour American flag education program as part of their social studies curriculum for students in grades 5-8. The program will teach topics such as the U.S. Flag Code, the 13 folds of the flag, flag etiquette, and its historical context. Schools may collaborate with local veterans' organizations to develop and present the program, and each student will receive a 3' x 5' American flag along with a flag etiquette booklet. The costs of the program will be funded through lottery funds or private donations. LB 426 also amends section 79-3501 to provide that flag education programs share the 3% of educational funds from state lottery money currently allocated for distance education incentives.

Explanation of amendments:

AM 586 is a white copy committee amendment that strikes the original sections and amends LB 426 to remove the



funding of the free flag program with lottery money and instead requires the Educational Service Unit (ESU) Coordinating Council, in coordination with the State Department of Education, to establish a grant program to help school districts purchase American flags made in the U.S. for flag education programs. Schools districts may apply to the ESU Coordinating Council for grants funded by the American Flag Education Grant Cash Fund, created by AM 586, which will be administered by the State Department of Education and receive contributions from legislative transfers, gifts, grants, and bequests.

Additionally, AM 586 requires the State Department of Education to contract with the ESU Coordinating Council to assist the the ESU Coordinating Council, which is required, in consultation and partnership with a statewide recognized veterans organization, to develop and provide online educational videos and materials about the American flag for use by schools. The amendment provides that it is the intent of the Legislature to appropriate \$5,000 for this initiative from General Funds in the 2025-26 fiscal year to the Department of Education.
