Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 415 changes provisions of the Nebraska Healthy Families and Workplaces Act.

LB 415, as amended by AM 545, amends provisions of LB 402, LB 435, and LB 698 into LB 415.

Certain definitions are amended under AM 545. "Employee" now includes and individual owner-operator and an independent contractor. Individuals employed in an agricultural employment of a seasonal or other temporary nature are excluded from the definition of "Employee". Similarly, individuals under the age of sixteen are excluded from the definition. The definition of "Paid sick time" is also expanded.

Section 4 of AM 545 strikes Section 8 (6) through (8) of Initiative Law 2024, No. 436. These subsections address employees claiming violations of the Nebraska Healthy Families and Workplaces Act and the remedies available to them.

Section 5 of AM 545 provides an additional purpose to the Gambling Winnings Setoff for Outstanding Debt Act. The additional purpose is for the Department of Labor to establish and maintain a procedure to set off against an obligator's casino winnings, parimutuel winnings, sports wagering winnings, or cash device winnings.

Section 6 adds the Department of Labor with respect to collection of a debt owed by an individual involving the receipt of unemployment insurance benefits to the definition of "Claimant" under section 9-1303. The Department of Labor may submit any certified debt of twenty-five dollars or more to the Gambling Winnings Setoff for Outstanding Debt Act's electronic collection system.

AM 545 (from LB 435): 1) references to certain standards (from the American Society of Mechanical Engineers) are specified as to which year's edition shall be utilized, 2) changes the State Fire Marshal's power to grant variances under the act to granting equivalency requests, and 3) amends language regarding the information which shall be contained for an elevator mechanic license application.
