LB 751 requires the Nebraska State Patrol (NSP) to conduct a study on how to increase protective and investigative resources for reporting, identifying, and investigating missing Black women and children in Nebraska.

The State Patrol must work with the Commission on African American Affairs to convene meetings with law enforcement, federal partners, and urban community organizations to assess the scope of the issue, identify barriers, and develop partnerships. The bill also directs coordination with the U.S. Department of Justice to improve information sharing and resource coordination.

By June 1, 2027, the State Patrol must submit an electronic report to the Executive Board of the Legislative Council containing data and analysis, identified barriers, and recommendations, including any proposed legislation.

The Commission on African American Affairs states no fiscal impact.

NSP has not submitted a response, but the assumption is that there will be a fiscal impact; the amount of that impact is indeterminable at this time.
